THIRD AMENDMENT TO

AGREEMENT FOR THE DESIGN, FINANCING AND CONSTRUCTION OF THE SUMMERLIN CENTRE INFRASTRUCTURE IN CLARK COUNTY, NEVADA FOR SPECIAL IMPROVEMENT DISTRICT 128

This Third Amendment to Agreement for the Design, Financing and Construction of the Summerlin Centre Infrastructure in Clark County, Nevada for Special Improvement District 128 (this "Third Amendment"), dated as of April ___, 2025, is by and between Clark County, Nevada (the "County"), a political subdivision of the State of Nevada, and Howard Hughes Properties, Inc., a Nevada corporation (the "Developer").

WHEREAS, the County and the Developer have heretofore entered into that certain Agreement for the Design, Financing, and Construction of the Summerlin Centre Infrastructure in Clark County, Nevada for Special Improvement District 128 dated September 19, 2000 (the "Original Financing Agreement"), with Howard Hughes Properties, Inc., a Nevada corporation (the "Developer"), relating to the design, construction and financing of certain of such public improvements within the District, as amended by a First Amendment to Agreement for the Design, Financing, and Construction of the Summerlin Centre Infrastructure in Clark County, Nevada for Special Improvement District dated April 3, 2001 (the "First Amendment"), and as amended by a Second Amendment to Agreement for the Design, Financing, and Construction of the Summerlin Centre Infrastructure in Clark County, Nevada for Special Improvement District 128 dated April 5, 2005 (the "Second Amendment," and together with the Original Financing Agreement and the First Amendment, the "Financing Agreement"); and

WHEREAS, the Developer has requested that the Subproject Descriptions and Purchase Prices set forth in Exhibit C to the Financing Agreement be modified to reflect the completion of certain subprojects, the elimination of certain projects, and cost revisions to certain other subprojects; and

WHEREAS, pursuant to NRS 271.6415, the Board heretofore determined that the aforementioned modifications were warranted and ordered the same; and

WHEREAS, the County and the Developer desire to amend the Subproject Descriptions and Purchase Prices set forth in Exhibit C to the Financing Agreement by substituting the same for Exhibit A attached hereto.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND CONDITIONS CONTAINED HEREIN, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. Exhibit C to the Financing Agreement is hereby substituted and replaced in its entirety with Exhibit A attached hereto.
- 2. If any provision of this Third Amendment is deemed to be invalid or unenforceable, such invalidity or unenforceability shall not affect the remaining provisions hereof that can be given effect with the invalid or unenforceable provision and the County and the Developer agree to replace such invalid or unenforceable provision with a valid provision which has, as nearly as possible, the same effect.
- 3. This Third Amendment shall be governed by and construed in accordance with the laws of the State of Nevada.
- 4. This Third Amendment may be executed in one or more counterparts, each of which shall be regarded as an original and all of which shall constitute the same Agreement.
- 5. Except as expressly amended by this Third Amendment, the Financing Agreement remains in full force and effect.

1.4 Proposed Project Changes and Modified Budget

Clark County has outlined a series of modifications to the SID improvements. The 2004 list was provided as part of our contract with the County, dated September 27, 2023. On May 23, 2024 and August 13, 2024, the County updated this list, which in included in Appendix E.

The project cost differences between the 2004 list and the 2024 list are summarized in Table 2 below under the "Project Cost Changes" column. The modified budget amount for each project is summarized below under the "2024 Modified Over/(Under)" column. The modified budget takes into account the modified project costs less the payments made to the Developer to date. Our calculations of the amounts can be found in Appendix A.
