Letter of Interest

I have been a physician providing care in Las Vegas since 2005. In that time, I have provided primary care in my office, worked as a hospitalist and eventually came to be the first locally trained fellow of addiction medicine in Nevada. While doing my fellowship, I gained considerable insight into the different silos that exist in our community in regards to services for those suffering from a substance use disorder. I rotated with Dr Wade, who provides substance use disorder (SUD) treatment and medication assisted treatment (MAT) in our jails. I also rotated at CrossRoads for my ambulatory site and Center for Behavioral Health where I was exposed to how care is coordinated with the drug courts. My inpatient rehab experience was at Landmark Recovery as well as inpatient rehab facility at the VA.


Upon finishing fellowship, I made it a point to push for the establishment of Nevada Society of Addiction Medicine as a fully active chapter of the American Society of Addiction Medicine. We were fortunate to establish our 501c3 and are looking to recruit more of our providers in the Las Vegas Valley. As a member of the advocacy committee in ASAM, I also did reach out to our congressional legislation as well as to the DEA. As a result, we were successful in our efforts to do away with the DATA 2000 waiver requirement for prescribing buprenorphine as well as prolonging the permission to write for MAT across state lines.

Through my office, we provided Covid testing, treatment and vaccination for thousands of patients. We worked under a Clark County contract and were the only private business to have done so during the pandemic emergency. Today we have initiated a memorandum of understanding with the Neighborhood Clinic to provide MAT and Hepatitis C treatment for residents at the Las Vegas Rescue Mission. We also serve as the ambulatory clinic site for the new classes of fellows coming through Southern Hills Hospital Addiction Fellowship.

My years as a hospitalist helped inform me of the services available in our ERs for SUD. It is for this reason that through the fellowship, I have promoted the formation of a Nevada Bridge program (much like California Bridge programs exist in California ERs). Doing this has led me to champion the adoption of buprenorphine in our various hospital systems and also the formation of delineation of privileges for addiction specialists. By pushing for these two important changes, we stand to provide much better SUD treatment in our medical institutions.

Now that I am the Medical Director of Emerging Markets at Groups Recover Together, Inc., I have gained considerable insight into the various approaches other states have taken to the opioid crisis. I hope to parlay this vantage point to make better educated recommendations for our own opioid task force, should I be given the opportunity. Thank you for your time and attention.
