1.3.16	Increased Septage/Chemical Toilet Charges: effective 7/1/2025 from 6 to 7 cents, then effective 7/1/2026 from 7 to 8 cents; the effective 7/1/2027 from 8 to 9 cents.	
1.3.20	Increased FOGG and Hydromechanical FOGG Interceptor Charges: effective 7/1/2025 from \$100 to \$110, then effective 7/1/2026 to \$125. Multiple interceptors on same parcel: effective 7/1/2025 from \$50 to \$60, then effective 7/1/2026 to \$75, and includes Hydromechanical FOGG Interceptors. Subsequent inspections during within a 12-month period: effective 7/1/2025 from \$100 to \$110, then effective 7/1/2026 to \$125.	
1.3.21	NEW: Hydromechanical FOGG Interceptor Waiver Application fee of \$1000	
1.3.22	Increased the capacity maintenance charge (formerly availability charge): effective 7/1/2025 from 30% of the annual sewer service charge to 50%, then effective 7/1/2027 to 75%.	
1.3.23	NEW: Point of Connection (POC) Processing Fee \$175 per POC	
1.3.24	NEW: Plan Review Fee: effective 7/1/2025 \$3.50 per lineal foot, then effective 7/1/2026 to \$5.50 per lineal foot.	
1.3.25	NEW: Construction Inspection Fee: effective 7/1/2025 \$3.50 per lineal foot, then effective 7/1/2026 to \$5.50 per lineal foot.	
1.3.27	Clarification for cost of District services provided to a person are reimbursable to the District.	
1.4.8	Clarification of delinquent account assessment of interest penalty.	
1.5.1	Clarification that a point of connection is required for single family residences and authority to charge a point of connection fee	1.3.23
1.5.5	Clarification of requirements for District to approve final maps.	
1.5.12	Clarification associated with Interlocal Agreements when connected to the District's POTW.
