THIS AMENDMENT is made and entered into this _____ day of _____ 2023, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and APPLE GROVE TREATMENT CENTER, LLC D.B.A. APPLE GROVE FOSTER CARE AGENCY, (hereinafter referred to as "PROVIDER").

WITNESSETH:

WHEREAS, the parties entered into an agreement under RFQ Number 604376-17, entitled "ALTERNATIVE LIVING SERVICES" dated JULY 7, 2017 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. SECTION I: TERM OF CONTRACT, PAGE 1

ORIGINALLY WRITTEN:

COUNTY agrees to retain PROVIDER for the period from date of award through June 30, 2018, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract. COUNTY reserve the right to extend the Contract for up to an additional twelve (12) months, on a month-to-month basis.

REVISED TO READ:

COUNTY agrees to retain PROVIDER for the period from date of award through June 30, 2018, with the option to renew for five (5), one-year periods subject to the provisions of Sections II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract. COUNTY reserve the right to extend the Contract for up to an additional twelve (12) months, on a month-to-month basis.
