

**AMENDMENT NO. 2
TO CBE-1061
AGREEMENT FOR SOUTHERN NEVADA SUPPLEMENTAL AIRPORT
ENVIRONMENTAL IMPACT STATEMENT PHASE 1 PLANNING**

This Amendment No. 2 ("Second Amendment") to the Agreement for Southern Nevada Supplemental Airport Environmental Impact Statement Phase 1 Planning dated January 21, 2020 (the "Agreement") is made on this _____ day of _____, 2025, by and between CLARK COUNTY, NEVADA, through its Department of Aviation ("OWNER"), and RICONDO & ASSOCIATES, INC. ("CONTRACTOR"). The OWNER and CONTRACTOR are each a "Party" to the Agreement and this Second Amendment, and together they are the "Parties."

WITNESSETH:

WHEREAS, the Parties entered into the Agreement on January 21, 2020 for the Southern Nevada Supplemental Airport Environmental Impact Statement Phase 1 Planning;

WHEREAS, the Parties previously revised the Agreement on May 2, 2023 by executing Amendment No. 1 (the "First Amendment"); and

WHEREAS, it is the intent of the Parties to further amend the terms of the Agreement to extend the engagement timeline, or "Term of the Agreement" (defined below), as set forth in this Second Amendment.

NOW, THEREFORE, the Parties, for and in valuable consideration of the mutual covenants and conditions herein, do agree to amend the Agreement as follows:

Action 1: In Section VII, MISCELLANEOUS PROVISIONS, Paragraph P of the Agreement, entitled "Term of the Agreement" and as previously revised in the First Amendment, add the following at the end of that Paragraph:

The term of this Agreement with the exercised First Extension and Second Extension shall be from the date of award through June 30, 2025 ("Term"). Thereafter, the Parties have the option to extend this Agreement for one (1) additional three (3) year period through June 30, 2028 (the "Third Extension"), should the Third Extension option be so utilized. Notwithstanding anything to the contrary contained in the Agreement, including any related exhibits or amendments, CONTRACTOR'S total charges to OWNER during the Third Extension will not exceed \$975,000.

Except to the extent modified pursuant to the First Amendment and this Second Amendment, all other terms and conditions of the Agreement shall remain unchanged, in full force and effect and are hereby affirmed and ratified.
