

AMENDMENT NO. 1 CBE NO. 607441-24 FOR COVERED SPECIES MODEL UPDATES 2024

THIS AMENDMENT is made and entered into this _____ day of _____ 2025, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and BOARD OF REGENTS OF THE NEVADA SYSTEM OF HIGHER EDUCATION, ON BEHALF OF THE UNIVERSITY OF NEVADA, RENO (hereinafter referred to as "AGENCY").

WITNESSETH:

WHEREAS, the parties entered into an agreement under CBE Number 607441-24, entitled "Covered Species Model Updates 2024" dated January 21, 2025 (hereinafter referred to as AGREEMENT);

WHEREAS the parties desire to amend the AGREEMENT.

NOW, THEREFORE, the parties agree to amend the AGREEMENT as follows:

1. ARTICLE IV: PRICE, PAYMENT, AND SUBMISSION OF INVOICE, Page 2, Paragraphs 1 through 3 have been revised as follows:

ORIGINALLY WRITTEN

COUNTY agrees to pay AGENCY for goods and/or services provided as outlined in Exhibit A, Scope of Work, up to a not-to-exceed amount of \$99,806.00, including Appendix 1 - Basic Services, and Appendix 1.2 - Additional Compensation, and based on approved budget appropriations for this project.

- 1. Appendix 1 Basic Services. For the services to be performed by AGENCY under this Scope of Work, COUNTY agrees to pay the AGENCY the fee in the amount of \$79,806.00 for Basic Services as detailed in Appendix 1 Basic Services, Milestone/Deliverable/Invoicing Schedule Table.
- 2. Appendix 1.2 Additional Compensation. For any services not set forth in the Appendix 1 Basic Services, AGENCY shall receive prior written approval for any additional services. Upon receiving written approval from COUNTY Designated Point of Contact, COUNTY will pay up to the Not-to-Exceed amount of \$20,000.00 per Appendix 1.2 Additional Compensation.

REVISED TO READ

COUNTY agrees to pay AGENCY for goods and/or services provided as outlined in Exhibit A, Scope of Work, up to a not-to-exceed amount of \$156,806.00, including Appendix 1 - Basic Services, and Appendix 1.2 - Additional Compensation, and based on approved budget appropriations for this project.

- 1. Appendix 1 Basic Services. For the services to be performed by AGENCY under this Scope of Work, COUNTY agrees to pay the AGENCY the fee in the amount of \$79,806.00 for Basic Services as detailed in Appendix 1 Basic Services, Milestone/Deliverable/Invoicing Schedule Table.
- 2. Appendix 1.2 Additional Compensation. For any services not set forth in the Appendix 1 Basic Services, AGENCY shall receive prior written approval for any additional services. Upon receiving written approval from COUNTY Designated Point of Contact, COUNTY will pay up to the Not-to-Exceed amount of \$77,000.00 per Appendix 1.2 Additional Compensation.
- 2. ARTICLE V: TIME SCHEDULE, Page 3, Paragraph 1 have been revised as follows:

Time is of the essence for this agreement. The work identified in Exhibit A; Scope of Work is anticipated to end on JUNE 15, 2025. AGENCY shall complete the work in accordance with the dates identified in Appendix 1, Milestone/Deliverable/Invoicing Schedule Table in Exhibit A, Scope of Work.

REVISED TO READ

Time is of the essence for this agreement. The work identified in Exhibit A; Scope of Work is anticipated to end on DECEMBER 15, 2025. AGENCY shall complete the work in accordance with the dates identified in Appendix 1, Milestone/Deliverable/Invoicing Schedule Table in Exhibit A, Scope of Work.

3. ARTICLE VI: TERM OF AGREEMENT, Page 3, Paragraph 1 has been revised as follows:

ORIGINALLY WRITTEN

The term of this AGREEMENT shall be from the day of contract award through JUNE 15, 2025, with one (1) six-month no-cost extension allowed and expressly permitted at the sole option of COUNTY contingent upon the availability of funds.

REVISED TO READ

The term of this AGREEMENT shall be from the day of contract award through DECEMBER 15, 2025, with one (1) six-month no-cost extension allowed and expressly permitted at the sole option of COUNTY contingent upon the availability of funds.
