
Dear Clark County Regional Opioid Task Force Committee:

I am writing to express my interest in joining the Clark County Regional Opioid Task Force created by Assembly Bill 132 of the 2023 Legislative Session. As I begin my journey in the Masters of Public Health Program at UNLV, I look forward to understanding how the social determinants of health impact behavioral health in our community and how we can move toward a preventative model.

As Executive Director of NAMI Southern Nevada, a peer-led mental health nonprofit, I've heard many stories from families and peers regarding their mental health and sometimes co-occurring challenges over the years.
