#### WITNESSETH:

**WHEREAS**, the parties entered into an agreement under Nearmap Quote #Q065498 on June 15, 2021, in connection with CBE #605841-21, entitled "Mapping Software Subscription" (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

**NOW, THEREFORE**, the parties agree as follows:

- 1. The CONTRACT is amended to incorporate the following provision as Section 27 of Schedule 1, Additional Terms and Conditions:
  - "27. Notwithstanding Section 2.3 of the CONTRACT, the Licensee and all government entities under the Licensee's License, are permitted to make the Products available to no more than one hundred (100) contractors, cumulatively, that are directly providing services on behalf of the Licensee ("Contractors"). In the event the Licensee requires additional Contractor access to the Products, the Licensee shall provide Nearmap with a written request. The Licensee and all government entities under the Licensee's License agrees:
    - a. The Products must be provided to the Contractor's as a static image, or through Nearmap's online platform MapBrowser, strictly to the extent necessary for the Contractors to provide the services to the Licensee. The Contractors may also access the Products through the Licensee's ArcGIS Online platform.
    - b. Each Contractor that accesses the Products through MapBrowser must be issued an email address that corresponds with a government entity under the Licensee's License, which shall be used to provision access to the Products via the Licensee's Nearmap account.
    - c. The Contractors shall promptly delete any Content in their possession upon the sooner of (a) the termination or expiration of the CONTRACT, or (b) the completion of the services provided to the Licensee.
    - d. At all times, the Licensee remains responsible, and liable, for all acts and omissions of the Contractors in connection with the use of the Products."
- 2. The CONTRACT is amended to incorporate the following Products:


