Due to the effect of the COVID-19 pandemic on our community housing inventory remains extremely low . This has impacted our programs ability to utilize housing and maximize HUD program funds leaving some available for recapture. Additionally STAR PSH experienced less client turnover and in turn led to decreased service numbers and fund utilization overall. STAR PSH also had a staffing vacancy that also contributed to the reduction in programmatic spend out.

STAR (Stability, Tenancy, Access, Restore) PSH (Permanent Supportive Housing) & STAR TH-RRH (Transitional-Rapid Rehousing) are complementary programs that meet the needs of Veterans & households experiencing chronic homelessness; high vulnerable individuals, families & transition age youth (TAY) experiencing literal homelessness who have mental illness (SMI), substance use disorder (SUD) or co-occurring SMI & SUD; & high vulnerable homeless frequent users of high cost public systems such as jails & emergency rooms. Through PSH, tenancy support, access to treatment & health care benefits, STAR restores lives & provides resources to allow households obtain self-sufficiency. Utilizing a housing first, harm reduction, client-centered model with motivational interviewing; households achieve stability & wellness while addressing the underlying causes of homelessness.

STAR PSH clients access effective SMI & SUD treatment, medication management, medical care, psychosocial rehabilitation & an array of recovery support services designed to stabilize tenancy, maintain treatment goals & engage clients. Social support helps clients overcome the alienation that frequently accompanies long-term homelessness & peer mentors help clients navigate complex social service systems, acquire important basic living & self-management skills, reunify with family & build support systems. Intensive case managers (ICMs) partner with service providers to ensure clients have access to assistance with moving costs, educational & legal services, employment assistance, food, life skills training, transportation & other services that promote self-sufficiency.

Utilizing a 1:21 ICM-to-client ratio & receiving referrals from the community queue, STAR PSH supports the needs of the client, supports Functional Zero sustainability efforts for Veterans & ending homelessness of all subpopulations by 2020 as outlined in the Opening Doors federal plan to prevent & end homelessness. STAR PSH aims to house at least 89 individuals in PSH. The Vivo Housing Project (TVHP), which served as a model for this reallocated project, served 125 individuals CHI with stable housing placement, outreach case management & supportive services during the past fiscal year. Of the clients served, 76 percent were diagnosed with three or more physical or mental health conditions & 95% of the clients had co-occurring SMI or SUD.

STAR PSH seeks to target 71 clients (80% of population) to remain in permanent housing as of the end of the operating year or exiting to permanent housing during the operating year; and 67 clients (75% of population) to maintain or increase their total income as of the end of the operating year or program exit. Using housing as a foundation for recovery, SOAR certified (SSI/SSDI Outreach and Recovery) ICMs assist 80 clients (90% of population) with applications for mainstream benefit programs for which they are eligible, in order to stabilize tenancy and increase self-sufficiency.


