

AMENDMENT TEN

TO THE VOTING SYSTEM AGREEMENT BY AND BETWEEN DOMINION VOTING SYSTEMS, INC. AND CLARK COUNTY, NV

This Amendment Ten to the Voting System Agreement ("Amendment Ten") is made and entered into as of this June 30, 2025 (the "Amendment Ten Effective Date") by and between Clark County, NV ("Customer") and Dominion Voting Systems, Inc. ("Dominion") (collectively, Customer and Dominion are referred to herein as the "Parties").

RECITALS

WHEREAS, the Customer and Dominion entered into a Voting System Agreement with an effective date of September 1, 2015, which was subsequently amended by Amendment One date February 16, 2016, Amendment Two dated February 7, 2017, Amendment Three dated May 7, 2018, Amendment Four dated July 1, 2019, Amendment Five dated July 26, 2020, Amendment Six dated September 23, 2020, Amendment Seven dated March 15, 2022, Amendment Eight dated March 5, 2024, and Amendment Nine dated November 5, 2024 (collectively, the Voting System Agreement and all amendments thereto are referred to herein as the "Agreement");

WHEREAS, the Customer and Dominion desire to amend the Agreement;
and

THEREFORE, in consideration of the mutual covenants and obligations herein contained, and other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Customer and Dominion agree as follows:

AMENDMENT

- 1. Recitals Incorporated.** The above recitals are true and correct and incorporated herein by this reference as if fully set forth.
- 2. Termination of Agreement.** The Parties hereby agree to terminate the Agreement effective June 30, 2025.
- 3. All Other Terms.** Except as expressly amended in this Amendment Ten, all other Agreement terms shall remain in full force and effect.
