

**SUPPLEMENTAL NO. 4 TO THE PROFESSIONAL ENGINEERING SERVICES
CONTRACT FOR THE INTERSTATE 215 AND AIRPORT CONNECTOR
INTERCHANGE PHASE 3 PROJECT**

THIS Supplemental No. 4 Contract, made and entered into this 20th day of January, 2026, between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada, hereinafter referred to as “COUNTY”, and WSP, USA, INC., a corporation authorized to do business under the laws of the State of Nevada, hereinafter referred to as “ENGINEER”. The COUNTY and ENGINEER may herein be referred individually as “Party” or collectively as “Parties”.

WHEREAS, on May 7, 2019, the COUNTY and the ENGINEER entered into a contract (hereinafter “Contract”) for professional engineering services for the Interstate 215 and Airport Connector Interchange Phase 3 Project (hereinafter “Project”); and,

WHEREAS, on July 6, 2021, Supplemental No. 1 to the Contract was approved by the COUNTY to pursue additional professional engineering services including additional design and related services which included an environmental analysis and design modifications; and,

WHEREAS, on May 17, 2022, Supplemental No. 2 to the Contract was approved by the COUNTY to extend the time of performance due to delays caused by design modifications and the additional design requirements of the Statewide Transportation Improvement Program (STIP); and,

WHEREAS, on June 6, 2023, Supplemental No. 3 to the Contract was approved by the COUNTY to extend the time of performance and for additional professional engineering services which included traffic noise modeling, additional retaining wall design, and stakeholder coordination; and,

WHEREAS, this Supplemental No. 4 to the contract is to extend the time of performance to provide construction support services.

NOW, THEREFORE, for and in consideration of the premises and mutual covenants herein contained, it is agreed as follows:

ARTICLE IV: TIME OF PERFORMANCE

4.01 Time of Performance

Replace the last paragraph in this section with the following:

Except as provided above the ENGINEER shall complete all other Basic Services and authorized Special Services by the end December 31, 2028, unless the Board of County Commissioners amends such date in writing.


The remainder of the Professional Engineering Services Contract, Supplemental No. 1, Supplemental No. 2, and Supplemental No. 3 remains unchanged.
