I am an Acute Care Nurse Practitioner at the St. Rose Hospital Siena Campus Intensive Care Units. While I currently do not serve on a committee, I have witnessed the devastating effects, including overdoses, of opioid addiction and the abuses of other controlled substances. I provide treatment to those in withdrawal and help prevent serious physiological damage, such as seizures or brain damage while in delirium tremens. After the acute withdrawal phase, I navigate the mental health/addiction support networks to ensure patients are discharged safely to the appropriate setting.

Previously, I served on ICU Length of Stay Committee, COVID Task Force Committee, Catheter Associated Urinary Tract Infection Prevention Committee, Central Line Associated Bloodstream Infection Prevention Committee, California Nurses Association Union ICU Representative – due to my transition to a non-bargaining unit position, I relinquished my membership/chairpersonship of said committees.

As an ICU provider, I am required to maintain a current Drug Enforcement Administration (DEA) license for Schedule II through V drugs, Nevada Registered Nurse (RN) and Advanced Practice Registered Nurse (APRN) licenses, as well as, national board certification through American Nurses Credentialing Center (ANCC), which all require constant training and continuing medical education in substance abuse disorders. My continuing education includes, pharmaceutical options, medical treatment for mental health illnesses and the related impact on substance abuse disorders.

I am frequently consulted to the Emergency Room to the care for the most critical of overdosed or withdrawing patients; I have seen the young and old lose their battle to addiction, and in the worst cases, cause brain damage with the resultant dependence on life support. I have also witnessed success stories of overdose survival, without long term damage. Too frequently though, we then see these same survivors at some point later, suffering the same fate, as their struggle is too great and our community resources too scarce. As a result of these experiences, I have a keen understanding of the dire need in
