2. Page 1, Section I: Term of Contract

"COUNTY agrees to retain PROVIDER for the period from DATE OF AWARD through June 30, 2020, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of the Contract."

### REVISED TO READ

"COUNTY agrees to retain PROVIDER for the period from DATE OF AWARD through June 30, 2020, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of the Contract. COUNTY reserves the right to extend the CONTRACT for up to an additional six (6) months for its convenience."

This Amendment No.5 represents an increase amount not to exceed \$935,579.94.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
