BACKGROUND:

Since 2005, the Department of Family Services (DFS) has received grant funding from the State of Nevada Department of Health and Human Services, Division of Child and Family Services (DCFS) to support administrative activities that are required to move children toward the completion of adoption.

Approval of this item will allow for the continuation of five (5) full time grant funded positions: two (2) Deputy District Attorneys (P02), one (1) Legal Secretary I/II (C24), one (1) Legal Office Services Supervisor (C26), and one (1) Legal Office Specialist (C23). These positions will facilitate the termination of parental rights for children in foster care who will not be reunited with their natural parents. In addition, grant will fund a marketing campaign to include events and media which will promote recruitment of foster and adoptive homes for children in DFS care.

The award process for this grant differs from the normal grant application process as funding is made available from the State and passed through to DFS without application or competitive process. In addition, it is not known in advance about funding availability until an award letter is received from the State.

BACKGROUND:

On December 19, 2019 the Clark County Department of Family Services (DFS) received notification from the State of Nevada announcing the release of Request for Application for Adoption Incentive Grant.
