**GIBSON** 

This morning there are a number of, um- Commissioner Recognitions. Uh- the first is the, uh- Board of County Commissioners in, uh- recognition in honor of Black History Month, recognizing the outstanding citizens and organizations in Clark County.

February marks Black History Month, a time to celebrate and acknowledge the contributions and the achievements of American, African Americans throughout history. In honor of Black History Month, we would like to open the meeting, um-from this point forward, with the singing of the Black national anthem and, uh- "Lift Every Voice and Sing" was a hymn that was written as a poem by NAACP leader James Weldon Johnson in 1900. Today, we have Miss Shemini Yoka, a professional live music stage performer and vocal coach here with us to sing, and we'd invite all to stand.

GIBSON Thank you very much. So, we will be recognizing today, a number of- and not

nearly enough, but a number of, uh- remarkable people, uh- who are exceptional

citizens, Black citizens, but citizens, and organizations in Clark County.

Commissioner Kirkpatrick.

MARILYN K. KIRPATRICK Thank you. Good morning and thank you, uh- Mister Chairman. So, now we're

gonna ask, uh- Victor to play the video on the importance of Black History Month, and this was, uh- made up of all of the commissioners, really what we

thought. (Video plays)

GIBSON Black history is American history. Let us remember those who fought for

equality and for a better tomorrow and celebrate those who continue this

important work to shape our community and our nation today.

MICHAEL NAFT Black History Month is an important opportunity for all of us to recognize and

appreciate the many contributions of the Black community here in Southern

Nevada.

WILLIAM MCCURDY II Let us continue to celebrate this entire year, pick up a book, open it up. Learn

about some of the past leaders who have blazed a trail.

ROSS MILLER They say that a page of history is worth a volume of logic, that it's important to

remember our past, and there's elements of Black history that, that just weren't taught in the history books, be it the, the Tulsa Massacre that I certainly didn't learn about or, you know, elements of our Black history here in Las Vegas. If

we don't learn from our past, we're doomed to repeat it.

KIRKPATRICK It's really important to Nevada, because it's where we come from, where we

started, you know, the Rat Pack, Sammie Davis Junior. And it's really about celebrating our past, our present, and inspiring so many of our young youth to

give back and get involved in our community.

TICK SEGERBLOM We have come so far. When I was growing up, we were known as the

"Mississippi of the West." African American entertainers on the Strip couldn't stay on the Strip. We were very segregated. Today, we're much more integrated,

uh- much more involved, but the truth is, we have so much more to go.

JUSTIN JONES This is an opportunity to truly celebrate those individuals who have been true

leaders and have provided the rich diversity that our community here in

Southern Nevada has enjoyed.

GIBSON Clark County has a very diverse workforce, and that diversity gives us real

strength.

JONES And that's why it's so critical that our own workforce here reflect that rich

diversity in our community.

MILLER It allows for economic opportunity for our entire community here, but, but also

internationally as we try to recruit companies to come here.

SEGERBLOM Diversity in- in the workforce, particularly here in Clark County is so critical

because, uh- government should reflect the society.

**NAFT** 

By bringing different ideas and different thoughts together around the table will not only better represent this community but will set us on a stronger path towards the future and towards resiliency.

**KIRKPATRICK** 

And for us to be able to have people that look like others, uh- serving and providing services, I think that that's, uh- something to be real proud of.

**MCCURDY** 

Black History Month is a time where we celebrate the enormous contributions of African Americans. This is our history. Let us never forget it. Let us remember where we have come from and let us continue to make progress for future generations. (video ends)

KIRKPATRICK

Yeah, thank you for that. So now, we'd like to welcome Miss Cora Wright for a special dance performance to Nina Simone's "I Wish I Knew It Would Feel To Be Free." Uh- Miss Wright is a dancer, choreographer, and teacher. Miss Wright attended the Ailey School, performed with the ballet, the Appalachian Ballet Company and the Contemporary West Dance Theater. She's a dance instructor assistant at the Las Vegas Academy for Arts. Good morning. (Music plays and Miss Wright dances)

Thank you very much, Miss Wright. This morning, uh- we have various recognitions that we'll make, and we'll start at this end, uh- with, uh-Commissioner Miller and we'll just move all the way to the end to Commissioner McCurdy and if you will, Commissioner McCurdy, I'd ask you to tie things up, uh- when we, when you finish your r- your introductions. Ruby Duncan, would you please come up here? It takes Miss Ruby a little bit to get down here, but uh- I, I'll begin. I am so proud to recognize this morning, uh- a true hero of mine, uh- Ruby Duncan, I think is, is familiar to most of us in this room, but that's still not enough people, a- and that's, th- I think the point of Black History Month.

Uh- thank you. Ruby's been often recognized, uh- from the floors of Congress to, uh- when I was Secretary of State, we, we had a National Courage Award named the Margaret Chase Smith Courage Award. Uh- every Secretary of State, has the opportunity to nominate individuals. She beat out people from Al Gore to, uh- Rosa Parks was a- was a former, uh- recipient of it. Uh- and, and it's intended to give an award to somebody who recognizes true political courage. Uh- a- and that's Ruby's story. Uh- her and the other co-founders of Operation Life, uh- d- did more probably to, to, to combat anti-poverty than an- anybody in our state's history.

Uh- as Commissioner Segerblom noted i- in our short video, uh- Nevada at that time was the "Mississippi of the West," uh- a- and Ruby took that on head on, uh- es- establishing nutrition programs, food stamps, uh- went up to the

Legislature a- and fought tough battles. Uh- and enduring some s- very significant intimidation, uh- a, a, a true act of courage and a real hero, a- and so, i- i- when you think about Black History Month, uh- th- again, th- this is the moment that you think about where we've come from. Uh- and if we're, we don't learn from our past, we're doomed to repeat it, a- and so I'm so proud to once again, uh- recognize my friend, uh- a- and somebody that truly inspires many of us every single day. Thank you, Ruby Duncan. Thank you for your courage and we're proud to recognize you.

**RUBY DUNCAN** 

(inaudible) Okay. I wanna thank you Commissioner Miller. Thank God for you. I wanna thank all of you, but uh- I wanna say to Commissioner (silence) Gibson (laughs), I want you to know, if it wouldn't have been for your father and Senator Brown at the time, they're the ones that helped me made sure that food stamps came into the State of Nevada.

I want you to know that the State of Nevada did not want any food stamps in the state, because they said there was no hunger in the state. So, therefore, they didn't need it.

But Senator Gibson, Senator Brown made sure that happened for this state throughout this community and all over, and I'm so happy that we also worked so hard and this was a group of welfare mamas, including me. I was a mother with seven children and all of those children were fed. We're taking them everywhere to feed them although, but in the meantime, the WIC program did not come into the State of Nevada until we, as a group of poor mothers, poor welfare mamas and other lawmakers including the state.

Uh- um- I was so happy that happened. We all were. There were over 200 women that went into the Legislature and testified. These were majority black women and others, brown, whites. It was the greatest joy of our lives to know that we made sure that the WIC program was the first, we were the first program, Nevada were the first program for the WIC program. We as a group of moms, although we didn't get paid, now, everybody else got paid throughout the state, but (laughs) we didn't get paid, but we made it happen.

So, God bless all of us and thank you Commission.

I, I'd be remiss if I didn't add that there is a wonderful book, "Storming Caesar's Palace," about R- Ruby and the, and the works of Operation Life, along with a documentary that's, uh- n- now, I think touring some of the film festivals and will eventually air on PBS. So, uh- urge you all to check it out. Thank you. (crosstalk)

**SEGERBLOM** 

It's gonna be tough to top that one, but, um (laughs). I, I have three, umamazing women I'd like to honor t- this morning. Uh- first Clark County Recorder Debbie Conway, th- all three come up, Clark County Assessor Briana

SEGERBLOM Johnson, and M- Michelle Maese, President of SEIU Local 1107.

AUDIENCE (applause)

SEGERBLOM Thank you so much. So, I'm honored, I'm, uh- glad to be able to honor all three

of these, because they're part of our family. They all came up in - as Clark County employees, uh- start with, uh- Debbie. You've worked for the public for 30 years, over 30 years. Um- she's been Recorder for, looks like four times

you've been elected. I guess there's no term limits for recorder.

DEBBIE CONWAY (laughs)

SEGERBLOM (laughs) Maybe I, that's where w- Jim and I should go to next.

AUDIENCE (laughs)

SEGERBLOM Um- but th- received numerous awards and you're f- also the first African

American to be the County Recorder, so thank you so much, and I...

AUDIENCE (applause)

SEGERBLOM -when I'm, when I'm done with all three, I'll let each of you say a few words.

Uh- next we have Clark County Assessor Briana Johnson. She's with "Strive With You," with the Clark County back in 1995, so almost 30 years. You don't

look it. Um (laughs).

AUDIENCE (laughs)

BRIANA JOHNSON Thank you.

SEGERBLOM (laughs) Um- you were first elected in 2018, reelected in 2022, native of Las

Vegas and you're also the first African American to be e- elected Clark County

Assessor.

AUDIENCE (applause)

SEGERBLOM And finally, Michelle Maese, who's the, currently the president of SEIU...

AUDIENCE (applause)

SEGERBLOM -but she's w- she, she brought her own rooting team, but um- she's also been,

uh- Clark County, one of our babies since 2007. So, she was elected local 1107 president in 2022, and when I, when she first elected, I said, gee, you may, Michelle, you may become the president of SEIU, and she said, President of the

United States.

AUDIENCE (cheers)(applause)

SEGERBLOM So, big, big future, and i- uh- Debbie, if we could start with you, you say a few

words.

DEBBIE CONWAY

Thank you, Commissioner Segerblom and thanks be unto God. I'd like to thank

CONWAY the Board of County Commissioners for this honor, and I'd also like to thank the

constituents of Clark County for this honor, and I'd like for my staff from the Clark County Recorder's Office, the award-winning staff, to stand, and be

acknowledged.

AUDIENCE (applause)

CONWAY Thank you. Of course, we're working today. We're recording documents, so we

couldn't have the whole office to come.

AUDIENCE (laughs)

CONWAY But uh- those are some of the managers in our office, and once again, I'd like to

thank the s- constituents for the trust that they put in me, and I'm honored to be here on this morning as the first black A- or, African American, uh- Clark County Recorder, and I believe I'm the first African American Recorder in the

State of Nevada. So...

AUDIENCE (applause)

CONWAY So, with that, again, I won't s- I won't, uh- b- uh- prolong this situation. I really

appreciate it. We appreciate the honor once again. Thank you, Board of Clark County Commissioners and Commissioner Segerblom. Thank you very much.

SEGERBLOM Thank you.

BRIANA JOHNSON Good morning, everyone, thank you Commissioner Segerblom and members of

the Board. Thank you so much for recognizing me today for Black History Month and for my service to Clark County, and again, as Debbie said, thank you to the constituents who have voted me in twice to represent you as your

Clark County Assessor.

I am so grateful and thankful and humbled to receive this recognition today and it is all because I have my parents in the audience, some of my staff members here, if you could please stand and just to say thank you to everyone, um-for

recognizing me...

AUDIENCE (applause)

JOHNSON - and like Debbie, um- I too am the first African American to not only be elected

as Clark County Assessor in- in Clark County, but also in the State of Nevada,

so thank you.

AUDIENCE (applause)

MICHELLE MAESE Thank you, congratulations both, to you. Thank you, Commissioner Segerblom

and Commissioners, um- I need you to know I got a couple text messages when SEIU showed up to ask if everything was okay because... they know when we show up, we're showing up for a reason. It's either on the paper or in the news, and so I just wanna say thank you so much for recognizing me for Black

History Month. Thank you and I just wanted to recognize a couple other people in the audience, because without us, there is no Black history, and I just wanna

MAESE say, um- thank you to my mom. I was adopted from foster care. Mom, please

stand up.

AUDIENCE (applause)

MAESE Thank you. Thank you to my mother. Thank you to my, yes (laughs). Thank

you, yeah. Yeah, so, I was adopted in New York from, mom, st- stay standing, h- stay standing. Um- and then I wanna say thank you to my, my daughters right there and my husband of 23 years, if you can please stand up too, as well as my, yeah. Stay standing. Stay standing, as well as my family who traveled in from New York, if you can stand up. My family, stay standing, s- who can s- travel from New York, stay standing. I wanna recognize UNLV, I graduated from

UNLV and I'm a proud Alumni, so please stand up as well. Yes.

AUDIENCE (cheers)(applause)

MAESE I wanna say, because of UNLV, I stayed here in Las Vegas and got a job at

Clark County. Jill, Patrick, please stand up, I c- I became a worker at Clark County and thank you for working with SEIU s- for so long, um- its been long nights, days and weekends, but we appreciate you so much, and then I have the honor and privilege to join my family at SEIU Local 1107. Please stand up.

Please stand up, SEIU. Yes.

AUDIENCE (applause)

MAESE Thank you so much, and because of SEIU, we are an anti-racist organization

because of that we believe in community. We believe in communities together, and because of SEIU, I've been able to work with some amazing people like the African Diaspora. Please stand up. Um- Nevada Now, please stand up, other

building trades, please stand up.

AUDIENCE (applause)

MAESE Thank you, and last but not least, I just wanna recognize one person. Mister

Harris, if you can come to the front, please. Mister Harris, can you come to the front? Just one person I wanna recognize. I was at a, um- celebration for his daughter who is also the first black judge in Nevada, Belinda T. Harris, and we

were talking, yes...

AUDIENCE (applause)

MAESE -BTH, thank you. Thank you, and we were talking, and Mister

Harris let me know that in 1977, he went to join the union and they said no. They said no because he was black. They said no because he didn't look like them, and he wasn't allowed to join the union, and in 1978, he went back to join, and they let him in. In 1979 I was born. You are the reason I'm here today.

You are.

AUDIENCE (applause)

MISTER HARRIS Thank you.

MAESE And I appreciate you, and I thank you, and this is what true union and true

leadership looks like. It's, thank you for continuing the fight, because we know

that when we fight...

AUDIENCE We win.

MAESE When we fight...

AUDIENCE We win.

MAESE Thank you so much. Thank you.

AUDIENCE (applause)

SEGERBLOM Thank you so much. Obviously, that was a union rally and not an honor. Oh, he

is.

AUDIENCE (laughs)

MAESE (inaudible) picture.

JONES Picture? Picture (crosstalk)

SEGERBLOM Thank you so much. I love your daughter. Your daughter has been so

unbelievable. (laughs)

HARRIS (laughs) Thank you. (crosstalk)

KIRKPATRICK Well, they just keeping harder and harder to top. But uh- first of all, I, for me, I

just wanna say, as you all see, uh- I work with a lot of great men, but it's so nice to have all these great women in the same room, so, with strong men supporting

us.

AUDIENCE (applause)

KIRKPATRICK So, th- um- Black History is really an important piece of who we are, and, and

what we do, and so many, um- African Americans have made the way across the c- uh- acrossed our own community and really given a lot, and sometimes we don't even know all the different impacts that they've done. Um- so this year, I have contributions, um- in my com- in my district from the east side to the far northwest, to young, to old, and so I'd like all of my, um- recipients to come up at this time, and we are going to present you with a Kente cloth. And the reason for that is because they're so intricately made, um- and back in the day, um-they were only for kings and queens and they were for royalty, and so, the folks that are coming up for me, I feel like they're the m- my royalty within my community. So, Miss Nita you'll go that way, go to that way, your left.

So, as I invite them, uh- all up, um- I would s- like to start with, uh- Miss Nita Brown. Um- so, you know, she fought me trying to get here today, 'cause she's so busy, and if you don't know her, everybody should, she's at John Mull's. She's the backbone of that commun- of that restaurant and all that they do, but she's really a big part, and she doesn't like, um- she doesn't like to be here, but

KIRKPATRICK we're, we are excited (laughter) that she's here and we forced her.

AUDIENCE (applause)

RENITA BROWN Yes, you did (laughs). Thank you. Thank you.

KIKPATRICK So, then we have Miss Sonja Bankston-Cullen. She is a member of our Sun City

Aliante Board of Directors. She's devoted to community service and m- many of the, um- Commissioners know that at Sun City Aliante, we go to often. We love, uh- what we do there, but she really keeps them going. She's a former teacher, principle, and administrator. So, we love that because she's always giving back to our babies. Um- but she's, uh- lastly the Chair of the Sun City

Aliante Lifestyle Committee.

Then we have Miss Velma McClinton. She was born at Southern Nevada Memorial Hospital. Who remembers that? (laughs)(crosstalk)

AUDIENCE (applause)

KIRKPATRICK I do (laughs). So, um- she has a Bachelor of Arts in Labor Studies. She has 37

years as a United States Postal Service worker. Bless you-

VELMA CLINTON Thank you (laughs).

KIRKPATRICK ... 'cause that is a hard job (laughs). Uh- she's a volunteer community activist,

and she's a founder of the Cora Coleman Newsletter, um-Sunrise Sounder. So,

thank you for all that you do.

AUDIENCE (applause)

KIRKPARICK 'Kay.

Then we have Mister Aubrey Branch. Um- he had, to, the chore of going shopping with me at Christmas time, and I said, we're gonna do this in 30 minutes, watch me (laughs) and we did it, but um- he really does so much in our community all the time, and we're thankful that you live in District B. He's a Chairman of Branch Hernandez Consulting. He's the Chairman of the Branch Company. He's with a joint venture partner with Hudson News. He's a treasurer of the NAMC and Chairman of the North Las Vegas Arts Recreation and

Culture Advisory Committee. So, thank you for all you do.

AUDIENCE (applause)

KIRKPATRICK So, the one that I'm most excited about, no disrespect here, but it's really about, uh- honoring our past, celebrating our present, which is who we have here

uh- honoring our past, celebrating our present, which is who we have here today. But inspiring our youth, and so if any of you don't know who Carter is, you will, because he is a leader. So, our office, uh- sponsors the YMCA's, uh-Power Scholars Academy, and that is an academy for the kids, um- during the summer, and especially during COVID when they could get, um- caught up in school and learning was fun and they did all these things and had no idea that they were actually ahead and ready, but Carter here, he um- didn't just like, right Carter? You didn't just like being in the class, he had to be in charge.

KIRKPATRICK (crosstalk) So, I like a lot of people in charge. So, he took charge. He became

the c- class leader, and he couldn't have done all that, so, if I could ask his mom, um- to stand, she here with you? Carter who brou- oh, she's taking the picture.

UNIDENTIFIED I'm the Grandma.

KIRKPATRICK Oh, Grandma. (laughs) W- W- Grandma's more important, 'cause I'm a grandma

too, and I know them chur-being in charge. Where's Dad? So, if we could thank

you for allowing Carter...

AUDIENCE (applause)(cheers)

KIRKPATRICK - 'cause he is our future, and he's gonna con- he's gonna continue, and he, he...

Carter, if you ever get into trouble, any one of these folks here are going to help

you get to the top, all right?

AUBREY BRANCH Got you.

KIRKPATRICK Ok, so Im gonna let Carter speak, you wanna speak? Don't be shy today.

(laughs) you speak

AUDIENCE (laughter)

KIRKPATRICK And all of a sudden, you're shy. All right. Uh- one of you ladies like to speak?

What? I have all these shy people in District B. (laughter) Oh, my goodness.

There you go.

RENITA BROWN Well, I really don't know what to say. I don't think that I've done anything

special...

AUDIENCE (laughter)

BROWN But I do thank you, Commissioner Marilyn. Thank you very much. Thank you

for honoring me, and all of us up here. We just want to say thank you.

SONJA BANKSTON-CULLEN So, I would be remiss if I did not, first of all, say thank you for this honor, but

also for those people who came out today to support me. So, Sun City Aliante

Board of Directors, you are here, would you please stand.

BANKSTON-CULLEN We have the management from FirstService Residential, and I am blessed that

they work with us so well. So, Damien and Debbie, please stand?

Good morning, everyone. Thank you, Commissioner Kirkpatrick, for honoring me. And, uh- I appreciate being here. I'm back home in Las Vegas, and I brought a few of our pamphlets, our papers, and we are also located on the website, but we have field trips, special events, speakers, and workshops, social, ka- uh- karaoke, uh- creative arts, fitness centers, and we have a exercise that we do three days a week, health and fitness. And it's all in our Sunrise Sounder, so, you know, I had to... So, I do have a few here, and please come out and visit, visit us. We're on the east side, right off of... just North of Lake Mead on Bonnie Lane. We appreciate you coming out and looking at what we have to offer. Thank you.

Alright. Good morning, everyone. I've been in this valley now for 28, 29 years, and out of those 29 years, 27 of 'em is City of North Las Vegas. So, I see some in the district and I think Commissioner McCurdy on the other end to somewhere we cross over, but mainly on this end. And I know I'm gonna get beat down when I get home because my wife is... 46 years of marriage, she's watching me on TV. I told her I'm just getting something. I know they told me to show up...

And I'm like, "Oh my God." (laughs), 'cause I'm seeing everybody bringing everybody. I'm like, "I ain't got nobody here." (laughs)

So yeah, my, yeah, my, my son is watching on the TV set at the office, now he's the president of a company. I'm like, "Oh my God. I didn't tell anybody, anything." I just, I just showed up. But one thing I do know, you can't beat God giving.

That's right.

And my heart is just to give and give at all times. Don't look... not looking for any recognition, I think that's where my weakness is. I don't look for anything in return. And the only thing that she beat me on giving was Commissioner when she told me, "Aubrey, you gonna give me this for these kids." Not give it to me, I wanted to give. But you come and buy, what I go and buy this stuff too? I gotta go with you, and to go shopping? That was the best treat I ever could have had to go back and purchase to see those kids and see their smile on their face. And so, at the end of the day, Commissioner, I appreciate this, didn't look for this at all, but I appreciate what you're doing. Alright.

KIRKPATRICK

Ready? You got it.

CARTER LEE Thank you.

AUDIENCE (laughter)(applause)

KIRKPATRICK Well, in District B, we're always working, so these folks are dying to get back. I

promise them they'd be outta here by 10. So, again, thank you for all that you do in every contribution that you do make. And for the "Y", I don't know why he's

so shy today, but you're on your own, (laughs).

AUDIENCE (laughs)(crosstalk)

GIBSON I'd like to invite Pastor Sam Roberson and his incredible wife, Earlene, to come

up here with us.

AUDIENCE (applause)

GIBSON I first met Pastor Roberson, uh- in the mid-90s. And I learned an awful lot from him the first moment I met him. And we have spent literally hours together, and

I have learned from him, and we have learned how to work together.

I think one of the things that we've heard about today is how important it is that

we work together. It is a united front that achieves the greatest results.

Pastor Sam Roberson moved to Las Vegas in 1957. And he united with the Greater New Jerusalem Baptist Church under the leadership of Pastor F.N. Addison, many of you will remember him. Pastor Roberson was called to the gospel ministry and preached his first sermon on May 25th, 1965. In 1966, Pastor Roberson began a 31-year career in radio broadcasting. He was called to pastor the Community Baptist Church in Henderson in February of 1977, and he retired as their pastor in December of 2022, after 45 years of dedicated service.

AUDIENCE (applause)

GIBSON Pastor Roberson is the recipient of many accolades, appointments, and

recognitions. In the area of Christian education, he was the first nationally certified state director for the State of Nevada in 1998. The 2001 recipient of the Outstanding State Directors Award, incorporated the State Congress of

Christian Education in 2002, and, served on the 2005 Scholarship Committee of

the National Congress-Congress of Christian Education.

His personal accomplishments are so many, but they include the, um- the fafact that he served as past president of the NAACP, Las Vegas branch. Um- he became the president of the Jackson Avenue Merchants Association in 1978. The co-organizer of the Nevada Black Chamber of Commerce, president of the American Singers Association, Local 11, we should have had him sing today.

AUDIENCE (laughter)

GIBSON And Chaplain for the City of Henderson Police Department. He was raised by

his grandmother Williana Ro- Roberson, and has been married to this incredible

woman, Earlene, since 1959.

UNIDENTIFIED Wow.

AUDIENCE (applause)

GIBSON He is the father of five children, and I think a daughter is here. Did your

daughter get here? There, I see a hand. (crosstalk)

Well, he's the father of five children, so you represent the others. A grandfather and a great-grandfather. Most important to me is he is someone who made a meaningful, I mean, a meaningful contribution to the City of Henderson.

People do not understand the depth of the commitment that he and his wife, and their congregation have made to the development of so much of what is there today, along Lake Mead and Boulder Highway.

Uh- he was into affordable housing before affordable housing was popular, and helped establish a-a complex that is meaningful. It is beautiful. It is clean. It is crime free. It is everything that we want for people who need housing. I could go on and on and on, but then I would reveal to you my ignorance, be- because I really did learn from this man. In my first meeting with him, there were two other f- people from his congregation who were sitting in the meeting, and I noticed that one of them was, you know, taking notes every now and again. And at the end of the meeting, Pastor Roberson said to him, would you review... What was his name?

PASTON SAM ROBERTSON Tommy Miles.

GIBSON Tommy Miles, he said, "Tommy, review with the, with uh- Mister Gibson what

we have just discussed." And this is the way he put it, "You promised that you

would do this...."

AUDIENCE (laughter)

GIBSON You promised that you would do that. You promised that you would do the

other." And there were about seven or eight things that I didn't realize I had ever

used the word promise to do... but I was now committed in writing.

It was my pleasure to follow up on every single one of those things, and I am grateful for the relationship and the contribution that this couple has made because we know, right? We know he's a great guy, real talented guy. He never

could have done it all, and five kids without this incredible woman.

AUDIENCE (applause)

ROBERTSON Thank you, Jim. We thank Commissioner Gibson. When we're together, I called

him Jim, he called me Sam. it... We you have that kind of friendship; you can do that. Many of those that, uh- I labored with, uh- Bob Bailey and, and, uh- Jesse Scott, and many of 'em passed on, but when I went to, I think it was Atlanta, Georgia, and saw the Wheat Street Affordable Housing Complex, which was 17 stories high, I wanted to build one. I had just become the pastor in '77, went to Atlanta in '78. In 2008, we broke ground for the affordable housing,

and I named it Smith Williams. Smith was the preacher, Williams was the deacon. Somebody said, "How come you didn't put your name?" I said, my name is on every rock because it's my brainstorm. It's my baby.

Even though I retired from active pastoring at Community, but I join because I have another dream that I'd like to see come to Henderson, and that is a cultural center, which we as Black people don't have one. I wanted to build it on the other four acres that's next to what we already have in Henderson. I know I can't do it. I don't know how to do it, but I thought if I tell it to everybody, it would get done.

**AUDIENCE** 

(laughter)(cheers)

**ROBERTSON** 

I'm not, I'm not concerned about who gets the credit, long as the building get up.

UNIDENTIFIED

Right, right.

**ROBERTSON** 

And we can do what it is that we need to do. There are a lot of contributions that we have... people have made to the world, and to Las Vegas at large, but many of us don't know and don't recognize. And when we learn of our history, we gotta go back to Atlanta or some of the other places when we ought to have it right here in our own backyard.

A lot of stuff I could say that time won't permit, but I was here when it was segregated, and we had sent for Dr. King to come in. I think it's 1960, and they open up everything. Said you could come in now. The only problem with that, you could go in, but if you didn't have no job, you couldn't get out. We gonwe're gonna cut it off right here. Thank the Commissioners for taking this time to bestow this proclamation and this honor unto me and my wife and, and my family. We did not do what we did for any recognition, but just because I had a good grandmother. (crosstalk)

(applause)(cheers)

JONES

I think... Let's try this again. Today, I get the distinct pleasure of, uh-honoring my friend and, um-former roommate, Aaron Ford.

Aaron Ford was elected as the, uh- Attorney General for the State of Nevada in 2018. And when he was elected, he was not only the first African American, uhelected as Attorney General in the State of Nevada, but the first African American who was elected statewide in any position.

Prior to, uh- serving as the Attorney General, uh- Aaron was elected to the Nevada State Senate in 2012 and went on to be the, uh- Senate Minority Leader and well as the Senate Majority Leader. And while he was in the Legislature, he championed, uh- a number of critical, uh- pieces of le- legislation. Uh- he, uh-created the Conviction Integrity Unit to review cases that allege wrongful convictions as Attorney General. Um- and he collaborated with prosecutors to revive a cold case and brought it to justice for a Nevada mother who lost her daughter to a brutal murder for more than 40 years. Um- uh...

Aaron is somebody who I admire, um- I've had the opportunity to know for

more than a decade now. Uh- and I would be remiss if I did not note, uh- his wife and, uh- rock, Berna Rhodes Ford, um- who is, uh- just a wonderful person, uh- and together they have raised three amazing, uh- sons, but also, occasionally, raised other children in their home, (laughs), including their nephew. Uh- and so I, uh- I want to, to to note all that, uh- Attorney Ge-General Ford has done.

Um- I would be remiss if I didn't, uh- re- recognize that he has been active in the National Bar Association, uh- and you've probably seen him and one of our former colleagues, uh- in videos, uh- uh- Uh- Caning with, uh- Kappa Alpha-Alpha Psi Fraternity.

Um- unfortunately, Attorney General Ford was not able to be here because he is up, uh- fighting the good fight in the Legislature on day two, uh- in the Judiciary Committee. Uh- but, uh- I wanted to give him a round of applause for all that he does for our community here.

I- I am delighted to get to, uh- acknowledge and thank District A resident, Marie Ray Scott. Uh- Marie is a trailblazing...

Absolutely. M- Miss Scott is a trailblazing entrepreneur here in Southern Nevada as owner and operator of R. M. Whitsett Inc. A minority owned business, operating five multiple concepts, food and beverage concessions at Harry Reid International Airport. She and her partners founded the successful Enterprise in 1993 with just four employees.

And if my math is right, that makes 30 years that you've been at, uh- a partner of ours at the Department of Aviation. And, uh- in those 30 years, she's grown the business from four initial employees to over 90 employees who work at DOA making... work for her at, at, uh- Harry Reid International, um- earning great ja- great benefits, performing well and contributing to our economy.

Uh- and in her spare time, aside from building that incredible business, she has served as an Advisory Board Member for the Salvation Army, President of the Girl Friends Inc. Las Vegas, Chapter, past Chairman of the Board for the Las Vegas Clark County Urban League, a member of the Board for the Girl Scouts of America Frontier Chapter. And I could go on.

I also want to mention some other awards that she has received, including the Rose of Sharon Award from the United Methodist Church, the Walker Business and Community Recognition Award from the National Coalition of 100 Black Women, the Non-Traditional Entrepreneur honor for Alph- from Alpha Kappa Alpha. An outstanding leadership award from Top Ladies of Distinction and the Distinguished Honoree Award from the Las Vegas Urban Chamber.

Uh- you have been an incredible inspiration to so many in this community who need strong entrepreneurs and, uh- business men and women to look up to and admire, and we thank you for serving that role here for us.

Uh- she leads, uh- a major initiative every year, uh- that seeks to bail out Black mamas... uh- during Mother's Day weekend as, as well as making sure that she hosts many letter writing campaigns to individuals who are looking forward to the day that they're released from incarceration and successfully in... reintegrating into our society. Uh- she works, again, to reconnect people with African concepts such as Ubuntu. Please join me in giving a warm round of applause to

childcare, minimum wage, and again, on paid sick leaves.

She's also worked with partners on voting rights restoration, formerly incarcerated residents, making sure that they have the information that they need to have their voice heard through the ballot box. I can go on and on, but I just want to say that Miss Erika Washington is an innovator. She is passionate. She is articulate. She is one that will speak her truth to power from her position of power, and I just want you to help me celebrate her one more time, Miss

Erika Washington.

As you've heard today, um- there has been trails that have been blazed literally all over the valley, uh- from every different direction, all leaning to one nucleus.

Boone, who is the Executive Director of TULIPS.

So, the way that it works, is they only have to get uh- a lab tested once, and then whatever they end up... There's never another lab test, umbefore it's sold.

## KIRKPATRICK

So, uh- what we do know... and so, other states... and I'm going to NACo this week. Other states are really starting to, um- work together to figure out what we can do, so we know that, uh- Delta-8, is allowed today in states surrounding us.

We're one of the few states that does not allow it. So, we want to make sure... Um- so I'd like to ask the Board, if we could, one, talk to the Legislature to make sure that, uh- it's not just the Delta-8, that it's anything. Because we don't... We want to be sure what people are selling for the CBD. And two, see if the Board would be amiable to having Business Licensing, work with LVMPD, and the CBB, the CCB, to mitigate the bad actors. Uh- and we know that there is quite a few.

And then, ask, uh- Business License, if they can work with DA's office in planning, so that we can be s-, um- we can put some signs out, so that people know what should be expected, because there should be no THC in this product. Um- but we believe that there is, and unfortunately several other states are struggling way more than us, but I want to get in front of it. So, that's really my emerging issue.

Um- and then last we'll be at Salt & Spoon on February 25th at 9 a.m., um- and, uh- looking forward to seeing everybody there for the next installation of coffee and conversation.

Uh- and then, uh- two, two, uh- committee updates for the group. Uh- we had our quarterly Audit Committee meeting, uh- last week, Commissioners Miller, McCurdy, and I serve on that committee. Um- the 2022 impressed and petty cash audit report was prede-, presented, uh- there were three low risk findings that have all been resolved.

Uh- in 2022, the department completed the following audits: The annual art plan review, Laughlin Constable follow-up, Recorder follow-up, election mail

in-ballot part one, Family Services P card and gift cards, 2021 impressed and petty cash, '22 Crowe LLP assistance, and '22 Crowe single audit assistance for the Fiscal Year 2022.

Uh- and currently in progress, they'll continue to work on the social service financial assistance, '22 impressed and petty cash account review, countywide compliance with FT6, Election Department mail-in balloting, part two, uh- 24-hour vehicle audit and an audit of the Animal Foundation.

Uh- the Audit Department also presented their '22 audit plan for approval, including audits they requi-, the, they are required to do such as the external audit assistance and other audits selected through risk assessment and discussions with county management. Just wanna thank everybody in the audit team for, uh- their hard work to make sure that, uh- we're being fiscally responsible he-, uh- here at the County.

And lastly, just wanted to update the Board on ambulance response times. Uhon January 3rd, the latest reapportionment maps went into effect resulting in an 18%, uh- call volume shift from AMR to Community Ambulance. Uh- and while that month is still being processed, we have a pretty good idea of where it stands. I'm sure the Board has probably received this report, uh- but in, uhzones one covered by AMR, uh- they're at 80%, .11. Zone two by AMR is 83.77. Medic West in zone five is 87.69. Community in zone six is at 96.98. Zone seven by Community 97.59, and zone eight is hit 95.51.

Um- so I just think that bears, um- saying because I think it's gonna be an ongoing issue that we need to continue to work together to make sure every resident in Clark County, no matter where you live, is well served by our emergency response. Thank you.

it's good to mention the tourism indicators that we saw, uh- as we closed out 2022. Visitor volume was, uh- up, uh- to the point that we're now trailing the 2019 tally by about, uh- a little under 9%. We made tremendous headway. 3,307,000, uh- visitors in December, 38.8 million during the year.

The convention attendance is, is beginning to come back. It's come back actually a long way. We're about 3/4 recovered from where we were in 2019, uh- with about five million, uh- trade show and convention visitors. That's really important to us for the midweek occupancy at the hotels.

Uh- city-wide occupancy, uh- reached 79% for the year. That's really important. Weekend occupancy has pushed up and over 90% a few times but it ended up about 89, uh- percent with midweek occupancy around 75%. Um- the room rates have recovered. It's been a good year of recovery and given where we started with CES this year, we imagine that we'll be even closer to the, uh-milestones that were established in 2019. We're excited for that.

Yesterday, um- the Director of the Department of Aviation, who is still with us here today. I don't mean ... She, she's here.

(laughter)

Um- she announced, uh- that the airport passenger record, uh- that was established in 2019 had fallen by 1.1 million travelers. Uh- the new record is 52.6 million passengers. An incredible year when it comes to this very interesting recovery that we're having because the Airport is the most recovered airport in the Country. That's the Harry Reid International Airport. We, uh-we're very proud of that and it has made such an enormous difference because not all of the rest of the economy has recovered. But we still have visitation here and the blessing of an airport that is thriving is really important to us.

Um- a, uh- uh- a couple of weeks ago on January 19th, I was thrilled to participate in the groundbreaking of Old Red. Now, I actually ought to say my wife was thrilled that I got to go to the groundbreaking of Old Red. Uh- Blake Shelton got to have his picture with me (laughter) and, uh- it was really a lotta fun. The, uh- Old Red is the name of, uh- a, an early hit of Blake Shelton's. And, uh- the opening, uh- in the Horseshoe Las Vegas right next to the Binion Steakhouse will be an exciting event. That's where our, our groundbreaking happened but the, the Old Red building is going to be, I think, four stories right on the Boulevard at, uh- Flamingo and Las Vegas Boulevard. A tre-, a tremendous addition to the Boulevard and we're very excited to have them. We'll let you know when the grand opening is. And as far as we're concerned, everyone can be invited to that but we'll, that'll be determined by people who actually have control over such things.

Um- last week, I was able to stop by the Sister Bailey Robert Joseph Elementary School, a great school, to participate in the UNR extension event, Chef For Kids Healthy Hot Breakfast. Great event. Volunteer chefs from hotel casinos served up a free hot breakfast to all students, teachers, and staff. Chef For Kids delivers breakfast to Title 1 Schools in Southern Nevada feeding more than 10,000 su-, students a healthy meal every single year. And we appreciate all of those who helped do that.

Uh- last Wednesday, the NFL Pro Bowl, uh- folks were here and we celebrated World Wetlands Day with the NFL and our Las Vegas Raiders. This is the second year of the NFL's Community Green Project out of wetlands where we planted 125 trees and nine shade trees in the nature play corner to create more wildlife habitat for kids to explore. But with the funding that the NFL provided, we'll be able to plant another thousand plants or so, uh- plants and trees that will help us replace those that are wiped out by fires, and help the staff manage the removal of invasive species that really need to be removed but we don't wanna leave holes in the landscape.

The funding from the NFL provides help with assisting this, uh- process but we, we also had volunteers out. We have 138 volunteers who help us maintain that park. Uh- they are there, uh- all of the time and we appreciate so much the incredible work. Not all of it is real glamorous: picking up trash and reporting issues. They act as the eyes and ears of our park. They work year round. No matter how much time each person contributes, their efforts are invaluable. And those who would be interested in adding their name to the list of volunteers out there, need to contact my office and we'll make sure you are able to do that. Finally, we have an upcoming event, uh- a Family Fun Bike Ride. On Saturday, February 25, my office in partnership with the Stop Coalition and the Whitney Recreation Center will be holding a Family Fun Bike Fest at Silver Bowl Park from 10 a.m. to 12 noon. We'll be holding a free raffle for 40 kids bikes. We'll have music, free food from food trucks, a free helmet giveaway, a BMX freestyle demonstration that is really gonna be cool and, of course, a 1.3-mile family bike ride around the park.

Uh- ABC Quick Checks will be there to provide basic bike repairs. So if the only reason you can't come is because you've got a problem with your chain, show up and we'll help you. Registration is recommended and, uh- you can see on this flyer that, uh- there is a registration, there is a, a, an app, a website you can go to.

Finally, we want to thank all of those who have helped us as we've transitioned into the new year. There's a lot happening, the weather has been different, and it is, uh- affected so many things. STEPHANIE ALLEN Good morning. Mister Chair, Commissioners. Stephanie Allen, 1980 Festival

Plaza Drive. With me is Terry Miller with Miller Project Management and we're both here today on behalf of Las Vegas Grand Prix. Also with us is Renee Wilm who is the CEO of the Las Vegas Grand Prix. She, unfortunately her voice has failed her this morning, otherwise she wouldn't be up here instead of me but she is with us here today. And, um- with that said, I would like to just thank your staff very much for all their hard work on this resolution. We very much appreciate it. I'm gonna turn it over to Terry to present to you, umeverything that's associated with this resolution and then we're happy to answer

any questions that you may have.

GIBSON Thank you.

TERRY MILLER So, I have a few, uh- boards to walk through. For the record, Terry Miller with

Miller Project Management, uh- project manager for the LVGP. Um- we are really excited about, uh- the forthcoming Las Vegas Grand Prix. The clock is ticking, the months are flipping by on the calendar, um- but we are, uh- on

**MILLER** 

schedule and, and we anticipate an exciting, uh- event in November.

Just to recap on some of the information that, uh- we've already shared with you before, um- the event itself is obviously in the heart of, of the Resort Corridor. We're gonna have 17 different, uh- turns on the track. We're going to reach mile, uh- miles per hour 212. Which I always get, uh- uh- a little bit, uh- caught up in because the engineers were very precise. It's 212, it's not 215, it's not 218, it's 212. I think we're gonna hit a record, um- for Formula 1 in Las Vegas in terms of the actual, uh- miles per hour for the, for the racers.

Um- in addition, we have shared with you previously the economic impact, uhfor the community. Um- this is a community wide opportunity for, uh- labor force, uh- for vendors, uh- for everybody that's excited about a new opportunity in Las Vegas and Clark County. Uh- we're very proud of what we're doing, umthis obviously provides labor for construction but also for the operation of the event itself. And, uh- if the resolution is passed this ev-, this afternoon or this morning, excuse me, it, it'll be years to come. Um- so the community impact is very significant relative to, to what LVGP, the Las Vegas Grand Prix, uhbrings to our community.

Again, a recap of the circuit itself and what we are doing around, um- the heart of Las Vegas in the heart of the resort community. The track itself is on both private and public land. Um- everything that we are building in a temporary spectator facility or in a permanent track facility is on private parcels. The track itself will be on County right-of-way and on private parcels. But we're excited about the fact that it wraps itself around some of the most world wi-, worldwide recognized resorts, um- here in, in our valley.

Uh- as the track runs down the Boulevard, we will turn, uh- on to Harmon. We will go around the Paddock facility which is the land that was purchased by the LVGP last year and on which we are currently building the Paddock Building. We'll zip down, uh- Koval, we will go around the Sphere, come around s-, uh- Sands and back to the Boulevard. It's 3.8 miles of excitement and we are really, really pleased to be able to bring this, uh- to the valley.

Specific to the resolution, it's about, uh- putting the track on County road roadways. And so, what you see in this illustration is the red dotted line, that is in fact the track but the black lines indicate the County roadways on which we are going to build the track and so that's, that's the, the focus of the resolution. I have to say that we have received, uh- great assistance, uh- from Clark County staff, uh- Public Works, Building Department, Comprehensive Planning, everybody associated with moving this forward in terms of the regulatory authorization to do so have really been uh- uh- an assistance to us throughout this whole process.

From the emergency services side, the Las Vegas Metropolitan Police Department, the Clark County Fire Department have been instrumental in us being able to plan for this event. Not just the facilities that we're building, uhbut also the event itself in terms of its operation, maintaining safety for all of the public that will be participating in the event.

So, I wanna show you just a few slides relative to what we are building over at

**MILLER** 

Harmon and Koval. It's the, it's going to be the, uh- Formula 1 Las Vegas Grand Prix flag in North America. This is where the, the, the, uh- Las Vegas Grand Prix will basically be seen worldwide as the, the flagship for North America. It's, it's a project that is underway, um- it's a project that has received significant attention in terms of its design. We've worked with the community, with the neighbors to make sure that they are all, uh- uh- knowledgeable about what we're doing, when we're doing it, how we're doing it. Uh- again, the neighbors have been tremendously helpful in, in keeping us moving forward on the project.

This shows you a little symbol on top of the, the building that we're building. It's the Formula 1 logo which also turns into a nice LED screen to be seen by millions coming into Las Vegas, uh- from, uh- from the air. Um- again, this is all part of what we're doing over on the property at, uh- Koval and Harmon and we're on schedule to deliver it, uh- for the event in November.

And this is a slide of what we are doing currently or where we are currently on the construction. This is actually outdated 'cause it's a week old. We've already put-

... another level on the building. Um- I would invite any and all of you to come out and walk the site with us. You don't get a sense of the magnitude of this building until you're out on the site. It's a thousand feet long, so it's larger than three football fields. It's 100 feet wide, which is twice a football field, so it's pretty, pretty significant in terms of, uh- the size and configuration of this building on that site.

Uh- again, I'd welcome any of you to, to come out. Let us know and we'll have a hardhat and a yellow jacket for you to walk around the site on. So, with that, um- I'll end the, the presentation and turn it back to, uh- the, the, uh- Commissioners for any questions that we might, uh- be able to answer for you.

GIBSON Now is the time for, uh- the final public comment period. Is there anyone here who wishes to make public comment? If so, please come forward, state your

name, spell your last name, and please keep your comments to three minutes.

Good morning.

MIKE WOLTHER

Good morning. Right. My name is Mike Wolther, nega-, uh- neighborhood advocate for the coalition. Uh- address: 1325 Los Meadows. Fact report on important Town Advisory Board meeting last, uh- Thursday. Our neighborhood volunteer coalition made a strong and unified turnout of about 25 well informed people. We were immediately thrown a curveball as two members of the panel withdrew themselves voting with no transparent explanation of why and leaving a three-member quorum to make this most important votes for the future of our community.

Next came public comments. Speaking first, I stated the coalition's goals: to protect our housing investments, our neighborhood, safety and security and we were not anti-development. We, in fact, support a like kind community with existing zoning that meets all existing county building and safety codes, and the houses to be built as not rentals.

As one of the several elderly single women homeowners had read into the record, I am saddened to hear of a potential high density rental complex in the middle of our single home zoning, it will lower neighborhood safety. I purchased my home as a retirement investment and intended to live there for the next 15 years. This zoning change will only bring trouble closer to our homes and the value of our home investments will be sacrificed.

Next, the project's professional spokesperson, Jennifer, announced a bait and switch, totally new but worse designed project. Our coalition disliked it even more. At that point, the only proper action for that TAB board was to postpone voting until they could analyze the fallibilities of what they were only just introduced to less than an hour before. That is not what happened. The chairperson made an immediate motion for the zone change, it was a split decision one to two commissioners appointed board members with next to no time to even start to analyze.

We have been voting and approve the zoning change bringing home ... Oh, they were voted on to approve the zoning change bringing home the win for the commercial for-profit LLC that they wanted. Yes, it was well, it was all suspected it would be, a fix was in. We invested citizens were betrayed, rolled

WOLTHER over like suckers at a cheap carnival. Shame on them. Please vote no on this

project as it stands and comes before you next session. Thank you.

GIBSON Thank you, sir.

WOLTHER That's my first topic.

GIBSON You've got ... it well ... You've got three minutes altogether.

WOLTHER Three minutes a piece?

GIBSON Is that ... You're finished with your comments?

WOLTHER That, that comment's through.

GIBSON Good, okay. Thank you-

WOLTHER Okay.

GIBSON ... very much, sir. Is there anyone else who wishes to speak during public

comment?

WOLTHER You, I, I noticed that everybody gets to speak on several is-, different issues. I

spoke three minutes and I got under the line.

GIBSON That's right -

WOLTHER You're trying to-

GIBSON Sir, pardon me. If we weren't clear, each speaker has a total of three minutes to

speak on whatever issues they want to address.

WOLTHER Uh- to make that clear, you also say that we should make sure that we have our

one person speak for our Commission. We have three. I don't have three people to be here today. We had 25 people there the other day. They all have jobs, I don't. They've asked me to come read these into you. It's important information

you need to know.

UNIDENTIFIED Sir, you can leave those with the Clerk...

GIBSON Sir, excuse me. Sir, this item is going to be heard and all the details will be in

front of us. And-

WOLTHER This-

GIBSON ... you and your, your neighbors will have an opportunity when the item comes

to us as a zoning item-

WOLTHER These are three-

GIBSON ... in due course.

WOLTHER ... separate, these are three topics. I'm not going to bring up the TAB Board

again. I have another thing.

GIBSON I understand.

WOLTHER Alright-

GIBSON But the-

WOLTHER ... and-

GIBSON ... problem is-

WOLTHER ... I do have what about the three-minute limit. And it's about the, you-

GIBSON Each-

WOLTHER ... violating that (inaudible) That's why (inaudible)

GIBSON And we're really happy to have you provide any information, but you need to do

it like everyone else who comes before us does it. Everyone conforms to the

rule of three minutes. I'm sorry, sir, I, we can't just relax the rule.

WOLTHER ... (inaudible) I can't (inaudible)

GIBSON You can in three minutes. You can conduct your, you, you can use your time

however you wish. You have three minutes.

do all of it in three minutes. You have three minutes. You've used your time.

WOLTHER Well thank you for your, um-lying approach to this whole thing. There are

people who (inaudible).

There, the lights on DI between the Convention Center, there are about 15 lights on DI between the Convention Center that have been out. That's 12% of 'em. They've been out for four months. I'd appreciate it if you would chastise the security of the Las Vegas Convention it's, of 30 for not reporting it, the individual at the fire station and Metro that are a block away for not reporting, and plus every County employee in this room and beyond for not reporting it.

Reference COVID. We're out pro-, promoting COVID vaccines. There is a strong group of information that's counter it. During COVID, we kept track of the deaths. Now the sudden deaths, we don't keep track of it. I encourage you, Mister Chairman, that you, that we hold a debate, a public debate, on it so that people know and we, we can. I encourage you, Mister Chairman, to meet with Wayne Allyn Root, an individual from your district to find his information on it.

Uh- the Chamber of Commerce, the Chamber of Commerce, uh- two weeks ago held their be-, their preview. Um- the president of the group bragged that about 18 companies were participating. Only two of those companies are manufacturing in the, in the County. There's hundreds of companies in the County that do manufacturing and I don't understand why this body and other municipalities don't challenge the Chamber of Commerce to either get in the business of promoting business in the County or to stay with the trips to new, to DC and, and Carson City. You need somebody be promoting the businesses that we have in the City, so that we know what to sell, so that we can build business, so that more people can be employed and pay for their own housing. We, we have all these businesses and they ... But there's no flashlights at ... The convention at that, at the event there, they promoted the, the F1, uh- racing in, in November, they promoted the Super Bowl next year. They didn't promote the National, um- Hardware Show that was the following week. They, they didn't, they don't promote, uh- the magic which is very big.

We should be taking part of that. They didn't promote ASD that comes twice a year, and they didn't promote 334,000 people coming to the MGM in February with the Car-, uh- Grand Cardone. That, there's so much going on in the city that we, that the word doesn't get out, sir. I'd encourage that the, the elected officials learn how to use our conventions in the whole state. Thank you, sir.
