Proposal Abstract



Elevate Girls Program

Clark County Department of Juvenile Justice Services (DJJS) provides diversion, detention, and probation services to youth who encounter the juvenile justice system. In 2021, Clark County Department of Juvenile Justice received 3,378 referrals of those 2,283 were males (68%) and 1,095 were females (32%). The rate of girls entering the juvenile system is slightly higher for Clark County than the national average. The purpose of this project is to reduce girl contact with the juvenile justice system and improve on girls risk level by focusing on girls entering the juvenile justice system on low level offenses.

Research shows a high need for appropriate and comprehensive programs for girls (Anderson et al. 2019). This document proposes the creating of the Elevate Girls Program (EGP), a program where girls entering DJJS on low level offenses participate in the Girls Moving on Program, a gender responsive program. Clark County's DJJS The Harbor, Juvenile Intake, and Juvenile Probation will provide EGP with referrals for girls entering DJJS on low level offenses and EGP work with girls and caregivers. Activities for girls include meeting with case managers, working through the Girls Moving On Program, and following up with girls and caregivers to provide resources, as needed.

It is expected girls going through the EGP will have reduced contact with the juvenile justice system and improve on their risk levels. The service areas include the City of Las Vegas, City of North Las Vegas, City of Henderson, and Boulder City. The intended beneficiaries of this program are girls who enter DJJS for low level offenses, their caregivers, and our community.
