SUMMARY – Establishes the boundaries of the Order Out Corridor; provides for the circumstances when a court may impose an order to stay out of the Order Out Corridor as a condition of a suspended sentence or deferred adjudication of any criminal offense; provides a criminal penalty for any person who violates an order to stay out of the Order Out Corridor; abolishes existing Order Out Corridors relating to misdemeanor drug-related activity and prostitution-related activity.

AN ORDINANCE TO AMEND TITLE 12 OF THE CLARK COUNTY CODE TO ADD A NEW CHAPTER 12.02 (“ORDER OUT CORRIDOR”) TO ESTABLISH THE BOUNDARIES OF AN “ORDER OUT CORRIDOR,” TO PROVIDE FOR CIRCUMSTANCES WHEN A COURT MAY IMPOSE AN ORDER TO STAY OUT OF THE “ORDER OUT CORRIDOR” AS A CONDITION OF A SUSPENDED SENTENCE OR DEFERRED ADJUDICATION OF ANY CRIMINAL OFFENSE, AND TO RENDER A VIOLATION OF AN ORDER TO STAY OUT OF THE “ORDER OUT CORRIDOR” A MISDEMEANOR OFFENSE; TO AMEND TITLE 12, CHAPTER 12.05 TO ABOLISH THE MISDEMEANOR DRUG-RELATED ACTIVITY - ORDER OUT CORRIDOR; TO AMEND TITLE 12, CHAPTER 12.08 TO ABOLISH THE PROSTITUTION-RELATED ACTIVITY - ORDER OUT CORRIDOR; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title 12 of the Clark County Code is hereby amended as follows:

CHAPTER 12.02 - ORDER OUT CORRIDOR

12.02.010 Definitions.

The "Order Out Corridor" shall include that area in Clark County located within the following boundaries:

Beginning from the center line of Sahara Avenue proceeding south along the west side of Sammy Davis Jr. to the north side of Twain Avenue; then turning west to the west side of Valley View Boulevard; then turning south to the north side of Viking Road; then turning west to the west side of Wynn Road; then turning south to the north side of Flamingo Road; then turning west to the west side of Arville Street; then turning south to the south side of West Nevso Drive; then turning east to the east side of South Valley View Boulevard; then turning north to the south side of West Flamingo Road; then turning east to the west side of Dean Martin Drive; then turning west to the north side of Tropicana Avenue; then turning north to the east side of Cameron Street; then turning east to the south side of West Tompkins Avenue; then turning south to the west side of Arville Street; then turning east to the south side of Tropicana Avenue; then turning east to the west side of Dean Martin Drive; then proceeding south to the south side of Russell Road; then turning east to west side of Las Vegas Boulevard South; then turning north to south side of East Reno Avenue; then proceeding north along the east side of Koval Lane ~~turning east~~ to the south side of ~~Tropicana~~ Harmon Avenue; then turning east to the east side of Paradise Road; then turning north to the north side of Flamingo Road; then turning west to the east side of Koval Lane; then turning north to the south side of Westchester Drive; then turning east to the east side of Manhattan Street; then turning north to the south side of Sands Avenue; then turning east to the east side of Paradise Road; then turning north to the south side of Desert Inn Road; then turning east to east side of Joe W. Brown Drive; then turning north to north side of Karen Avenue; then turning west to east side of Paradise Road; then turning north to the center line of Sahara Avenue; then turning west along the center line of Sahara Avenue to the west side of Sammy Davis Jr. Drive.

The Order Out Corridor includes the entire width of the roadway and sidewalks of the streets, avenues and roads described above. The Order Out Corridor does not include Interstate 15 or the property occupied by Harry Reid International Airport.

12.02.020 Order Out Corridor - Condition of Suspended Sentence

(a) If a court:

- (1) suspends all or part of a sentence for a conviction of any criminal offense;
- (2) defers the adjudication of guilt upon a plea of guilty or no contest to any criminal offense; or,
- (3) otherwise withholds the imposition of a sentence or defers adjudication of guilt for any criminal offense;

and if the circumstances warrant, the court may order as a condition of the suspended sentence or deferred adjudication that the defendant stay out of the Order Out Corridor for a period not to exceed one (1) year.

(b) Before ordering the defendant to stay out of the Order Out Corridor, the court shall inquire of the defendant as to the defendant's special reasons for requiring access to any specified areas within the Order Out Corridor, including:

(1) Working or residing within the Order Out Corridor;

(2) The need for medical services within the Order Out Corridor;

(3) The need for access to federal, state and local social services within the Order Out Corridor;

(4) The need for religious services within the Order Out Corridor;

(5) The need for public transportation within the Order Out Corridor; and

(6) The need for legal services or appearances within the Order Out Corridor.

After such inquiry, the court may grant such exemptions from an order to stay out of the Order Out Corridor as the court deems reasonable. Any person granted an exemption pursuant to this subsection shall carry a copy of the order at all times the person is located within the Order Out Corridor.

(c) Any order issued pursuant to this section shall:

(1) describe the boundaries of the Order Out Corridor and any exempted areas therein and shall be accompanied by a copy of a map depicting the perimeters of the Order Out Corridor; and,

(2) prescribe the effective dates of the order.

12.02.030 Violation of Order Out Corridor order.

(a) Any person who wilfully violates an order to stay out of the Order Out Corridor is guilty of a misdemeanor.

(b) Nothing in this section shall limit the authority of the court to impose a sentence or employ any sanction authorized by law for the enforcement of a court order.

SECTION 2. Title 12, Chapter 12.05 of the Clark County Code is hereby amended as follows:

SECTION 3. Title 12, Chapter 12.08.010 of the Clark County Code is hereby amended as follows:

Chapter 12.08 - PROSTITUTION

12.08.010 Definitions.

(a) "Prostitution" means engaging in sexual intercourse, oral-genital contact, anal-genital contact, oral-anal contact, or sado-masochistic abuse as defined in NRS 201.262, or any touching of the sexual organs or female breast of a person for monetary consideration, whether by credit, cash or check except between persons who are legally married to each other.

- (b) "Prostitute" means a male or female person who, for a fee, engages in sexual intercourse, oral-genital contact, anal-genital contact, oral-anal contact, or sado-masochistic abuse as defined in NRS 201.262, or any touching of the sexual organs or female breast of a person, who is not that person's legal spouse, for the purpose of arousing or gratifying the sexual desire of either person.
- (c) "Prostitution referral service" means any person who refers knowingly, or under such circumstances where a person should reasonably know that the person is referring, another for the purposes of prostitution or solicitation thereof.
- (d) "Person" means a natural person, any form of business or social organization and any other nongovernmental legal entity including, but not limited to, a corporation, partnership, association, trust or unincorporated organization.
- (e) "Public place" means any place of business, public building, or other building open to the general public, street, sidewalk, bridge, alley or alleyway, plaza, park, driveway, parking lot or transportation facility or the doorways and entrance ways to any building which fronts on any of the aforesaid places, or a motor vehicle in or on any such place.
- ~~[(f) "Order out corridor" means that area within the county of Clark which is bordered by Industrial Road from Sahara Avenue south to Twain Avenue (including the proposed extension of Twain Avenue from Industrial Road to Procyon Avenue as shown on Exhibit A, attached hereto and incorporated herein as if fully set forth), Twain Avenue west to Valley View, Valley View south to Viking Road, Viking Road west to Wynn Road, Wynn Road south to Flamingo Road, Flamingo Road east to Industrial Road, Industrial Road south to the alignment of Russell Road, the alignment of Russell Road east to Paradise Road, Paradise Road north to Desert Inn Road, Desert Inn Road east to Joe W. Brown Drive, Joe W. Brown Drive north to Karen Avenue, Karen Avenue west to Paradise Road, Paradise Road north to Sahara Avenue, and Sahara Avenue west to Industrial Road. Such suspended sentence may also be conditioned upon such other conditions as the court deems reasonable for the rehabilitation of the defendant and the preservation of the health, safety and welfare of the public. SECTION 6. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 7. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 8. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
