

**SECOND AMENDMENT TO CLARK COUNTY CORONAVIRUS STATE AND LOCAL
GOVERNMENT FISCAL RECOVERY FUNDS (FISCAL RECOVERY FUNDS)
PROGRAM RESOLUTION**

THIS AMENDMENT effective May 6, 2025, ("Amendment") is made and entered into by and between CLARK COUNTY, NEVADA, ("Clark County") and the IMPACT EXCHANGE ("Recipient"), collectively referred to as the Parties ("Parties").

WHEREAS, on May 31, 2022, the Parties entered into a Resolution ("Resolution") to grant to Recipient up to \$700,000 of Fiscal Recovery Funds (CFDA #21.027) ("Funds") for the Recipient's CLARK COUNTY HARM REDUCTION PROGRAM ("Program").

WHEREAS, on September 18, 2023, the Parties entered into the First Amendment to extend the expenditure of the Funds for the Program to December 31, 2024.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein and, in the Resolution, the parties agree as follows:

1. Change the funding source from Coronavirus State and Local Fiscal Recovery Funds (CFDA #21.027) to Clark County Recovery Funds to remit reimbursement of \$369,456.76.

IN WITNESS WHEREOF, this Amendment has been executed and approved and by both Parties. The Parties acknowledge with the exception of the payment of \$369,456.76 the Agreement is completed and the Parties have no further obligations under the Agreement.
