SECOND AMENDMENT TO CONTRACT LABOR SERVICES FOR OWNER REPRESENTATION

This Second Amendment ("Second Amendment") to Contract Labor Services For Owner Representation ("Contract") is made on this _______, by and between CLARK COUNTY, NEVADA, through its Department of Aviation (hereinafter referred to as "OWNER"), and AECOM TECHNICAL SERVICES, INC. (hereinafter referred to as "CONSULTANT"), for contract labor services for airport construction projects (the "PROJECT"). OWNER and CONSULTANT may each be referred to herein as "Party" or collectively as "Parties."

WITNESSETH:

WHEREAS, the Parties entered into the Contract on February 4, 2020 for the Project;

WHEREAS, the Contract was previously amended on January 17, 2023 (the "First Amendment");

WHEREAS, the Parties desire to amend the Contract to extend the term until February 4, 2026, add one additional one-year term extension option, which if exercised would extend the term until February 4, 2027, and increase the not to exceed payment amount; and

WHEREAS, it is the intent of the Parties that except as expressly amended and modified by the provisions and conditions of the First Amendment and this Second Amendment, the Contract shall and will remain in full force and effect.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

Action 1: SECTION V(A) shall be deleted and replaced as follows:

A. OWNER agrees to pay CONSULTANT for the performance of services described in the Scope of Services (Exhibit A) a not to exceed amount of \$21,000,000.00. The OWNER's obligation to pay CONSULTANT cannot exceed such fixed fee amount. Any balance remaining at the conclusion of the PROJECT will be deducted from the Contract amount through an amendment to the Contract.

Action 2: SECTION VII(N) shall be deleted and replaced as follows:

N. Term of Contract

The term of this Contract shall be from February 4, 2020 through February 4, 2026. The OWNER has the option to extend this Contract by written notification from the Director of Aviation for one additional one-year term, which if exercised would extend the term until February 4, 2027.

Action 3: Exhibit E to the Contract, entitled "Disclosure of Ownership/Principals Form," shall be deleted and replaced with the Exhibit E attached to this Second Amendment.
