

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2
TRAFFIC SIGNAL IMPROVEMENTS PROGRAM
PACKAGE 103**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 is made and entered into this 12TH day of August 2021, by and between Clark County, a political subdivision, hereinafter referred to as "COUNTY" and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as "RTC."

W I T N E S S E T H

WHEREAS, the RTC approved Interlocal Contract #1212 dated August 13, 2020, and supplemental interlocal contract dated July 8, 2021, for improvements to Traffic Signal Improvements – Package 103, hereinafter referred to as "PROJECT," located wholly within Clark County; and

WHEREAS, Nevada Revised Statute (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the COUNTY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the COUNTY wishes to increase total PROJECT funding; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the Parties hereto, the Parties agree to proceed as follows:

SECTION II: PROJECT COSTS; Paragraphs 1 and 2 shall be revised to read as follows:

1. The total cost for this contract shall not exceed \$6,400,000.00.
2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$0.00
 - b. RIGHT-OF-WAY not to exceed \$0.00
 - c. CONSTRUCTION not to exceed \$6,400,000.00

The remainder of Interlocal Contract #1212 dated August 13, 2020, and supplemental interlocal contract dated July 8, 2021, shall remain unchanged.

Description of and Reason for Change(s):

During construction, Clark County Public Works extended the limits for pavement rehabilitation along Gomer Road to include from east of El Capitan Way to west of Durango Drive and from east of Durango Drive to west of Bella Cosa Street, and also, along south bound Durango Drive from south of Gomer Road to south of Moreno Mountain Avenue. Initially the roadway rehabilitation only included 1-inch of UTACB at the intersection of Durango Drive and Gomer Road as well as striping along Gomer Road; However, the existing conditions along Gomer Road and Durango Drive beyond this intersection have deteriorated so additional milling, placement of 1-inch of UTACB, and striping are warranted.

A Construction Change Authorization (CCA) shall be executed to specifically outline this scope of work. It is estimated that this work will have a cost of approximately \$700,000.00, which is the basis for this Change Order request. These funds will be needed to add to the Contract for completion of this needed work.


