BACKGROUND:

The District's Plant Operations utilizes wastewater pumps that are critical to meeting the requirements of the National Pollutant Discharge Elimination System (NPDES) effluent discharge permit. This contract will provide access to a highly specialized off-site machine shop, with heavy equipment and industrial parts that are necessary for repair of these large and intricate pumps. Additionally, this contract will include the reconditioning, overhauling, and installation services of pumps and other related equipment used in wastewater processing and conveyance.

An Invitation to Bid (ITB) No. 230008, for Pump Repair and Maintenance Services, was advertised on February 23, 2023, in the Las Vegas Review Journal and posted on the District Website. On April 6, 2023, four (4) firms responded by submitting bids. The bid results are as follows (the noted "corrections" accounted for mathematical discrepancies found during bid evaluation). Staff will submit an annual report to the Board detailing incurred expenditures.
