### EXTENSION OF THE TELECOMMUNICATIONS UTILITY SYSTEM

# FRANCHISE AGREEMENT

# ZAYO GROUP, LLC successor in interest to ELECTRIC LIGHTWAVE, LLC d/b/a INTEGRA TELECOM

THIS FRANCHISE EXTENSION is granted this 16th day of April, 2024, by Clark County, Nevada, a political subdivision of the State of Nevada, acting by and through its Board of County Commissioners which is its governing body (hereafter called "County"), to Zayo Group, LLC, a Delaware limited-liability company as successor-in-interest to Electric Lightwave, LLC d/b/a Integra Telecom (hereafter called "Franchisee") which is authorized by the Public Utilities Commission of Nevada to do business in the State of Nevada.

#### WITNESSETH:

*WHEREAS*, on April 7, 2009, the Clark County Board of County Commissioners awarded a Telecommunications Utility System Franchise Agreement to Electric Lightwave, LLC d/b/a Integra Telecom to construct, operate and maintain its telecommunication network serving its customers within Clark County until April 7, 2019; and

**WHEREAS**, the Franchise Agreement was extended for a five-year period pursuant to the provisions of Clark County Code Subsection 5.01.070(c) until April 7, 2024; and

**WHEREAS**, the Franchisee desires to apply for a new franchise agreement to construct, operate and maintain its telecommunication network serving its customers within Clark County; and

*WHEREAS*, Zayo Group, LLC acquired Electric Lightwave, LLC on March 1, 2017, and is the successor-in-interest; and

**WHEREAS**, the Franchisee desires to extend the current Franchise Agreement for an additional period not to exceed six months under the same terms and conditions as the existing Telecommunications Utility System Franchise Agreement to finalize the proposed new agreement.

## **NOW THEREFORE**, the County agrees to the following:

- 1. The existing Telecommunications Utility System Franchise Agreement is extended beginning April 7, 2024, for a period not to exceed six months until October 7, 2024, or until a new agreement is approved by the Clark County Board of County Commissioners, whichever occurs first (the "Extension Period"), during which time the parties agree to work together to develop a new agreement.
- 2. During the Extension Period, all terms and conditions set forth in the Telecommunications Utility System Franchise Agreement shall continue in full force and effect.

3. This extension of the Telecommunications Utility System Franchise Agreement shall be without prejudice to any rights of either party under any federal, state or local laws or regulations. Other than extending the term of the Telecommunications Utility System Franchise Agreement for the duration of the Extension Period, this extension shall not expand or limit the rights of either party, create new rights that would not have existed without the extension, or adversely affect either party's rights in any proceeding. No claim that either party may have against the other shall be released or otherwise affected by this extension.
