
Highlights 2023



- Department of Aviation celebrated its 75th anniversary on December 19th
- Harry Reid International Airport 7th busiest of any airport in the nation
 - Shattered Annual Passenger Record with 57.6 Million in 2023
 - Previous record was 52.6 million in 2022
 - Domestic travel was at an all-time high with 53.3 million passengers
 - International travel recovering, surpassing 3 million passengers for the first time since 2019, with 3.2 million
 - 11 of the 12 months in 2023 set records for that month
- Overall throughput for TSA checkpoints was 7th busiest of any airport in the nation
 - Daily passenger throughput averaged over 90,000 passengers a day
 - October 2023 busiest month in Las Vegas history
- Ranked 3rd highest in passenger satisfaction across all mega airports in 2023 by J.D. Power

Total Passengers 2018-2023




