BACKGROUND:

Bid No. 606176-22, for Annual Requirements Contract for Testing, Inspection, Maintenance Services and Purchase of Portable Fire Extinguishers Countywide was advertised on April 12, 2022 and opened on May 18, 2022. The Bid Amounts are as follows:

*GF Fire Design, LLC requested the opportunity to withdraw in lieu of being formally rejected because of calculation errors.

This Contract is for Testing, Inspection, Maintenance Services and Purchase of Portable Fire Extinguishers Countywide.

The following are the pertinent provisions of the Contract:

- The term of the Contract is from date of award through June 30, 2023 and includes the option to renew for 4, one-year periods.
- Includes the option to increase the award amount up to 10% based on possible increased user requirements for the renewal terms and approved budget appropriations.
- Includes the option to increase the award amount up to 3% for possible price increases for renewal terms.
- Includes the County's option to terminate for cause, convenience or default and suspend the Contract with
