- A. WHEREAS Karpel Solutions and County have entered into an Agreement, CBE No. 606628-23, entitled "Criminal Case Management System," with exhibits and incorporated documents, for Software Products and Services associated with PROSECUTORbyKarpel®, effective September 27, 2023 ("the Agreement"); and

- C. WHEREAS the Agreement allows the parties to amend the Agreement, contingent upon the mutual written confirmation provided by both parties.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties—with the intent to be legally bound—agree to the following:

Modification of Exhibit A "Criminal Case Management System Scope of Work:"
 The services include data conversion from multiple databases as outlined in the Investment Summary and Pricing, Professional Services. County has identified additional databases for conversion with cost to be incorporated with the

Agreement—Tyler Supervision database \$40,000 (Qty. 1) and File Server \$15,000 (Qty. 1) for a total of \$55,000. In addition, County has eliminated the need for conversion of "Data Conversion: Civil (provided as SQL data)," and parties have agreed that Karpel Solutions will instead do a one-time conversion of data from the Child Welfare division's Unity database; parties agree that the costs offset, so there will be no additional costs added to the contract for conversion of the Unity database. The Agreement will be amended by this document to include the additional services and cost, which is hereby incorporated into the terms of the Agreement, and which is deemed to be a part of the Agreement as set forth in full herein.

2. <u>Incorporation and Ratification of Terms:</u> In all other respects, including compensation and scope of work, the undersigned parties hereby ratify and confirm the Agreement as it was originally drafted and executed by the parties.
