I was initially appointed to this Board pursuant to NRS 380.030 to fill a vacancy created by the death of my father, Thomas D. Beatty, in April 2020. The Board approved my interim appointment in July 2020.

The Clark County Commission then approved my appointment to a two-year term as a Trustee in December 2020, and approved my appointment to a second two-year term as a Trustee in December 2022.

My term of office expires on December 31, 2024.

In 2016, I opened my own law firm, Peterson Baker, PLLC.

Separately, I have an extensive background in volunteer and nonprofit organizations, serving as a board member, President, and Chairman of various nonprofit groups over time.

As an attorney with a varied and demanding practice, I have excellent written and communication skills, as well as analytical and legal research skills. Due to my background in the nonprofit sector, I have significant skills in nonprofit management, governance, and leadership.

I am a lifelong Nevada, born and raised in Las Vegas. On a personal note, I spent formative years researching in the Clark County Law Library, learning research skills from my father, who served many years on this important Board. I would like to continue to dedicate my skills toward promoting access to sources of law and community resources, as this Board is charged to do.
