**ANNUAL REQUIREMENTS CONTRACT FOR FLOOD CONTROL CHANNEL**  
**MAINTENANCE AND HOMELESS ENCAMPMENT CLEANUP**

**THIS AMENDMENT** is made and entered into this \_\_\_\_ day of \_\_\_\_\_ 2021, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and BRIGHTVIEW LANDSCAPE SERVICES INC (hereinafter referred to as "SUCCESSFUL BIDDER").

**WITNESSETH:**

**WHEREAS**, the parties entered into an agreement under Bid Number 605675-20, entitled "Annual Requirements Contract for Flood Control Channel Maintenance and Homeless Encampment Cleanup" dated February 3, 2021 (hereinafter referred to as **CONTRACT**); and

**WHEREAS**, the parties desire to amend the **CONTRACT**.

**NOW, THEREFORE**, the parties agree to amend the **CONTRACT** as follows:

1. Special Conditions, Page III-1, Section 1, Documentation Submittal Required by Apparent Low Bidder

Add the following line items:

J. Provide copies of any OSHA, EPA, or other regulatory body violations or citations in regard to the type of work that is being performed, for the past five (5) years.

K. **SUCCESSFUL BIDDER** shall provide copy of MCS-90 Endorsement Coverage.

2. Bid Response for Package 2, Item 2.1, originally read:

4. COUNTY agrees not to exercise its right to Terminate for Convenience under Page II-5, Section 35— Termination for Convenience, through the initial term of the CONTRACT.


This Amendment No. 1 represents a decrease of \$95 per cubic yard on Package 2, Line 2.1.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.


