**AMENDMENT NO. 1
RFQ NO. 606252-22
JUVENILE ASSESSMENT CENTER**

THIS AMENDMENT is made and entered into this ____ day of _____ 2024, by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY”), and EAGLE QUEST (hereinafter referred to as “PROVIDER”).

WITNESSETH:

WHEREAS the parties entered into an agreement under RFQ Number 606252-22, entitled “JUVENILE ASSESSMENT CENTER” dated April 29, 2024 (hereinafter referred to as CONTRACT); and

WHEREAS the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Section I: Term of Contract, Section A, Compensation, Page 12.

ORIGINALLY WRITTEN

COUNTY agrees to pay PROVIDER for the performance of services described in the Scope of Work (Exhibit A) and Fee Schedule (Exhibit D) for not-to-exceed amount of \$3,036,854.88 annually. COUNTY'S obligation to pay PROVIDER cannot exceed the fixed fee not-to-exceed amount. It is expressly understood that the entire work defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that hours and tasks are properly budgeted, so the entire PROJECT is completed for the said fee.

REVISED TO READ

COUNTY agrees to pay PROVIDER for the performance of services described in the Scope of Work (Exhibit A) and in accordance with the fixed fees listed herein, Fee Schedule (Exhibit D). COUNTY'S obligation to pay PROVIDER cannot exceed the fixed fee not-to-exceed amount in Exhibit D. It is expressly understood that the entire work defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that tasks are properly budgeted, so the entire PROJECT is completed for the said fee.

2. Exhibit A, Scope of Work, 4th paragraph, Page A-1.

This contract is to operate four (4) Juvenile Assessment Centers - one (1) Juvenile Assessment Center located in Henderson, one (1) in North Las Vegas, and two (2) locations in Las Vegas, Nevada, as well as possible future sites. Juvenile Assessment Centers shall provide a coordinated approach which contributes to the safety of youth, families, and the community through early intervention and improved access to appropriate services in Clark County, Nevada. Juvenile Assessment Centers shall provide early intervention screening, assessment, and services to youth, family development, as well as mental health and substance use related issues. The types of programming providers offer may include tutoring, mentoring, drug/alcohol education, conflict resolution, anger control, social skills training, job skills development, counseling sessions, or cognitive behavioral therapy.

REVISED TO READ

This contract is to operate three (3) Juvenile Assessment Centers - one (1) Juvenile Assessment Center located in Henderson, one (1) in North Las Vegas, and one (1) location in Las Vegas, Nevada, as well as possible future sites. Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.


