

This letter of interest is to accompany my application for the Clark County Regional Opioid Task Force here in Las Vegas, Nevada. With 5+ years of working wholeheartedly as an independently licensed Substance Abuse Counselor through the Nevada State Board of Alcohol, Drug, and Gambling Counselors, I am confident in my ability to contribute my extensive addiction therapy knowledge to increasing awareness and decreasing opioid fatality rates.

My experience stems from personal dedication to Addiction Medicine programs here in Las Vegas, where I would provide intervention therapy to hundreds of patients, along with their families, that were suffering from severe opioid dependency -along with numerous additional illicit substances- tied with co-occurring unaddressed mental health concerns and adverse childhood traumas. I was privileged to work alongside North Las Vegas Police Department, Nevada Parole and Probation, Child Protective Services, Southern Nevada Health District, We would collaborate care tirelessly and shared the same goal of guiding our client towards a better path. I would pride myself on my ability to make each of my patients feel individually supported while in my care, no matter if it was a brief interaction before unfortunately relapsing and signing themselves out AMA, or if they were taking the first step in for long-term treatment and change their lives for the better.

While working in outpatient therapy, I identified a pattern of suppressed and unaddressed adverse childhood experiences (ACES) linked as one of the main root causes for illicit drug use in a majority of my patients that were desperately seeking recovery. I then made the difficult decision to exit addiction medicine/behavioral health rehabilitation therapy (which was unfortunately harm-reduction in most cases) and redirected my efforts towards our atrisk, tier 3, children. I am now serving as a Substance Abuse Therapist with the Clark County School District, Invo IMPACT Program, which is a team-based approach that supports high-

risk students by addressing underlying causes of unwanted behaviors.

I now provide substance abuse counseling support services to students both directly and indirectly suffering from the negative effects of addiction and illicit substance use. I now have the privilege to collaborate with Principals, Assistant Principals, School Counselors, Nurses, CCSD Police, Student Success Coordinators, and so many others. I am personally equipping students with self-awareness, self-management, coping skills, stress reduction, and personal empowerment that they will undoubtedly need in order to be able to identify and confidently reject the temptations of addiction. If a student has experienced any type of traumatic event such as; verbal abuse, physical abuse, sexual abuse, physical/emotional neglect, domestic violence, has previously been taken/held captive, has an incarcerated relative(s), or has been previously diagnosed with a mental health concern, they are at an increased risk of developing a DSM-5 Diagnosed Substance Use Disorder (SUD) by the age of 12. I believe our adolescent community is our strongest weapon in this opioid epidemic drug war we are currently facing, it starts with them.

As a Vegas-Born Substance Abuse Counselor, I take an immense amount of pride in my Vegas roots. However, I internally fear the systematic commercialized normalization of drug and alcohol use that our local youth is absorbing on a daily basis. Our students are not just in dire need of mental health support, but also in dire need substance use education, prevention, and for many students -that have already fallen victim to the temptations of alcohol and/or drugs- addiction therapy.

My ultimate goal, is to continue to provide education and facts for every student, no matter if they are currently using a substance themselves, or have a family member or friend that does. I tell every student willing to listen that addiction is looming all around them, waiting for a moment of their weakness, lack of judgment, or to prey on their vulnerability, pain, trauma, or simple curiosity to ultimately hijack their young lives.

I am passionate about delivering results and exceeding goals, which is why I believe that my expertise would make a valuable contribution to the task force team. My interest in this opportunity only intensified after recently attending the Las Vegas DEA 2023 Opioid Youth

Summit this past September at the Venetian Resort. I view this task force as a way to dedicate my part in giving back to the same community I was born and raised, which is why I greatly look forward to this opportunity to become a member of the Clark County Opioid Task Force.
