This results in referral to appropriate mode of treatment (disease or prophylactic) of individuals.

Since 2018, as Executive Director of Impact Exchange the shift has been toward the behaviors of one specific risk population — user of illicit drugs — working with needs of safe injection supplies, disease exposure, wound care, and linkage into care. This last part of linkage involved meeting individuals where possible — outreach to street, encampments, tunnels, participation with overdose admits in emergency departments, and individuals directly into store front exchange facility seeking treatment/information. Impact Exchange dispenses 35-55,000 syringes a month and disposes of 30-52,000 syringes per month, seeing between 15-40 individual per day. Currently as part of the operations Impact Exchange, through Trac-B Exchange LLC which has a sole source contract with the State of Nevada, to supply up to 1.8 million syringes a year for clean and safe injection usage.

Added to the above experience Rickey Reich is also the founder and executive director of Trac-B Exchange LLC. This is a private consulting company originally developed (2015) prior to inception of the nonprofit Impact Exchange, to gain and purchase supplies at low cost for injection drug users in Nevada working with and for various nonprofits in the community. This company currently works with Impact Exchange exclusively per an agreement with the Board of Directors of Impact Exchange - seeking low-cost supplies, servicing and stocking public health harm reduction vending machines, helping with coordination of supplies, and leasing spaces for activities for Impact Exchange.

In closing I would add that my educational background is a dual BA in Behavior Science and Psychology from California State University Dominquez Hills, located in Los Angeles County.

Coalition of HIV and AIDS Services Providers – becoming a non-profit in 1995; 1993 collaborated with the State of Nevada to induce HIV testing into all local drug and alcohol treatment sites locally; 1994 started the first of an on-going relationship with county and city jails for HIV testing and surveillance; 1995 introduce HIV specimen collection at various social and non-traditional venues; 1996 introduced free HIV T-Cell testing to aid the surveillance of HIV/AIDS in Clark Co; 1998 successfully became the fiftieth EMA under HRSA Ryan White adding 3.5 million dollars directly to Clark Co. to aid care of HIV/AIDS; 2001 introduced the first "one-stop" shopping site for Ryan White Services (discontinued 2003); 2005 assumed leadership and responsibilities for all SNHD Medical Case Management and STD activities; successfully lower the number of pediatric syphilis diagnoses after ranking No. One in the USA; in 2008 combined the HIV evaluation clinical services with STD clinical at a off-site Public Health location; and in 2013 developed the first SNHD Physician staffed HIV/STD clinical services program

2014 retired from public service and began Trac-B Exchange LLC a consulting business to assist in promoting positive public health outcomes; 2017 opened the first needle exchange program in Clark Co. providing free harm reduction supplies, HIV and Hep C rapid testing; 2018 helped develop IMPACT EXCHANGE a non-profit corporation to assist community harm reduction partnerships.
