SUMMARY – An Ordinance to amend Title 2, Chapter 2.90, Section 2.90.040 of the Clark County Code by removing the requirement for an annual audit of the funds allocated; and providing for other matters properly relating thereto.

AN ORDINANCE TO AMEND TITLE 2, CHAPTER 2.90, SECTION 2.90.040 OF THE CLARK COUNTY CODE BY REMOVING THE REQUIREMENT FOR AN ANNUAL AUDIT OF THE FUNDS ALLOCATED; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title 2, Chapter 2.90, Section 2.90.040 of the Clark County Code shall be amended to provide as follows:

2.90.040 Establishment of the County Arts Plan – Selection of works of art.

(a) The board of county commissioners shall approve an annual County Arts Plan for works of art and other artistic programs and projects in the county. The county department of parks and recreation shall establish the initial plan for presentation to the board for approval at the first regular board meeting in December of 2012. Subsequent revisions of the plan shall be submitted to the board in conjunction with the county's annual budget for the next fiscal year. The department, in making its annual recommendation, shall include:

- (1) Proposed acquisitions, commissions or purchases of works of art in conjunction with capital improvement projects;
- (2) Proposed acquisitions, commissions or purchases of works of art for sites

and locations on public property or in public works not in conjunction with capital improvement projects, with the exception of works of art given to or purchased by museums;

(3) Proposed artistic programs and projects;

(4) Progress reports and completion plans regarding uncompleted works of art previously approved by the board, ~~[including an audit of the funds allocated for such works of art];~~

(5) Ongoing maintenance of works of art; and

(6) Requested funding from the County Arts Fund for proposed and ongoing works of art and other artistic programs and projects.

(b) In presenting the annual County Arts Plan to the board each year, the county department of parks and recreation shall make recommendations with respect to proposed acquisitions, commissions or purchases of works of art. For purposes of determining which specific works of art to include in the recommendations to the board, department staff may work with a designated arts agency, if one has been established by the board, or may establish an arts jury community made up of art administrators, artists, and interested county citizens.

SECTION 2. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
