**WITNESSETH:**

**WHEREAS** the parties entered into an agreement under Bid Number 606957-24, entitled "ANNUAL REQUIREMENTS CONTRACT FOR CUSTODIAL SERVICE ON LAS VEGAS BOULEVARD PEDESTRIAN BRIDGE, ELEVATOR, ESCALATOR, BOLLARDS, AND SIDEWALKS" dated DATE OF AWARD (hereinafter referred to as CONTRACT); and

**WHEREAS** the parties desire to amend the CONTRACT.

**NOW, THEREFORE,** the parties agree to amend the CONTRACT as follows:

1. Service Specifications, Page IV-2, Section 1.2 Hours and Days of Service, Bullet Point C Las Vegas Boulevard Sidewalks, Second Paragraph.

- C. Las Vegas Boulevard Sidewalks  
Evening Shift: SUCCESSFUL BIDDER shall provide a minimum of two (2) custodial service personnel working independently one shift each evening, 3:30 p.m. to 12:00 a.m., Friday and Saturday and all legal holidays. This service shall include all COUNTY maintained sidewalk areas, bollards, news racks and items as shown on Exhibits B, C & D. Refer to table below. All Work performed shall be in accordance with the specifications set forth herein or as otherwise approved by COUNTY.

**REVISED TO READ:**

- C. Las Vegas Boulevard Sidewalks  
Evening Shift: SUCCESSFUL BIDDER shall provide a minimum of two (2) custodial service personnel working independently one shift each evening, 3:30 p.m. to 12:00 a.m., seven days a week, including all legal holidays. This service shall include all COUNTY maintained sidewalk areas, bollards, news racks and items as shown on Exhibits B, C & D. Refer to table below. All Work performed shall be in accordance with the specifications set forth herein or as otherwise approved by COUNTY.
2. NGEM Line-Item No. 7 has increased from \$13,434.50 to \$21,114.50 per month, for a new extended total of \$253,374.00.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.

This Amendment No. 1 represents an increase of \$318,579.49.
