RE: Request for Waiver of 1,500-Foot Distance Separation Requirement 3525 S Fort Apache Rd, Las Vegas, Nevada

To Whom It May Concern:

I, Rody Yousif, am the sole member and authorized representative of Platinum Management Group 8 LLC, the applicant for a business license at 3525 S Fort Apache Rd, Las Vegas, Nevada. Our application is being represented by Jay Brown, Esq. of Brown, Brown & Premsrirut.

In accordance with Clark County Code, we respectfully submit this formal request for a waiver of the 1,500-foot distance separation requirement from a school.

Distance Separation Details

According to the Certified Evidence of Separation Distance Survey prepared by HMC Land Surveying, LLC, dated October 24, 2025, and included with this request:

- The only school located within the 1,500-foot analysis area is Hayes Elementary School,9620 W Twain Ave, Las Vegas, NV 89147
- Based on the certified survey measurements, the distance from the nearest entrance of Hayes Elementary School to the proposed business location at 3525 S Fort Apache Rd is 1,398 feet (measured to the school's northern-most driveway).

The survey confirms that the measurement was performed in accordance with Nevada Revised Statutes and Clark County requirements, using the required pedestrian-travel method from the school entrance along approved pathways.

Basis for Waiver Request

Because the certified measurement identifies a distance of 1,398 feet, which is 102 feet short of the 1,500-foot requirement, Platinum Management Group 8 LLC is respectfully requesting a waiver based on the following compelling justification:

- 1. The separation deficiency is minimal and does not indicate any direct conflict or exposure risk to the school.
- 2. The school entrance used for measurement is a bus-only directional driveway, limiting public pedestrian access, thus reducing practical proximity concerns.
- 3. All operations of the applying business will comply fully with Clark County laws, security requirements, age-restricted product control, and operating conditions.
- 4. The applicant has a long and compliant operating history in Clark County with no adverse licensing actions.

Request

Platinum Management Group 8 LLC respectfully requests that Clark County Business Licensing grant a waiver of the 1,500-foot school distance separation requirement for the property located at 3525 S Fort Apache Rd based on the documented certified distance, the nature of the school entrance, and the minimal variance from code requirements.
