**AMENDMENT NO. 1

SMOG-FREE CLARK COUNTY VEHICLE REPAIR PROGRAM**

**THIS AMENDMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2026 by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY”), and VALLEY CAN (hereinafter referred to as “PROVIDER”).

**WITNESSETH:**

**WHEREAS** the parties entered into an agreement under CBE Number 607139-24, entitled “Smog-Free Clark County Vehicle Repair Program” dated July 16, 2024 (hereinafter referred to as CONTRACT); and

**WHEREAS** the parties desire to amend the CONTRACT.

**NOW, THEREFORE,** the parties agree to amend the CONTRACT as follows:

- 1. Exhibit A: Smog-Free Clark County Vehicle Repair Program Scope of Work, Page A1, Paragraph C, Program Overview.

**ORIGINALLY READ:**

In an effort to continue air quality improvements, COUNTY is extending the PROGRAM and modifying the eligibility requirements. COUNTY removed income verification while maintaining a 2006 model year cap. These changes will cast a wider net and extend the reach of the PROGRAM so that more residents are able to qualify. Without an income verification requirement, COUNTY can increase the number of vehicles that can be served by the PROGRAM. The PROGRAM will be administered by COUNTY and managed by PROVIDER. All payments to the smog and repair facilities (SUBCONTRACTORS) will be managed by PROVIDER.

**REVISED TO READ:**

In an effort to continue air quality improvements, COUNTY is extending the PROGRAM and modifying the eligibility requirements. COUNTY removed income verification and will determine model year eligibility with input from PROVIDER. These changes will cast a wider net and extend the reach of the PROGRAM so that more residents are able to qualify. Without an income verification requirement, COUNTY can increase the number of vehicles that can be served by the PROGRAM. The PROGRAM will be administered by COUNTY and managed by PROVIDER. All payments to the smog and repair facilities (SUBCONTRACTORS) will be managed by PROVIDER.

This Amendment No. 1 represents a no cost change.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
