Issue: CDAC APPOINTMENTS 2-Year Term

Subject/Title:

Community Development Advisory Committee (CDAC)

Recommended Action:

Approve and Authorize the Chair to appoint five (5) additional members (including 1 At-Large member, 2 Representatives, and 2 Alternates) to the Community Development Advisory Committee (CDAC), for a two-year term, from the list of the following nominees: (One (1) At-Large) Patrina McKinney; (Representing two (2) Town Advisory Boards/Citizens Advisory Councils) Representatives Vernon W. Pollock and James Ortiz; (Two (2) Alternates) Laren Abbott and Lori Houston, and to recognize the appointment of one (1) member to CDAC by a participating city, Diana Ramirez (North Las Vegas). (For possible action)

Summary:

Clark County's Urban County CDBG Consortium for FY 2024-2026 includes the unincorporated County, Boulder City, and Mesquite. The Cities of North Las Vegas, Las Vegas, and Henderson elected not to participate in the CDBG consortium agreement. However, the City of North Las Vegas will continue to participate with the county's HOME Consortium for FY 2024-2026.

An ordinance was adopted on October 20, 1981, creating a citizens advisory committee to enhance public accountability during the CDBG, ESG, and HOME program planning, application, and implementation phases. MIR #5470, issued August 27, 2009, explains the role and purpose of the CDAC, including its long history of citizen involvement and participation.

The CDAC consists of a potential thirty-six (36) members: a representative from each of the nineteen (19) town advisory boards and citizens' advisory councils and fourteen (14) at-large members appointed by the Commission. CDAC membership also includes one representative from each of the three (3) participating cities of North Las Vegas, Boulder City, and Mesquite that serve as non-voting members.

The additional appointments will increase the CDAC members as follows: sixteen (16) representatives, ten (10) at-large members, and one (1) representative from the participating cities serving as non-voting members for a total of twenty-seven (27) CDAC members.
