215 BRUCE WOODBURY BELTWAY LANDSCAPE MAINTENANCE

THIS AMENDMENT is made and entered into this _____ day of _____ 2023, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and BRIGHTVIEW LANDSCAPE SERVICES, INC. (hereinafter referred to as "SUCCESSFUL BIDDER").

WITNESSETH:

WHEREAS, the parties entered into an agreement under Bid Number 606231-22, entitled "215 Bruce Woodbury Beltway Landscape Maintenance" dated February 7, 2023 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. IV-Service Specifications, Page IV-1, Section 1.2, 1st Paragraph:

ORIGINALLY WRITTEN:

The maintenance work shall include but not limited to: unpaved shoulders along the 215 alignment, frontage roads, ramps and bridges within the right-of way of the 215 Bruce Woodbury Beltway and appurtenant facilities, located generally between approximately 1,800' east of Valley View Blvd heading westward to **215/North 1-15** interchange for a length of approximately **38.5** miles which equates to approximately **1,297** acres. Such facilities to be maintained shall include but not be limited to unpaved portions of the Beltway, medians, right-of-way areas behind sound walls, the non-motorized trail corridor (including paved trail) from South Pecos Road to West Charleston Boulevard, dog bag stations, drainage conveyances within or adjacent to the beltway right-of-way and paved and unpaved maintenance roads. The limits described above are collectively shown on the Exhibit A- Landscape Maintenance Map.

REVISED TO READ:

The maintenance work shall include but not limited to: unpaved shoulders along the 215 alignment, frontage roads, ramps and bridges within the right-of way of the 215 Bruce Woodbury Beltway and appurtenant facilities, located generally between approximately 1,800' east of Valley View Blvd heading westward to **Range Road** for a length of approximately **40** miles which equates to approximately **1,447** acres. Such facilities to be maintained shall include but not be limited to unpaved portions of the Beltway, medians, right-of-way areas behind sound walls, the non-motorized trail corridor (including paved trail) from South Pecos Road to West Charleston Boulevard, dog bag stations, drainage conveyances within or adjacent to the beltway right-of-way and paved and unpaved maintenance roads. The limits described above are collectively shown on the Exhibit A- Landscape Maintenance Map.

2. IV-Service Specifications, Page IV-2, Section 1.3, Item C:

ORIGINALLY WRITTEN:

SUCCESSFUL BIDDER shall provide landscape maintenance personnel for each regularly scheduled shift as follows:

- The staff for these areas shall include a minimum of **five (5)** full time landscape maintenance workers for each shift, to perform all work in accordance with the specifications set forth herein or as otherwise approved by COUNTY.
- In addition, SUCCESSFUL BIDDER shall provide a minimum of one (1) irrigation technician once per week per shift to perform weekly inspection of the irrigation system plus additional time to troubleshoot irrigation problems and make repairs associated with the irrigation system and perform all work in accordance with the specifications set forth herein or as otherwise approved by COUNTY.
- Providing a minimum of **five (5)** maintenance personnel does not relieve SUCCESSFUL BIDDER of his/her obligations to perform under this CONTRACT.

REVISED TO READ:

SUCCESSFUL BIDDER shall provide landscape maintenance personnel for each regularly scheduled shift as follows:

- The staff for these areas shall include a minimum of **seven (7)** full time landscape maintenance workers for each shift, to perform all work in accordance with the specifications set forth herein or as otherwise approved by COUNTY.
- In addition, SUCCESSFUL BIDDER shall provide a minimum of one (1) irrigation technician once per week per shift to perform weekly inspection of the irrigation system plus additional time to troubleshoot irrigation problems and make repairs associated with the irrigation system and perform all work in accordance with the specifications set forth herein or as otherwise approved by COUNTY.
- Providing a minimum of **seven (7)** maintenance personnel does not relieve SUCCESSFUL BIDDER of his/her obligations to perform under this CONTRACT.
