

**AMENDMENT NO. 2
CBE 604895-18
MASTER CONTRACT FORENSIC PATHOLOGY SERVICES**

THIS AMENDMENT is made and entered into this ___ day of _____ 2023, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and VENDOR'S NAME (hereinafter referred to as "PROVIDER").

WITNESSETH:

WHEREAS, the parties entered into an agreement under CBE Number 604895-18, entitled "FORENSIC PATHOLOGY SERVICES" dated DATE OF AWARD (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Page 1, SECTION I: TERM OF CONTRACT.

Original:

COUNTY agrees to retain PROVIDER for the period from date of Contract execution through June 30, 2019, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract.

Replace:

COUNTY agrees to retain PROVIDER for the period from date of Contract execution through June 30, 2019, with the option to renew for five (5), one-year periods subject to the provisions of Sections II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract.

2. Amendment No. 1, Exhibit A, Page A-1, Compensation, Letter A

Original:

PROVIDER shall provide COUNTY with services on certain days as and when requested and specified by COUNTY under this Contract, in the CORONER'S sole discretion, and PROVIDER, based on availability, agrees to accept as full compensation for the performance of the services at a rate of two thousand dollars (\$2,000.00) per each day of the autopsies and/or external exams delegated per stint.

Replace:

PROVIDER shall provide COUNTY with services on certain days as and when requested and specified by COUNTY under this Contract, in the CORONER'S sole discretion, and PROVIDER, based on availability, agrees to accept as full compensation for the performance of the services at a rate of two thousand five hundred dollars (\$2,500.00) per each day of the autopsies and/or external exams delegated per stint.

3. Exhibit A, Page A-1, Compensation, Letter D

Add:

As requested by COUNTY, PROVIDER shall provide court testimony and agrees to accept as full compensation services at a rate of two thousand dollars (\$2,000) per day or \$1,000 for a half day.

This Amendment No. 2 represents an increase of \$1,800,000.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
