WHEREAS, the parties entered into an agreement under CBE Number 605600-20, entitled "Electronic Plan Review Software" dated April 10, 2020 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Remove the two pricing tables from page 7, Basic Project Volume Discount Table and Interactive Project Volume Discount Table.
2. Replace the two pricing tables on page 7 with Credit types and Project Volume Discount Table attached hereto.
3. The revisions contained herein are effective as of March 1, 2022.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.



Credit types and Project Volume Discount Table

1. **Credit Types.** Company offers Credits for both simple projects ("**Simple Credits**") and complex projects ("**Complex Credits**"). Simple Credits are used for projects that require no more than twenty (20) plan sheets that go through no more than (2) review cycles, such as may be used in the building of fences, decks, sheds, accessory structures and the like. Complex Credits are used for projects that require greater document control, sheet-level versioning, collaborative communication with end-customers and/or other advanced functions. Complex projects have more than twenty (20) plan sheets and/or go through more than two (2) review cycles, such as may be used in site planning and land use, commercial, residential, mixed-use projects, fire planning and the like.

2. **Fee Calculation.** The fees charged for Credits in each Subscription Period (the "**Subscription Fee**") are calculated as follows:

- the Price Per Credit for each of the Simple Credits and Complex Credits, respectively, are determined according to Estimated Usage and the corresponding Volume Tier as listed on the Amendment Order Form; and
- the Subscription Fee assessed is equal to the sum of the following: ((Simple Price Per Credit) x (Estimated Usage of Simple Credits) + (Complex Price Per Credit) x (Estimated Usage of Complex Credits))
