KEVIN SCHILLER

Item 1 is to present a proclamation to the members of Nevada Task Force 1 to recognize their recent deployment to Kerr County, Texas. Commissioner Naft.

MICHAEL NAFT

Thank you, Manager Schiller. The Clark County Fire Department, as we all know, does an outstanding job in our community on a daily basis. What we may not all realize is that they're also the sponsoring agency for the Nevada Urban Search and Rescue Task Force 1. Nevada Task Force 1 is one of 28 teams funded and authorized by FEMA (Federal Emergency Management Agency) to respond to major catastrophic

events in and around the United States. The team includes emergency responders from all local fire departments and many area agencies. The ranks include paramedics, structural engineers, logistics technicians, medical doctors, and mechanics.

Last month, as you've seen, Nevada Task Force 1 was called upon to assist in Kerr County, Texas, following the devastating floods that occurred over the July 4 weekend. A team of 47 local responders, who join us here, along with four canines were deployed, along with thousands of tons of vehicles, equipment, and supplies. Their primary mission was to assist with search recovery and debris clearing operations along the Guadalupe River. After nearly three weeks deployed, the team return to Nevada, and we are thrilled to get to celebrate and thank them for their tireless work over those three weeks in Texas. Will you join me in recognizing Nevada Task Force 1? And I'm going to pass the microphone for a moment to Chief Matthew Gordon. Chief, there you are, and he's also joined, I want to shout out, where's Kenneth? Who's here, who runs the task force, also provided me with a tour of their training grounds not too long ago. Thank you for being here with us. Chief?

MATTHEW GORDON

Hi, good morning, everybody. Thank you for the recognition. We just wanted to say, it's our honor to serve the community here in Nevada and to represent our home agencies from all the different fire departments that we participate in, and also some of the civilian organizations that make up this team. And we're honored to go and be called upon to do this mission that we got to do in Texas and to try to bring some healing to the community there. It's a pleasure to work with these professionals from all the different organizations and the teams and it's the people and the caring and the hard work that come together from this group that allow us to be successful. So, just want to say thank you, thank you for your support. Thank you for allowing us to go out to do the work that we believe so strongly in. And thank you for the recognition today.

KENNETH MORGAN

I'd just like to say that these gentlemen up here right now went out and represented Clark County, represented the City of Las Vegas, City of North Las Vegas, City of Henderson, City of Boulder City, The Test Site, and the State of Nevada. When we left, we left with a good impression on the people of Texas. It doesn't always happen when, sometimes when the federal government shows up, but they left with a pat on the back from the people that were there. Sometimes we get there, and we think that we're the ones that are supposed to be taking care of the people and the people take care of us a lot, with food and with a lot of stuff. But these individuals went out and represented and you all can be proud of that because when the people of Texas look at Nevada, they look at these guys and then they think of you as well. So, thanks for the opportunity of being here and thanks for the recognition.

MICHAEL NAFT

Thank you. It's not nearly enough, but on behalf of this Board of County Commissioners, we thank you. We're so proud of each of you for serving our country in the way you have, and we get to proclaim today Nevada Task Force 1 Day in Clark County. Thank you so much.

2. Present a proclamation to recognize Overdose Awareness Day in Clark County.

ACTION: PRESENTED.

KEVIN SCHILLER

Commissioners, your next item is to present a proclamation to recognize Overdose Awareness Day in Clark County. Commissioner Naft and Commissioner Kirkpatrick.

MICHAEL NAFT

Thank you, Manager Schiller. I'm going to ask Mrs. Nadler to come join us up here. Commissioner Kirkpatrick is the true leader when it comes to combating opioids in Clark County. But we're delighted to be joined today to recognize Mrs. Debi Nadler, the founder of Moms Against Drugs. Approximately 48 million Americans, age 12 or older, experienced substance use disorder in the United States, last year alone. While we know that there are some really positive numbers that are coming out, a reduction of nearly 30% since 2019 of overdoses, there is still so much work to do and we're so glad to recognize you, Mrs. Nadler. I'll let you speak a little bit about why you are so invested in this mission, but first I'll pass it over to Commissioner Kirkpatrick.

MARILYN K. KIRKPATRICK

Thank you, Commissioner Naft, and thank you Ms. Nadler. We go back a little ways. This really is an important issue in our community, and it is one that does not discriminate against anyone. So, what I would tell you, everybody should be alert. Everybody should be paying attention because nobody wants to be in that situation, where it's their family member or their loved one. For me, it's personal. Been down this road with my daughter. She is almost two years clean, so that's great, but at the same time, it's an issue that plagues us every single day. So, it doesn't matter who you are, what your social economic is, and I thank Ms. Nadler for really stepping up and doing what so many of us can't do because we're just trying to make things right at home.

The Southern Nevada Health District has a hotline that you can call, so that you can get those fentanyl strips, so that you can get them. We are doing amazing things in the county, testing the water level so we can get a handle on where it is. We work with our partners across the valley, but really this is a day that I ask each and every one of you on August 31, please wear purple or silver because somebody that you know, somebody that is close to you has been impacted by this. And until we as a community are not afraid to stand up and talk about it, we won't fix the issue. So, Ms. Nadler, thank you so much for what you do, and thank you, Commissioner Naft, for including me because it is a journey that we've all been on. So, thank you very much for what you do.

DEBI NADLER

Thank you. I apologize for reading from my iPhone, but if I talked from my heart, we'd be here all day. August 31 is International Overdose Awareness Day, and the color purple represents lives lost to overdose. Every year we light the Welcome to Las Vegas sign purple in remembrance. We weren't able to do that this year. Commissioner Naft has been kind enough to present the proclamation here and carry on that tradition. He's been presenting it to us every year. Excuse me.

Across the country, overdose deaths have gone down, but here in Nevada they've gone up. According to the provisional CDC (Centers for Disease Control and Prevention) data, in 2023, we lost 1,520 people to overdose. And in 2024, that number rose to 1,528. That equals four Nevadans a day. The banner that you see over there. Oh, okay. The banner that he was holding up, which my son is a part of, unfortunately, there's about 64 kids on there and that's not what we've lost. That's just a small representative of the number, it equals to — that banner is 11 days of loss in our state. And when you look at the full year 1,528 lives is the equivalent of filling 20 school buses, if you can imagine that.

So, what can we do? We can start with our children. Primary prevention in every school, consistent age-appropriate education, and awareness. Mandated mental health counselors in all our schools are greatly needed, so students and families know where to turn before crisis. And very important, if we could have a state-funded remembrance and loved ones, August 31 by lighting the Vegas sign purple every year. And let's expand the impact. Let's establish, perhaps, an Addiction Prevention Month every August, beginning with prevention and education, and ending on the 31 with remembrance.

Before I close, I really need to thank my husband. He's Brett's stepfather. He helped me raise my son and he has been with me every step of the way and it's been treacherous, I can assure you. And he has built every banner stand, been to every event, and done so tirelessly and effortlessly. Thank you, Jim, for everything. My son, Brett always said, "Find your purpose." When he was in recovery, the years in between, he would help and counsel others and he always told them, "If you find your purpose, you'll succeed. Find your purpose." I had to take on my son's purpose and try to help as many people as I can. And I thank y'all so very much for remembering all our children, for remembering the day and thank you. Thank you, again.

MICHAEL NAFT

Debi, I know everybody here is inspired by the courage that you've taken such tragedy and turned it into an opportunity to educate and inform and make the world a better place for those of us, in Brett's memory. Thank you for that. And we are presenting this to you, but on behalf of everybody in our community. We, unfortunately, have to declare today International Overdose Awareness Day in Clark County. Thank you. Would you join me in recognizing Mrs. Debi Nadler?

3. Present a proclamation to Lieutenant David Pollex, Code Enforcement Supervisor, in recognition of his retirement and 32 years of service to Clark County.

Commissioners, your next item is approval of the agenda with the inclusion of any emergency items and deletion of any items. Staff is requesting that Items 14, 15, and 16 under consent agenda be deleted. For the record, the District Attorney's office would like to read a correction on Item 33 under your consent agenda, and staff is requesting that Item 57 under the business section be deleted from your agenda.

LISA LOGSDON

The party's request that the following changes to Subsection A of Section 1 of the Amendment as your backup of Item 33. The fourth sentence beginning with, "UNLVSOM (University of Nevada School of Medicine) will indemnify and hold harmless." We shall delete "Past or future" from the Amendment, and at the end of that sentence, add, "For the applicable statute of limitations." And also at the end of section one, add the following language, "In the event that UMC (University Medical Center) believes that it may have an obligation to CMS (Compliance Management System) that could trigger UNLV's obligations under the section and/or in the event that UMC receives any information that puts it on notice of a potential claim, penalty or fine that could trigger UNLV's obligations under the section, UMC will provide prompt written notice to UNLV. UMC will provide full information and documents to UNLVSOM and its legal representatives with respect to any potential obligation UNLV under this section. JIM CHRISLEY

Thank you, Mr. Chair. Jim Chrisley, Senior Director of Aviation, Clark County Department of Aviation (CCDOA). I'm here to provide a brief presentation on the update to Title 20. As you know, we're looking to update our maximum allowable rates for the rates and charges at our GA airports that include North Las Vegas, Henderson, Jean, and Overton. We are adjusting the fee limits. We are not proposing to go right to those maximum rates. I do have some slides here just to show what we're doing. So, the big thing we're doing here, this is our base tenant rates, so we are looking to adjust those maximum rates. We've also adjusted to include two additional sized aircraft. Currently aircraft, anything above 3,500 square feet, is charged the same.

With the transition of GA to bigger jets, we needed to add two additional categories so there are now a category five and six that are included. And then, the other major provision is to update the rates with those same new categories for our transient customers. As we learned during our mega events here in town, our GA airports were very critical to the success of those events and to have those rates and charges in line are very important moving forward.

And then finally, we did conduct an extensive market survey across the country, and what we did discover are our current rates are low, and our proposed rates are in line both on the base customer and the transient customers with other airports of similar purpose and need across the country. With that, that concludes my presentation, Mr. Chair.

TICK SEGERBLOM

This is a public hearing, anyone here wishes to speak. Please come forward.

STEPHANIE PHILLIPS

Stephanie Phillips, Political Affairs Director with Veterans in Politics, P-H-I-L-I-P-S. Good morning, Commissioners. I strongly oppose amending Title 20. This will raise costs for all local airport users, give preferential treatment to one private company, and rapidly erode public trust in how our airports are managed. First, the measure will raise rents and fees for airport businesses, tenants, and operators, sometimes doubling monthly rates for local pilots just to park their airplanes. Many of these pilots are active-duty military, veterans, and retirees. They deserve fair treatment, not higher costs that threaten their ability to fly. Second, the favoritism. While everyone else pays more, one private company, World Fuels Air Elite [Air Elite by World Fuel] gets special treatment. Out of state corporate jets that buy fuel from Air Elite would avoid parking fees. This gives Air Elite a monopoly advantage, while the county may actually lose revenue. Third, the law. FAA (Federal Aviation Administration) grant assurances require airports to provide fair and equal access without unjust discrimination or unfair advantages. This proposal tilts the field toward one vendor which violates those obligations and risks the county's FAA funding.

Finally, the conflict of interest. This proposal was advanced by Ben Czyzewski, the county's managing director of GA airports, who also serves as vice chairman of Air Elite's Board, the very company that benefits most. That conflict of interest cannot be ignored. The Hangar Owners Group believes it is tied to

a larger agenda, removing more than 150 privately-owned hangars, displacing local businesses, and turning that land over to Air Elite. Such a move will certainly trigger massive lawsuits leaving taxpayers with the bill.

Commissioners, you have a choice today. Protect fairness, competition, the military, and the small business community that depend on these airports, or hand a monopoly to one company at the public's expense. I urge you to reject this amendment and stand with the people you represent. Thank you.

TICK SEGERBLOM

Thank you. No clapping.

STEVE SANSON

Good morning, Commissioners. Steve Sanson, President of Veterans in Politics International. I'm here to address what I believe is the most dangerous flaw in this ordinance, a clear conflict of interest, and a complete lack of meaningful engagement with the public. This proposal comes from Ben Czyzewski, the county's managing director of GA airports, who also serves as vice chairman of the board for World Fuels Air Elite [Air Elite by World Fuel], the very company that would gain the most from the amendment. Air Elite already has a fuel monopoly at Henderson, North Las Vegas, Overton, and Jean Airports. This ordinance would strengthen that monopoly by granting Air Elite selective financial benefits while raising costs for every other tenant and business.

At public meetings in Henderson and North Las Vegas, Mr. Czyzewski never disclosed his position with Air Elite. That omission hid from the public, the fact that the person promoting these changes holds a leadership role in the company that stands to profit from them. If he also involved in negotiating contracts with Air Elite, the ethical concerns grow even deeper. NRS (Nevada Revised Statutes) Chapter 281A prohibits public officials from using their positions to secure unwarranted advantages. NRS 281A.400(2) and NRS 281A.400(10) make this type of dual role impermissible. Federal law is also at stake by accepting FAA airport involvement funds. The county is bond by Grant Assurance 22 requiring non-discrimination and Grant Assurance 23, prohibiting exclusive rights, parking fee waivers, limited to Air Elite's customers violated these assurances and put FAA funding at risk.

On the top of this, Nevada's Open Meeting Laws, NRS 241, grants, guarantees the public the right to be heard. Yet this Commission has refused to repeat, repeated requests to meet with airport constituents, hangar tenants, business owners, and pilots. The Hangar Owner Group representing more than 200 members believes that this conflict is part of a larger agenda to eliminate over 150 privately-owned hangars and transfers the land to Air Elite. That would display small businesses, concentrated control, trigger costly litigation. For these reasons I call this proposal to be immediately, immediately tabled until the Nevada Commission on Ethics completes a review, the FAA is consulted on possible violations, and this Commission holds public meetings with those affected. Anything less would betray public trust and expose the county to enormous financial and legal consequences. Remember Badland. Thank you very much.

TICK SEGERBLOM

No, no clapping.

RAYMOND HALLETT

I was waiting to be called, so I guess I just got in line.

TICK SEGERBLOM

Yes.

RAYMOND HALLETT

Okay, thank you. I have some handouts for the Commissioners, and I'd hope that it won't start my clock until they're handed out. Eight copies there in case you need one for your recorder or something.

TICK SEGERBLOM

All right. In the meantime, state your name and spell your last name.

RAYMOND HALLETT

Sure. My name is Raymond Hallett, H-A-L-L-E-T-T. I live at 1513 Via Cassia in Henderson, Nevada. You don't have to study all this. This is just so you'll know I'm not lying to you. But the first page is simply a CPI (Consumer Price Index), cost of living adjustment page from the Department of Labor Statistics showing that in 2011 when the previous ordinance was created, the CPI index was 225 and now it's 323, including and almost doubling because of the climate bill that was passed in 2021 and the inflation that's came along and that's why it's marked there. But the bill before you has an averaged 154% price increase even though the inflation was only 43% during those years, those 14 years. So projected forward, it's way more than is necessary. That would make \$100 fee today on this thing, it's \$250. And the government doesn't lie, right? They say it's 23%.

The second page is a copy of the ordinance where I dissected all of the prices and I include included for your benefit the previous price and the current price and the percentage of increase for each of them. There's one that's 1,400%, it's probably not going to be used a lot. That's the \$15,000 penalty for landing during F1 (Formula One). Which went from \$1,000 to \$15,000 by this ordinance. But there's a lot of social engineering happening here, or there's just somebody using random numbers because in any particular category for pre-existing, the rates go 78%, 82%, and 100% for the three types of aircraft. But in another one they go down from a 100% down to 67%, back up to 150%, and up to 167% as the aircraft size changes. Were they just lazy and they didn't bother finding out what CPI was, or are they social engineering by trying to force the GA airplanes, the transient aircraft out of North Las Vegas like they forced it out of Harry Reid?

This ordinance incidentally would apply to Harry Reid too. So, I guess if I want to fly to Harry Reid, I can now park for \$40 a night, because that's the way the ordinance is written. It has flaws like that. It has flaws all over throughout it. If you buy exactly 300 gallons of fuel, you don't get the benefit. If you buy 299, you get this benefit. If you buy 301, you get that benefit. It's just poorly crafted. I also included a diagram of a sample, small plane operator having to pay a \$20 ramp fee just for stopping at our airport. So, if he has to check his engine or take a pee, it's \$20 and this takes it up to \$40. It doesn't make them feel welcome and we can do it. Yeah, we can do it, but you're not making them feel welcome and our tourism is already down. We need to stop some of the nickel and diming.

But those examples will show you that if I don't buy fuel, I pay \$127. If I buy 19 gallons of gas, I pay more and it's just not, there's no equality. We're already been spoken to. This is about Ben [Czyzewski] being on both the World Elite, or I'm sorry, and I'll stop if you want me to, but it's relevant information for you. And this is the NRS it says all thing have to be equal —

TICK SEGERBLOM

All right, your three minutes are up. Thank you so much. We have your documents.

RAYMOND HALLETT

Three minutes isn't really enough time to describe how to build a pyramid.

TICK SEGERBLOM

All right. No clapping.

TIM ROSS

Hello, my name is Tim Ross, R-O-S-S. The Clark County taxpayers will pay a high price if Title 20 of the public code is passed. The proposed Title 20 enables discriminatory practices and monopolistic control of our public airport. First, the Clark County taxpayers and federal taxpayers and tenants pay for this airport.

Second, the CCDOA is giving a lease to Air Elite, a large fuel company for \$0. \$0. So why would they give a lease to a large fuel company for \$0? Well, Ben Czyzewski, a Clark County employee, is also on the board of that fuel company. Ben and the CCDOA have allowed Air Elite to become a monopoly and are acting on their behalf instead of Clark County taxpayers, or the GA community. They have been making it difficult to transfer ownership of hangers and harassing some of the tenants. Third, the transient parking income from the airport goes to Air Elite, the fuel company. It does not go to CCDOA. It cost taxpayers more by misappropriating in the income earned at the airport. This allows private third party to take control and profit from a public airport, basically misappropriating income from Clark County taxpayers. This undermines the public trust and financial integrity of Clark County Aviation.

Third, this is a clear violation of FAA Grant Assurance number 22, which can cause the airport to lose federal funding, and leaves the county liable for violating our rights. The rights of tenants holders or tenants, allowing jets to park for reduced fees or zero by buying large amounts of fuel is discriminating against the small aircraft operators and is what FAA Grant Assurance number 22 has created to prevent.

In fact, Clark County plans to repurpose or eliminate small aircraft hangers in order to park more large jets in their area. This is a clear violation of FAA Grant Assurance number 22. Our present goal is simply to remain as tenants as we have in the past at a reasonable cost. However, suppose the airport continues to work as a monopoly, working for Air Elite instead of the community. In that case, we're forming a group if needed, unfortunately, to sue the county for damages for more than the Badlands Golf situation was. It could cost Clark County taxpayers up to \$800 million. Please delay or vote against Title 20, save the Clark County and taxpayers millions of dollars. Thank you for your time.

TICK SEGERBLOM

Thank you. No clapping.

JAMES GRAHN

Hi there. Thanks for listening today. My name's James Grahn, G-R-A-H-N, 4315 North Tioga Way, Las Vegas, Nevada 89129. I've been a tenant of that airport, North Las Vegas, for 23 years. I can tell you in my 23 years, the services have degraded rapidly. The bathroom is shut on the north end. There's two condemned buildings. The shade hangars were falling down an aircraft, so they were simply removed, and you can park your airplane out in the sun. And to me the worst part is the taxiways have not been swept in decades. And if you know anything about aircraft, it's horrible for sand and gravel on propeller and on engine intake systems. So, having said that, that this airport is falling into disrepair, at least from the GA side, not from the corporate side. Why would I want to pay more for something that has gone downhill in the 23 years I've been here? Thank you.

TICK SEGERBLOM

Thank you. Please.

IRA SMITH

Good morning, Commissioners. Thank you for letting me have the time to speak. My name is Ira Smith. I'm a disabled American veteran who proudly served in the United States Air Force for years. I poured my passion for aviation into a flight school right here in the North Las Vegas Airport (VGT). It wasn't just a business, it was a way for me to serve the community and train the next generation of pilots. But as of February this year, we were forced to shut down. We lost our office lease, and we could not find suitable replacement on the airport property, which is required for some reason, for that operation to continue. So now my business itself is gone, but my aircrafts still remain there and they sit there sort of collecting dust, while the very fees that I am paying for and being charged for to keep it there continue to increase on me.

This brings me to the proposed ordinance here today, the ordinance 20.10.013. Please, I urge you, either postpone this or do not adopt this ordinance. This ordinance if passed will only make an already difficult situation impossible. It will lead to increased fees and charges that will continue to squeeze out independent small businesses like me. It will make it harder for me as a veteran who was already given so much and given back to the business and continue contributing to the community. I have to be frank, this feels like more than just a coincidence though. There's a serious concern about a conflict of interest that's been brought up already involving World Fuels and the airport manager, Ben Czyzewski. It appears that the goal is to increase jet traffic and jet fuel by sales, by intentionally creating an environment where GA is no longer welcome.

This ordinance feels like the final nail in the coffin, a measure designed to ultimately eliminate GA altogether. And without GA, there will be no future pilots. So, by passing this, you are not just regulating fees, you are creating a future where our airport serves only large corporate interests, leaving no room for the small businesses and passionate individuals like myself who have the heart and soul of aviation. I came here today not just to speak for myself, but for every other small business owner who believes in the spirit of GA, I'm asking you to protect our rights here. Please do the right thing and reject this ordinance or at least postpone it. Thank you.

TICK SEGERBLOM

Thank you. No clapping.

NICHOLAS TORNO

Good morning. My name is Nicholas Torno. I live at 4413 Oasis Plains Avenue, North Las Vegas, Nevada. I've been a proud resident of North Las Vegas since 2017, and I'm here to talk about tenant rates today and operational policies at CCDOA managed airports, specifically VGT because that's where I'm based. I'm a blue-collar dad with a daughter that likes to fly. I don't have any businesses. I'm not tied to any organizations. I'm not very political, but this is something that I'm pretty connected to. Last year I bought a derelict Cessna and restored it so that I could pursue my dream of flying. This April it happened, and it seems like right now I'm being priced out.

So, I'm concerned with the proposed increase in tenant rates at VGT, especially without corresponding improvement in services. These rate increases along with certain operational policies negatively impact the GA community specifically. This impact is not only felt by tenants, but also by the local community who derive benefits from our local policies, pilots, and airports. VGT tenants provide significant opportunities offering flights to friends, families, neighbors, and most importantly youth. We offer mentorship to aspiring mechanics and continuing education to acuity airmen that learn the fundamentals of smaller aircraft engines, all of which takes place at no cost to the local community. There is no better ambassador for aviation. There is no better ambassador for North Las Vegas GA community or CCDOA

than happy tenants that feel supported by local airport management and government. And right now as a new tenant, I'm not feeling it. I just got my license. So, I'm a crash investigator at Nellis. I've worked fighters for 18 years. I've worked GA, general aviation, for another eight years and it just keeps getting harder and harder just to exist. So, that's why I'm here today.

These rate hikes and requirements for GA operating permits make it hard to bring new business to VGT. I've had two operating permit requests denied because I couldn't have a facility for a mobile maintenance business, which I didn't need — Excuse me, which I didn't need a facility. So, it makes it difficult to bring outside services onto the field for aircraft owners, each increase prices out a tenant, each added restriction takes away an opportunity to train a young mechanic or the chance to spark a child's interest in aviation, my daughter included. I know with my budget specifically, I feel every dollar come and I also feel every dollar go. It's severely impactful.

I respectfully request that CCDOA reconsider the Title 20. I'd like to see a reevaluation of the current tenant rate structure, maybe exploring alternative funding models for our airport. And I'd like a review of specific operational policies that are considered unduly burdensome to people looking to do business on the field, such as the blanket requirement to lease adequate facilities for customers and staff from which to operate regardless of their business model. It's personally impacted me.

I would love to show the Council Members the other side of the coin. Seeing it in action from the end user's perspective is more informative than any report. If you guys have time, I'm just a guy, but if you'd like to come out and walk the field, go fly, go check things out, meet my daughter, I'd love to spend time with anybody that would be willing to listen. Thank you.

KIRSTEN JOHNSON

Good morning. My name is Kirsten Johnson. My address is 19 Morning Glow Lane, Las Vegas. My family has long been term tenants and hangar owners at VGT. I'm here to oppose the proposed amendment to Title 20. This amendment is not about improving the airport, it is about advancing a private agenda. The manager promoting it also sits on the board of the fuel vendor that stands to profit the most. That is a clear conflict of interest. When the same person who sets the fees and the charges also serves on a company that benefits, excuse me, financially, this process is compromised. Decisions that should protect the community instead favor one private business that erodes trust in the county government and damages the integrity of our airports.

Our airports are built — are public assets built with maintained taxpayer dollars. They must serve everyone fairly. Yet this proposal ties tenant fees to fuel purchases in a way that funnels money to one vendor, while forcing hangar owners like myself and my family to pay more unless we buy fuel on their terms. That's not fairness and that's not transparency. Even if the policy had merit, and it doesn't, the conflict of interest alone is enough reason to reject it. For decades, my family has invested in this airport. We want to see it thrive, but it cannot thrive if leadership places private interests ahead of public trust. I urge you to reject this amendment and make clear that Clark County's airports will be managed for the public good, not for private enrichment. Please vote no on today's amendment. Thank you.

TICK SEGERBLOM

All right. Seeing no one else. We'll close the public hearing.

WILLIAM MCCURDY II

Mr. Chair, I have comments. Will like to get clarification on the representations that have been made regarding the conflict of interest. I think that's pretty significant if true. And I also would like to have some justification around the pricing that has been represented, particular to the percentage increases. Thank you.

ROSEMARY VASSILIADIS

Of course. Thank you. Rosemary Vassiliadis, Director of Aviation, there has been a myriad of comments on various subjects involving GA operations just in general, appears there's some misunderstandings and assumptions made on some future activity that could take place. But what I want to state for the record is the process that what is before you went through, and that is the tenants of the GA airports were notified in May. There were in-person follow-up meetings held with them on May 5 and May 7. The CCDOA followed the Business Impact Statement process, sending out over 400 notifications to stakeholders and all the Chambers of Commerce in the valley. The notices were published in the [Las Vegas] Review-Journal on May 23, 22, and 29. As reported to you at the last meeting, we received three comments from that, all on the same subject matter as how, basically, are we going to go right to the highest, not to exceed amount? We explained we weren't and that was the end of it.

And in addition, let me just state for the record, we hold quarterly meetings with our tenants. All these comments are new to myself and my staff. So, we will be happy to meet with them independent of what this item is about. And then I can ask Jim [James Chrisley] and Joe [Joseph Piurkowski] to talk about, excuse me, I'm sorry. Mr. Vice Chair, talk about the pricing structure that's before you today.

WILLIAM MCCURDY II

I think it would be appropriate of, you know, based upon the representations that have been made about the conflict of interest. I think that sticks out pretty much. I think that's —

JOSEPH PIURKOWSKI

Sure.

WILLIAM MCCURDY II

We need to address that.

JOSEPH PIURKOWSKI

So, for the record, I'm Joe Piurkowski, the Airport Chief Financial Officer. I'd like to clarify a few things. So, there's no tax money involved in this at all. It's all user fees. So, first I'd like to clear that off for the record. And we haven't done an increase, it's approaching 15 years since we've done an increase on these rates. Since I've been CFO (Chief Financial Office), we have subsidized this, the GA airports, several million dollars every year with the exception of the fiscal year where we had the Super Bowl, where we had some additional fees for the private jets that flew in for the Super Bowl and for the first year of F1. So, this is getting us in place to be self-sustaining and earn enough revenue to operate the facility.

Also, the first-year fees were increasing approximately 10%. So, that CPI index that was provided obviously from 2011 is a lot higher than 10%, probably more in order of 50%. So, we're just trying to play a little bit of catch-up here. The total amount here, so you can see for a small tenant for an uncovered apron goes from \$45 to \$49.50. For a larger uncovered apron, it goes from \$250 to \$275. And then from a shade hanger, the smaller shade hanger, it's \$100 to \$110. So, it's a 10% increase for all of the base tenants there. And then as far as the World Fuel Project, we do bid that. So, we had recently bid that. So, it is competitively bid, the fuel supply to the GA airports.

JIM CHRISLEY

Jim Chrisley, again for the record, and the Air Elite Program is merely a customer service program that we participate in. It's not directly linked to the World Fuels bid contract that Joe [Joseph Piurkowski] just mentioned.

MICHAEL NAFT

And that's always been my understanding of Air Elite at least I'm more familiar with the operations at Henderson. But I guess what are we missing? What's the disconnect there? Because I've understood Air Elite to be a customer service, raise the hospitality level of the GA facilities.

JIM CHRISLEY

It's a program offered, you know linked to World Fuels but not, there's no linkage between the sale of fuel and the customer service program. So basically, the customer service program, we had to meet certain standards within our terminal, within our training of our employees to be deemed Air Elite qualified. So that is all Air Elite is a customer service program that we're participating in and there is a separate agreement for that versus the fuel contract that was mentioned. There's no ties between the two.

WILLIAM MCCURDY II

So, we're clearly stating that there is no, to your knowledge, conflict of interest. Is that correct?

JIM CHRISLEY

That is correct, to my knowledge, yes.

MARILYN K. KIRKPATRICK

May I ask a question, Mr. Chair? So let me ask this. So, we do fuel bids across the government all the time, right? Whether they're different departments or different agencies. That's something that we always do. So, when you say they're competitive bid, they go out and then I feel like we've done this and very seldom we don't change, but sometimes we do change, right? To whoever it is. So you're saying that you went out to a competitive bid that gives a lot of people the opportunity to give a proposal. There's no inside information because we have sealed bid process, all of those things, right?

JOSEPH PIURKOWSKI

That's correct.

MARILYN K. KIRKPATRICK

Okay. So, I'm trying to reread the ordinance to see where the connection is. And I know the airport, Sunshine Café is my little hidden gem eating spot on Sundays. So, I know that pretty well. So, where's the connection of get better pricing if you buy their fuel? I'm trying to find that in the ordinance, because I'm not understanding that, and I want to make sure that we're addressing some of those concerns —

JIM CHRISLEY

So, basically, that's linked, as a transient customer comes in, if they stay a certain amount of time, they're charged a certain rate. If they purchase fuel, this is how it is currently as well in Title 20. If they purchase fuel, that rate to park is discounted based on the amount of fuel that they buy.

JIM GIBSON

Excuse me, Jim [James Chrisley], speak right into that microphone.

JIM CHRISLEY

Oh, sorry.

JIM GIBSON

You kind of tail off when you're at the end of your sentence —

JIM CHRISLEY

Excuse me.

JIM GIBSON

The end of the sentence is kind of significant here.

JIM CHRISLEY

Sorry. So, what the current ordinance states with a transient customer, non-based tenant comes, and they stay a certain amount of time, there's a certain rate they're charged. If they purchase certain amounts of fuel, those rates to park are reduced accordingly based on the amount of fuel they purchase.

MARILYN K. KIRKPATRICK

And that's the way that it's been for a very long time though, right?

JIM CHRISLEY

It's been that way for a very long time currently. And it's now this ordinance update is merely updating those prices associated with those stays.

MARILYN K. KIRKPATRICK

And so let me ask this question then. How is that discount applied? Because I believe if the way it used to be is that there's documentation on what that expectation is, and so it's not just the stroke of a pen, right?

JIM CHRISLEY

It is. It's published totally clear, and published on our website, as well as when they interact with our customer service folks. If they purchase fuel, their rate is discounted on their parking fees.

MARILYN K. KIRKPATRICK

But it's a consistent rate right?

JIM CHRISLEY

It's very consistent. It's outlined very clearly —

MARILYN K. KIRKPATRICK

So, it says if you're here for three hours versus 24 hours —

JIM CHRISLEY

Or if you purchase greater than 50, less than 75 gallons, you get a certain discount. If you go above 300 gallons, it changes as well. So, it's based on the amount of fuel purchased.

MARILYN K. KIRKPATRICK

And our fuel contract is good for typically; don't we do three to five years or something? How long is that for? Sorry.

JOSEPH PIURKOWSKI

I don't have that information right now, but yes, it's generally speaking —

MARILYN K. KIRKPATRICK

Well, I mean it's not — we don't do it every year we are hedging our bets, right? Okay, okay.

WILLIAM MCCURDY II

Is there any other clarification needs to be made to us by our legal counsel?

LISA LOGSDON

No, I mean I think Commissioner Kirkpatrick is correct. The connection between the fuel purchase, and it's always been an ordinance, and like the department said, these fees haven't been updated for 15 years. But this is really, before you, an update of those fees related to that.

WILLIAM MCCURDY II

All right. Commissioner Becker.

APRIL BECKER

Well, based on some of the things that have been brought up today in this meeting, I am not comfortable going forward. I believe that there should be a little bit — additional time to address the concerns of the people that have come here. So, for me, if it's easily explainable, and you would like to meet with the people that are here, I think that we should be able to give it a little bit more time. Yeah.

TICK SERGERBLOM

(Inaudible).

APRIL BECKER

Yes. I would like to hold this item for the future. I don't know if we need to put a date on it? But.

MICHAEL NAFT

I would just say yeah, if we are going to hold it, there should be a date, and it should be relatively soon because it —

APRIL BECKER

I agree.

MICHAEL NAFT

I'm all for explaining it thoroughly, but, you know, we're going on 15 years here, so.

APRIL BECKER

Yeah, it was my understanding that today was just to raise rates that had not been addressed in 15 years. And for me, that's perfectly understandable, but if there's an issue of conflicts of interest and there are parties that are involved that work for the airport and are also benefiting from a contract that would be entered into. I am very uncomfortable with that.

WILLIAM MCCURDY II

Two weeks.

APRIL BECKER

Two weeks, I believe is enough time.

TICK SEGERBLOM

So, that would be September?

LISA LOGSDON

So, your motion would be to hold this item until the September 2 meeting?

MOTION

TICK SEGERBLOM

All right, so there's a motion to hold the item until September 2. Cast your vote.

VOTE

JIM CHRISLEY

Thank you, Mr. Chair. I look forward to working with you all at such meetings in the future, so thank you.

TICK SEGERBLOM

Good morning.

JOHN ADVENT

Good morning. Good morning, Commissioners. John Advent, Deputy Director with RPM. Today, presenting quickly on this updated policy for our new JOC (Job Order Contracting) program, just a quick background. The county successfully completed a three-year pilot program for this delivery method under Senate Bill 67. It was recently passed into permanency under AB43, and as a requirement of that bill, we need to establish a new policy.

So, the new policy in front of you today is very similar to that, that was previously approved three years ago, with the updated verbiage that addresses the new Assembly Bill 43 language. We have added the requirement for apprenticeship participation and reporting, and then we're proposing an updated contract term with our future job order contractors coming in. The previous pilot was three years, so it limited it to a three-year contract. We would like to go with three years with two one-year terms under this policy. And that's basically it in a nutshell, but I can answer any questions you may have.

Thank you, Mr. Chairman. I do have two. So one, I just want to remind everybody that it's our turn to host Nevada NACO (Nevada Association of Counties), so they'll be here September 23 through 25. We have all 17 counties that are participating, so be hosting it at the South Point [Hotel, Casino, and Spa] this year. Commissioner Gibson and I are going to be there, but there's a lot of good informative stuff. One of the speakers, we hope to have someone from the BLM (Bureau of Land Management) to talk about Nevada as a whole, what does that look like? We also have someone that's going to come and talk about the opiate treatment settlement dollars. So, we hope that there'll be informational stuff for everybody, so I just wanted to put that on your radar.

Secondly, you know this Board took some of our dollars from ARPA (American Rescue Plan Act) and invested into the EMT (Emergency Medical Technician) program. There was a lot of questions, when we first did the EMT program, about who was doing it. So, I'm happy to say that our second cohort has completed, and this is an idea of the diversity that we have across the board. Men, women, young, older. And so, everybody's been there. It's been a really great class; I've been trying to stop by because they're housed in North Las Vegas during one of their meetings. And they say it's hard. We had a valedictorian this time. In the first cohort, we've already had people that have passed the state test on the first try, which is a huge thing. So, but this Board should be proud of the work that the Economic Development and Chief Travis are doing to get us plenty of EMT-ready folks within our community.

So many of them are already signing up for EMT 2, but we don't always get to see the fruits of our labor and this was a program that is doing well. So, and if people want more information, they can reach out to Clark County Economic Development to talk about when the next sign-ups are. I think we have one or two more cohorts, but we've been managing to 25 start, 25 finish. And that's a big win, so thank you.

TICK SEGERBLOM

Chairman, I just wanted to take a second and highlight a couple things in this agenda item because it's really significant. It's a big commitment to a lot of the things that each of us care about. I thank Jessica and her team for getting all of this together. We've got \$9 million in here for traffic safety-related items. I would just ask on those items if we could have some follow up on the line items of where those expenditures go. I'm a big fan of most of these line items, I just want to be able to follow it through and see exactly where they're going to.

But in addition to the traffic safety items, you also have a real commitment to animal welfare here. Clark County's moving forward with a supplemental animal shelter design and construction. This will not deter us from shelter diversion, continuing to fund programs that, hopefully, prevent our animals from getting into shelters to begin with, but it's a commitment that has to be made. As we just saw in the previous presentation, our population continues to grow. Current shelter services are continuously at capacity, and we have to continue to kind of recommit to expanding and meeting the need of the community.

You also have the commitment to life-saving services and, more urgently, meeting the need of emergency shelter services through the construction project at the Silver Bowl. So, I'm appreciative of everybody for getting these expenditures together. There are things that are not luxury items, but things that we need in this community and are meeting the demand. If there isn't any further discussion, I would move for approval of Item 52.

Commissioners, your next item is to receive a report regarding the conditions of confinement at County jail facilities to include the deaths of any inmates in custody; or take other action as appropriate.

TICK SEGERBLOM

Good morning.

NITA SCHMIDT

Good morning. My name is Nita Schmidt. I am Deputy Chief of Detention Services for LVMPD, and it is my honor to be the deputy chief over the three Clark County Detention Center facilities (CCDC), the large one that's downtown, the one in North Valley Complex, and then our temporary holding facility in Laughlin.

This presentation covers the NRS requirement under 211.030, that is a biannual report to the County Commission regarding the conditions of confinement and review of deaths in custody. So, who are we? Detention Services Division. Our vision is to be the safest jail in America. It's not something we take lightly. It's our top goal, and we work every day to try to achieve that. Our mission is to set the standard for American jails. We are one of the largest jails in the United States, and we are accredited by the American Correctional Association as well as having an additional correction for the National Commission on correctional healthcare. Our mission is to set the standards and our values for our agency are integrity, courage, accountability, respect, and excellence.

The current capacity of our facilities is a little bit different right now because we're under renovation. We'll talk about that a little bit later. Our CCDC has a current capacity of a little over 3,000; North Valley Complex, a little over 1,000; and our Tucker Holding facility, which is a temporary facility, has a capacity of 40; and our Electronic Monitoring Program has a capacity of 950. Right now, our average count for electronic monitoring is around 500 per day, so we're about half of that in capacity. And then due to renovation, our capacity is adjusted for the number of available cells that we have. We have a major renovation going on in our South Tower, which was built in 2002, and I'll show you some photos of that later on in the presentation.

So, some trends for our population. We had our total bookings for the first half of this year were almost 25,000. Our average length of stay, so that's the average length of stay of somebody who comes into our facility, is about 19.5 days, and our average daily population hovers around 2,800. If we follow this current path of the trends we're going to see for the first time in a long, long time, our detention facilities with a population of less than 50,000 bookings a year. And that's significant. In 2019, our bookings per year were just under 75,000. So comparatively, that's a reduction of about 25%, and that's through a lot of things that have gone on in the justice system. As well as some collaborative work that have been done by many partners who have invested their time and initiatives that were geared to reducing jail population and making our criminal justice system more efficient.

For this reporting period, the total deaths from January 2 until the end of June were nine. The demographics for those deaths are listed below six males, three females. Eight of them were at the hospital, one was in the Clark County Detention Center. And at the time that I submitted this, we were pending five medical reports from the medical examiner. We've received a couple more since then. Speaking nationally about deaths, the number one leading cause of deaths in jails are suicides, then it's followed by a heart disease or heart-related issues, cardiac-related issues, and then drugs. I'm happy to say that suicides are not the leading cause of death in our jails. We've done a lot throughout the years to look at things to reduce suicides in detention centers across the nation, but also very much so in our facility, and we are far lower than the national average.

One of the other things talking about, and it's timely that you had a proclamation today talking about overdose deaths and having the overdose awareness, as you know, we have a robust MAT Program in our facility, Medication-Assisted Treatment, to assist people with drug use and to be able to give them some stability when they leave our facility so they could reenter society. Jails have become that intersection between public health and public safety, and we inevitably become the safety net for a lot of people for getting into care and having continued care.

This is a reflection of the deaths that we've had during this reporting period, three of the nine deaths that we had were bookings and absentia. So those are people that never entered our detention facilities. There was some interaction out on the street that caused them to be arrested, but they were never actually booked into our facility. They physically were not booked into our facilities. And one of the deaths was the person was released from custody prior to them passing. Also, a little bit about this, none of the deaths that we had in this reporting period were as a result of suicides that occurred within our facility. None of them were as a result of use of force either.

So, this right here is a photo of our SMART housing unit. It is our Specialized Mental Health and Recovery Treatment Unit. This is a housing unit that doesn't look like anything else in our facility. This is a housing unit, and I know you guys have heard quite a bit about this. This is the first of its kind in its state. It is a 60-bed mental health facility that is within our jail. It has a single purpose, and that is to help people that have been deemed incompetent to proceed in their cases, to help prepare them to either transition to a mental health facility, but to also have that length of time be reduced in the mental health facility. And we just celebrated a year anniversary with them. They've had 25 patients that they have been treating, our vendor has been treating in this housing unit that have been removed from the state's waiting list. That's big, because the state has a waiting list for one of the two locations that we send people for mental health competency restoration. It allows those folks to be able to have their cases proceed to help them move through the system a little bit faster. It also allows us to bring, when people come back from state mental health facilities, to be able to have them engage so that they stay competent, so that those cases can proceed. The providers in this housing unit provide a number of different resources including assisting them with those reentry initiatives so that they can be able to get out of our facility and hopefully not come back.

Our South Tower is under renovation. It was built in 2002, so it's under a major renovation. We have just completed — we're working on the second, finished the second of fifth of five floors that need major, major renovation. It looks great. The major renovation includes plumbing, upgrading of electronic systems, ADA (Americans with Disabilities Act) accessibility, you name it. It's getting a full run down from the bottom up. It's a slow process to do, and it's a challenge for us to do renovation in a facility that's still being occupied, so it's causing us to have to shift our population all over the place.

And then last, I wanted to show you guys some photos of the UMC hospital ward, and I know that this has been something that's been a long time coming for us. This is from probably about a month ago, when I was able to go out and take a tour of it. This is going to be a huge benefit for us to go back to having a full hospital ward that's at UMC. It will allow us to take people who are in custody and receiving medical care at UMC, place them in one centralized location. This space has the ability to have ten inmates in eight different rooms. It's a secure location, so it'll allow us to be in a more secure location. It will allow there to be dedicated healthcare professionals that'll be assigned to this space for faster response. This will allow us to continue to reduce our costs for staffing, to be able to reduce those overtime costs and stay more within budget. It's estimated that they should be completed with a major construction in October. I'm hoping that after they place the furniture and the technology and everything else that gets in there, we should be hopefully occupying it by the end of the year. That concludes my presentation.

TICK SEGERBLOM

All right. Anyone wish to say anything? No. Thank you so much. I look forward to touring the facility at the UMC. That looks fantastic.

Commissioners, we can now move back to the business section of your agenda. Item 55 is to receive a presentation from the Community Housing Office on the Welcome Home programs, including the County's Welcome Home Community Land Trust (CLT).

DAGNY STAPLETON

Good morning again, Commissioners. Dagny Stapleton, Community Housing Administrator. I have a very brief update on the Welcome Home Programs for you this morning, including the CLT, on the CLT and our Homeownership Program. As we recently updated you, to date, since this Commission created the Community Housing Fund (CHF) and the Welcome Home Programs in 2022, we've supported the creation or rehab of approximately 5,000 affordable rental units across Southern Nevada, which equates to an increase or preservation of approximately 28% of our deed restricted housing supply. With the approval earlier of Item 37, we can add 453 units to that number. Also, want to note that we are funding more units at 30% AMI (Area Median Income) for our most vulnerable. We're also funding some Permanent Supportive Housing (PSH), have created a handful of development incentives in partnership with Comprehensive Planning, and we actually have six parcels in play in various stages of development process for housing. For projects that otherwise would not have happened through the Welcome Home Program.

Just a couple pictures of projects that we have supported. This is our PSH Project, Tropicana Trails. Before I talk about our Homeownership Project, the CLT, I want to ask our communications team, they've got a video they've prepared for us that they're going to play.

(Video Presentation Begins)

VIDEO NARRATOR

Clark County and Kavison Homes are working together to make the age-old American dream of homeownership possible. CLT uses a modern model, where working families can buy a home at a price they can afford, not just today, but for generations to come.

TODD STRATTON

You're either part of the problem or part of the solution. The county chose to be part of the solution.

VIDEO NARRATOR

In a CLT, the homeowner owns the home, while the land is owned by the county. This helps set an attainable price, builds equity for families, and ensures that future buyers will also have a chance to purchase an attainable home. It's a model to support families and strengthen communities.

One of the two projects to be completed first under this program is Cactus Trails, a vibrant 20-acre neighborhood that will open the door for 210 families to own beautiful single-family homes and put down roots for their future.

TODD STRATTON

To me, it's a legacy project, and I grew up here. I raised my kids here, I went to school here, and it's a way for us to give back to the community that's really, really desperately needed. 210 homes total, square footage is 12 to about 1,680 square feet, and they're beautiful homes. They're going to look just like you would see all around you. They're the same type of home, same architectural standards, same colors, same color palette, same everything, just a little bit smaller.

VIDEO NARRATOR

Using the CLT Plan, Cactus Trails will open the door to homeownership, to people such as teachers, truck drivers, and other working families who might not qualify for a mortgage in a conventional neighborhood. Every CLT homeowner will have to meet various eligibility requirements, such as participating in homebuyer education. These HUD-certified classes will help prepare families for the responsibilities of owning a home, and ensure this program is the right match for them, setting them up for long-term success.

JENNY COX

For Cactus Trails, there is going to be requirements for homebuyer education. This is going to be HUD-certified classes that these potential home buyers are going to have to go through to make sure this program is going to fit them, so they're going to be on this property for the long term. Not only that, but when they're going to qualify, these are not buyers that don't have their own funds, right? They're going to have to have at least 3% of their own funds down. The credit score is going to need to be higher than your traditional credit score for just qualifying for a loan itself. So, we're talking about home buyers that are going to have their own money and need higher credit scores.

VIDEO NARRATOR

Many people wonder whether homes at Cactus Trails might become rentals or sold to investors. It's important to know these homes are owner-occupied, not rentals, meaning the people who live there own their homes, and are committed to the community.

TODD STRATTON

The people that are going to be living here have to go through probably a little bit more stringent process to get the mortgage than what the people that are living here now. It's not low income, it's not Section 8, and that's middle. That's what we call, I've heard it called "Workforce Housing, The Missing Middle," but there's a big, big hole in Las Vegas and nationwide in this price point, and that's what we're trying to do is trying to fill the need.

VIDEO NARRATOR

Cactus Trails will offer top-tier homes, designed with quality and care. When people own their homes, it creates a real sense of pride and belonging. These homes aren't just a place to live. They're long-term investments that help build lasting value in the area. It's about creating a neighborhood where families can grow, thrive, and feel truly connected to their community.

MARK WILEY

This is a path to be or a time to be smart about how you invest in real estate. CLT communities really give you that opportunity if you qualify to leverage a unique position where you're not necessarily paying full price for the same type of assets and community amenities that you would get right down the street. I certainly think it's an exciting project, because it's so new and being rolled out in so few communities around the country. I do see the advantage for our valley as a high-growth community to bring in affordable housing options for that workforce community.

VIDEO NARRATOR

Some neighbors might worry that affordability comes with a cost, like declining property values. This is a misconception that real estate experts also agree on.

KENDALL BRITTON

I believe Cactus Trails will not affect the values of the surrounding neighborhood.

VIDEO NARRATOR

County leaders and real estate appraisers want neighbors to know that CLT homes are appraised differently, and will not impact or be directly compared to the value of houses in nearby communities.

KENDALL BRITTON

Well, from an appraisal standpoint, it wouldn't be used in appraisals for houses outside of the project.

VIDEO NARRATOR

In addition to generating homeownership opportunity through the CLT, Clark County's Historic Welcome Home Program and CHF are changing lives, helping low-income families, seniors, and working parents secure affordable rental housing. Since 2022, the Board of County Commissioners has allocated nearly \$250 million to tackle this critical need. Partnering with builders, lenders, and community groups, Clark County is creating safe, affordable neighborhoods people are proud to call home.

(Video Presentation Completed)

DAGNY STAPLETON

Thanks so much to the communications team and the stakeholders who worked to create that video. Just a few more things about the CLT, these home buyers, these homes will be for folks at 80% and 100% and below AMI. These homes are guaranteed to be resold to families at the same AMI levels, so it creates the opportunity of homeownership for decades to come. The home buyers must meet strict qualifications to receive one of the homes, including being able to qualify for a mortgage and being county residents.

Home buyers will be selected through a lottery process, and we have two developments in the pipeline: Cactus Trails in unincorporated Clark County, and Rebecca Place in the city of Las Vegas. Here's some additional information on each of these projects, including that we expect applications to open quarter four in this year and quarter one 2026 respectively.

There are over 300 community land trusts throughout the United States, some with far more homes than this, but we are the first to start a CLT at this scale with two subdivisions. So, really, this is a historic project and a historic investment that the county is making to provide accessible home ownership to folks in our community. With that, I'd be happy to answer any questions, or provide any other details that you might like.

TICK SEGERBLOM

Commissioner Jones.

JUSTIN JONES

Just want to say thank you to Dagny, Margo, and the entire CLT team for all the tremendous amount of work they put into this and to the communications team for putting together that video. I know it's going to be really valuable as we go into the zoning process and really educate folks on what these projects are about, and why we as a Board are so committed to providing a better access to housing.

TICK SEGERBLOM

Do we need a motion? Nope, just a presentation.

WILLIAM MCCURDY II

I also quickly wanted to say that I'm very excited about these two projects. There's a lot happening in our community. There's a lot that we do bi-weekly on this Board, but I don't think there's anything that we do that's more important than providing housing for families in our community. I personally want to thank Commissioner Jones for his leadership with Cactus Trails, because that's going to change so many families, and change the trajectory of where they can go and who they can be within this lifetime. Thank you, Commissioner Jones, and thank you for all of your leadership.

TICK SEGERBLOM

I think, doesn't Commissioner Kirkpatrick have one too?

MARILYN K. KIRKPATRICK

(inaudible).

And Commissioner Kirkpatrick.

KEVIN SCHILLER

Commissioners, Item 56 is to receive a presentation from the University of Nevada Las Vegas (UNLV) and provide updates on various programs and recent activities.

TICK SEGERBLOM

And I recognize a former commissioner.

SUSAN BRAGER

Thank you.

CHRIS HEAVEY

Delighted to be here with you today to talk briefly about UNLV with two of my bosses, and servants well-known to this community, Regent Stephanie Goodman and Regent Susan Brager, who has served on all the essential Boards of Southern Nevada. Who'd like to make a few comments to start off?

SUSAN BRAGER

Thank you so much. It's really nice to be here today on the opposite side of the podium. Nice to see you. I just want to say that we really appreciate the opportunity not only to be here today but know that UNLV has had some amazing changes. And what we want from this day forward, to know that we can have a great relationship and work with each and every one of you. We are the university down here that cares and wants to see more students not only attend that university, but throughout our state to know that we are viable and ready to continue staying at work. Our Interim President Heavey is feet on the ground. I mean, he is really making great strides and great differences, so we look forward to that relationship continuing. Thank you.

STEPHANIE GOODMAN

Thank you, President Heavey. We're happy to be here. And I just simply wanted to say, I'm the chair of the Health Sciences Committee, and the work that's been done here is vital. UMC and UNLV is a vital partnership, and there's been a lot of work that's been done here. And the Board of Regents is committed to making sure that this is a relationship that thrives. And moving forward, we'll be continuing to work closely with UMC and just wanted to let you know you have our commitment to that relationship.

TICK SEGERBLOM

That was Stephanie Goodman, for the record. Thank you.

CHRIS HEAVEY

Thank you both to our regents. I appreciate their support in trying to serve this community. I have a few slides that I'll run through just very quickly, and then happy to answer any questions you may have. Delighted to be serving the institution, where I've been on my whole career. I've been at UNLV for 33 years. And so, now have the opportunity to lead this incredible institution, and I think you all know that UNLV is the comprehensive research university of Southern Nevada, and it's a major research university in every way. We're now both classified as R1 and a community-engaged university, over 150,000 alumni. And really proud of our vision, transforming our communities through education and engagement. And that's my commitment to you is that every day, we will work to make this community a better place through our service.

I think we all know this story, but it's one, I think, we have to remind ourselves of the incredible growth of Clark County, this dynamic city that we're a part of. And this is a slide that represents the 17 counties in Nevada, population from 1890 to today. And it's easy to identify, basically, two lines on this, Washoe County, which has grown well, and Clark County, which has been a rocket ship since about 1950, when UNLV was founded in 1957. And so, you're familiar with these numbers, and trying to catch up to serve the incredible growth in this community is our shared task. And we know that with that growth, we've often struggled to have enough professionals and college-educated individuals to deliver the full range of

services that are needed by our residents. And these are just some of the figures that I think you're very familiar with.

I think everyone's aware that Clark County doesn't have as many college-educated residents as many comparable counties. So, for example, 25% of the people in Clark County have a bachelor's degree. In the Phoenix metropolitan area, that number is 37%. In the Salt Lake City metropolitan area, that number is 40%. And if you look at graduate degrees, we're at 8.6% of our population. The Phoenix Metro area is 14% of its population, and Salt Lake City is 16% of its population. And those kinds of educational credentials often lead to economic development opportunities for communities. And so, we're happy to be a part of this story, and growing with our community. And so, we started, as you know, humbly, in 1957 as Nevada Southern University, a branch campus out in the middle of the desert. And now, we're in the heart of the urban area of Commissioner Segerblom's district of Clark County. And now 33,000 students, grown dramatically since even 1980.

Since 1980, the population of Clark County has grown by about five times. The population of UNLV has grown by about three times. And so, even with our explosive growth, haven't fully kept up with the population of Clark County. Nonetheless, we're the largest institution of higher education in Nevada by a large margin. And with our key partners, College of Southern Nevada, who we work very closely with and our very complimentary educational missions, we are serving the dynamic growth of Clark County. And we're serving people from every zip code in Clark County. We're eager to be in every zip code. And if there's any opportunities for us to engage in zip codes that have fewer residents coming to UNLV, we would be eager to be partners in that effort. We are an access-oriented institution that serves 85% of the people coming from Clark County. More than 40% are Pell recipients, and many of our students are attending, especially their first year of college free, with all of the financial aid that we're awarding.

And so, we're delivering impact at a very large scale, producing far more college degrees in the state of Nevada than anyone else, with 7,000 graduates each year, and most of those people staying in Clark County. We're also trying to really focus on hitting specific community needs. As Regent Goodman talked about, our school of medicine is a key addition to trying to serve our community. Nursing is an incredible shortage and working closely with Nevada State University to try to fill the nursing shortage. We also do a lot to serve mental health needs in this community. I actually came here to start the Clinical Psychology PhD Program at UNLV, and we are the largest city in the country that didn't have a standalone clinical psychology program when I arrived. We started that program in 1999, and now we have leaders across the state in serving the mental health needs of our community.

We're also looking at what are specific kind of talent pipelines that we need. We all know that we've really struggled to have enough qualified teachers in classrooms, and so we're really growing our elementary education programs, our IT (information technology) programs, our nursing programs, computer science, all of the kinds of degrees that a thriving community like this will need.

We also really believe in direct engagement with the community. We're working with the Innovation Corridor in Commissioner Naft's district, especially with our Harry Reid Research and Technology Park. We're doing our fine arts in the center activities in order to enrich the cultural heart of Clark County. We do a lot of youth programming. This summer, we had 40 summer programs on our campus, serving 1,600 residents. And we're also trying to work with Cooperative Extension to realize the vision that Governor and now President Sandoval put forward of "Stronger Together" about how we can work to continue to amplify the mission of Cooperative Extension.

We're also looking at what the future is, making sure we're growing our online degrees. We have new efforts in immersive learning. AI (Artificial Intelligence) is going to be a big part of the future of all of us.

And making sure that we are teaching our students to be AI-ready as they graduate. And doing research on areas that are critical to the future of Clark County, especially water resources and sustainability. And as we know, cyber security is a huge issue.

And that's just a quick overview of what we're doing at UNLV to serve this community. And again, my commitment to you is that every day, as the president of UNLV, my north star will be, "What can we do to make this community better and to provide both education and services that our residents need?" So, thank you for your attention. We have a reception in the Pueblo Room that we're welcome anybody who can come by and chat further, and I'm happy to answer any questions that anyone may have.

TICK SEGERBLOM

Commissioner Naft.

MICHAEL NAFT

Thank you. First, I just wanted to thank Regents Goodman and Brager for being here, but also for putting Dr. Heavey in this position in the time that he has been there. At least for me, and I know for my colleagues, the collaboration that has already occurred has been 10 times. And so, I just thank you for that. President Heavey, I'm, as you know, glad you are in this role because you didn't have to buy your Scarlet and Gray. You've had it for a long time. You know this community, you know the needs of the community and the campus. And just thrilled that you are there and that we have this collaboration. Yes, in the innovation district, yes, we'll continue to work through any issues that come up between Clark County, between any of our entities and the university. But knowing that we have someone who we can work with in a collaborative way makes all the difference. So, thank you for your presentation. Chair Segerblom, thank you for agendizing this. And just appreciate the work that we're going to do together.

CHRIS HEAVEY

Thank you, Commissioner Naft.

TICK SEGERBLOM

Commissioner McCurdy II.

WILLIAM MCCURDY II

Thank you, Chair Segerblom. And thank you, President Heavey, for your presentation. It's been truly a joy working with you since you've come into this new role. I think that we've made a lot of progress together. I'm looking forward to the future, what all we have to accomplish within my district, but broadly across Clark County. So, thank you for the presentation. I'm proud to be an alumni of UNLV, Greenspun College of Urban Affairs, and look forward to doing great things. Thank you.

CHRIS HEAVEY

Thank you.

TICK SEGERBLOM

Seeing no one else, I'd like you to come up with your team. I do have a proclamation for you, but I also want to correct one thing. Commissioner Gibson and I share UNLV, so I would love to have it, but he's sold out.

JIM GIBSON

Yeah, until a few minutes ago, I was thrilled to have you at UNLV.

TICK SEGERBLOM

Anyway, if you and your team would come on up, please? There we go. All right, so as I said, I do have a proclamation for you. Today is UNLV Day at Clark County. Go back to the Pueblo Room. There's all kinds of resources there. But we're just so proud to have you as part of our partnership, and we look forward so much to working with you, the medical school, the nursing school, all the schools, and just so proud. And Heavy you already said it, so let's, maybe we can have the dean of the medical school say something.

ALISON NETSKI

Oh, thank you very much. I'm very happy to be here today. I'm the current dean of the Kirk Kerkorian School of Medicine at UNLV, and very honored to be here serving our community. Being able to expand the opportunities for the residents of Clark County, to receive healthcare and provide fantastic educational opportunities to the students in Nevada.

PUBLIC COMMENTS

KEVIN SCHILLER

We can now move to your second section set aside for public comment.

TICK SEGERBLOM

All right, this is the second period for public comment.

STEPHANIE PHILLIPS

Morning again, Commissioners. Stephanie Phillips, Political Affairs Director with Veterans in Politics. I speak in advocacy of Jasmine and Eddie Rojas. As I understand it, this body has jurisdiction over agencies like Child Haven, CPS (Child Protective Services), and DCFS (Department of Children and Family Services). When it comes to oversight and policy, every elected official in the state with jurisdiction must get involved and start holding these agencies accountable for their actions.

Imagine your child ripped from their bed as they're sleeping at 3 a.m., with no court order, warrant, when there is no sign of abuse or harm. Imagine your children being moved to five, five different placements within a nine-month period of time. Imagine your kids being moved to a foster home or to Child Haven without notice, cause, or a court order. Imagine seeking medical records from Child Haven, and being told they are not allowed to give parents medical records, and it must go through a CPS caseworker, yet that caseworker ignores your request.

Imagine your child needs medication that could be life-threatening if they did not get it, and Child Haven not be able to tell a parent whether they have the medication or have given it to the child. Imagine being accused of abusing your children, but you're innocent. Initial tests appear to show possible signs of abuse, but are often mistaken for other serious medical and genetic conditions. Imagine CPS blocking your ability to schedule medical tests for your child and your ability to be in an emergency room to make medical decisions for your child.

This is what happens to Nevada families. There is abuse of power, severe overreach, parental and civil right violations, parent alienation, false accusations, lying, and beyond. Standard protocol needs to be implemented immediately for oversight of CPS, Child Haven, and DCFS. Number one, where abuse has not been proven beyond a reasonable doubt, parents must be notified prior to their children being moved, and a court order must be required before changing placements. Number two, visitations set up within 24 hours of a new placement. Number three, phone calls allowed daily with children. Number four, CPS must not interfere when a parent schedules medical testing and is present at medical appointments. Number five, Child Haven must be required to give parents medical records directly. Number six, placements are chosen by a collaboration of the presiding judge, the parents, and CPS, not solely CPS. A full investigation of CPS worker, Carrie Allen Singleton, needs to be conducted for abuse of power and position.

I urge the Commission to get involved and fully investigate these agencies. There are thousands of parents who are affected by them, but more so, the poor, innocent children are affected in the most devastating and horrific ways. We the taxpayers of Clark County urge this body to move swiftly in this matter. The children in Clark County are counting on you, and all elected officials with jurisdiction over these agencies, the very agencies that are supposed to be protecting children. I speak in advocacy of Jasmine and Eddie Rojas. Thank you so much.

TICK SEGERBLOM

Thank you.

STEVE SANSON

Good morning, Commissioners. Steve Sanson, President of Veterans in Politics Foundation. I stand here today for the families who cannot be here, because of their voices have been stolen and their children ripped away by the very agencies meant to protect them: DFS, CPS, and Child Haven. I want you to listen, not as politicians, but as parents, as grandparents. I want you to picture the faces of your own children and grandchildren as I speak. Picture this, it is midnight. Your grandchild is sleeping peacefully in their bed. Suddenly, there's a pounding on the door. No warrant, no judge's order. Just a case worker, like Carrie Allen Singleton, barging into your home with intimidation and threats. In minutes, your child or your grandchild is screaming, clinging, begging not to be taken, and then gone. Not because of abuse, not because of neglect, but because the system can. This is happening in Clark County. This is happening under your watch.

These case workers are not experts. Many have no education in child psychology, no training on trauma, no understanding of the lives they destroy. Yet they walk into courtrooms with confidence, lying under

oath, deceiving judges, making a mockery of justice, and because of their words, words they know are false, families are shattered. Child Haven is not a refuge, it is a warehouse of suffering. Children quiet themselves to sleep in strange beds because — holding blankets that are not theirs, whispering through tears, "Why didn't Mommy come? Why didn't Daddy save me?" These children do not understand that their parents are fighting every second to get them back. What they learn instead is abandonment, betrayal, despair. The wound never heals.

Commissioners, you hold the power here. These agencies report to you. Their budgets, their authority, their oversight is yours, which means every unlawful removal, every trespass, every intimidation, every lie in court, every tear shed at Child Haven is on your conscience if you do nothing.

Let me ask you mother to mother, father to father, grandparent to grandparent, would you stand silent while a stranger lies under oath to steal your grandchild? Would you stay quiet while your child is dragged out of the bed in the night by someone with no warrant, no authority, no truth? Would you accept your family being destroyed by a caseworker who treats lives like paperwork? This is not child protection. This is government cruelty. This is the state-sponsored kidnapping. And the children of Clark County are begging you with their tears, their screams, their silence to stop it. History will remember this moment, either as the time —

TICK SEGERBLOM

Your three minutes are up —

STEVE SANSON

This commission stood up for families or as the time it took while children are stolen from homes. The choice is yours. Please do not let another child —

TICK SEGERBLOM

Your three minutes are —

STEVE SANSON

— go to sleep at Child Haven, wondering why no one came. Thank you very much, and I looked up all of you. All of you are parents or grandparents —

TICK SEGERBLOM

Your three minutes are up —

STEVE SANSON

This should apply to all of you. Thank you, Chair. I'm sorry. This is very emotional.

TICK SEGERBLOM

Obviously.

STEVE SANSON

Until it knocks on your door, then you'll never know.

TICK SEGERBLOM

All right.

STEVE SANSON

Thank you.

AL ROJAS

Can I speak now?

TICK SEGERBLOM

Yes.

AL ROJAS

My name is Al Rojas. I'm active in the community for community safety, and I just wanted to report some positive things that are going on in our community. How law enforcement is really helping us out. I really do want to give a compliment to our Clark County Police Department [Office of Public Safety] with how they're doing well with our parks. You know, our parks are so important, especially, like you know, I'm a senior citizen, I'm 65, and some people complain about going to the park. There's a lot of homeless, but I can say in our Clark County parks, they're doing really well with the County Police Department, and especially at Martin Luther King Park, which was, they just did a road there. Before, there was a lot of RVs (recreational vehicle) around the park, and I was going to call, and I don't know how they did it, but three days later, everything got cleared up, and it's a great park to go to. I'm getting a lot of compliments in the community that that park has just turned a whole image around. That communicate and I have to attribute; this is really what I wanted to say.

There must be good communication that's going on now with the Clark County Parks and Metro (Las Vegas Metropolitan Police Department), because I see that collaboration and that's what it's going to take. That's happening in our community, and I want to compliment both our Clark County Police, Metro for working together. We still need a little bit more accessibility when somebody wants to call, if there's homeless at the park to reach the Clark County Police. We still need to work on that just a little bit, but I really want to just thank our law enforcement and our Commissioners who are keeping everything coordinated. I just wanted to get that out there.

Let's enjoy our parks. Our parks are important. People go out there on the weekends with their family, with their churches. It's a place to go relax, and you don't want to be like some of these parks, and I hate to say it, Las Vegas City Park, Jaycee Park, it's a disaster. You go in there, nothing but a bunch of shopping carts with homeless. It's scary. Nobody wants to go there anymore, but we're not having that problem in our county parks. Thank you very much.

TICK SEGERBLOM

Thank you. Good morning again.

MARCO MONTENEGRO

Good morning. Thank you for having me. It's an honor to be here, Chairman. Thank you. I have two minutes, I suppose left, right?

TICK SEGERBLOM

Yes, but we'll give you two and a half.

MARCO MONTENEGRO

Okay, thank you. All right, so my name is Marco Montenegro. I am the Operational Director of Akari Law Firm, Personal Injury Firm. And the reason I'm here, I'm here because once upon a time, I was an Uber driver. And now, I'm doing excellent, thank God, but I do want to stand up for Uber and Lyft drivers. Now, I don't know if ever anyone brought to your attention, but I can tell you that Uber has been taking advantage of these good people for many years. They're going to celebrate, now, 10 years servicing Las Vegas.

I don't know if you'd know this, but they're not providing uninsured motorists, neither to drivers or riders, and guess what? They actually reject their COOs (Chief Operating Officer) or CFOs reject on behalf of drivers. I have one right here, he's a friend of mine, and he can confirm. I'm willing to provide you also paperwork so you guys can see that they do that. If I was to do that on anyone's behalf, I would be jailed. They don't even get slapped on the wrist. Please understand, a single hospital visit can range anywhere between \$10,000 to \$70,000, depending on what's done on a person. Uber has made \$46 billion, and they claim that they profited only \$10 [billion], last year. Lyft, however, they did a lot worse, sadly, only \$16 billion. Average driver, Uber driver, full-time driver makes \$32,000. The only thing that they're offering, Uber offers \$5,000 in MedPay (medical payment coverage), or Lyft is a little more generous. They offer \$10,000 in MedPay and that's it.

Now, I have to go and tell my client, let's say, Mohammed Waseem, who is now having confirmed permanent brain damage. I have to tell him that he's going to get offer of \$5,000 by Uber. That's all they're going to give him. Please, this needs to change. I'm asking you, there's 5,200 registered Uber and Lyft drivers. Most of them do full-time. That is a critical mass. I promise you, I will unionize them. I will do everything I can with the help of a couple other counselors, pro bono. We're going to create a movement, and I promise you, next time you see me, there's going to be a lot more of them.

But I'm asking you, please put an agenda. They either need their licenses revoked or suspended, but something needs to be done. If we can, I would like to see if the Chairmen and counselors would like to perhaps schedule a date. I'd like to come back with far more paperwork. I can provide you everything I said. I have receipts. I can show it to you, and I'll show you that atrocities continues. Please take me seriously, because again, I'm not going away. I'm coming back in numbers, and I thank you for your time. Any questions? I'm sorry.

TICK SEGERBLOM

Thank you. We can't have questions right now.

SALEM AYOOB

Good morning, Commissioners. Salem Ayoob, 3079 Garnet Court. Actually had a Metro incident last night on our cul-de-sac, because now I got two illegal short-term rentals trying to pull some shifties, because obviously of recent events. Now, we're talking about previous agenda, you get scrambled if I come here too early, because there's so many items that are on the agenda that are connected to this issue, fees. Like that last project that Commissioner Jones, Commissioner McCurdy II were going to put it off for two weeks, but all these things can be solved if we're collecting proper fees, especially from the unlicensed properties. The fees and the penalties are astronomical. Unless I'm wrong, we just got our butts kicked last week, didn't we? This is war. I'm a Nevadan, all for our country, whatever you want to call it, man. This Airbnb things, guy, I know that something's supposed to be going down August 31 or September 1, but this is how blatant it is.

Tayshaun Todd was found drowned at 2670 Palma Vista two months ago. They're all already advertising illegally again on Airbnb. That should be an automatic \$10,000, \$10,000, \$10,000, \$10,000, regardless what any judge orders. If it gets so bad where the fees are so high, just refer it to the DA's (District Attorney) office for criminal prosecution, because you can tag on all the fraud and the theft from the Public Treasury. Every host and every licensee is supposed to pay fees. They're killing it. That's why they're not stopping. They're making so much money. Let's throw this one in. Are we on a \$900 million shortfall for a new stadium, and the guy comes down from Oakland and says he's going to help out Southern Nevada? Oh, my gosh, this is getting crazy. Sorry. I understand there's a lot of emotion in the room today, but so you got 3068 Garnet Court right outside my front window. Four men from out of the country last night. I called Metro, and I didn't open Pandora's box.

The officer assigned to that case called the LVMPD three weeks ago. 25070000091718. It was a story that was on Fox 5. There was eight days of groceries left on the front door. What does that tell the vagrants in the neighborhood? What does that tell the potential squatters? When the officer showed up, he made contact with the people that were illegally staying at 3080, the other, the bane in the neighborhood. He didn't even contact Officer Jones who has that one. Officer Yay didn't even — They got seven short-term rental code officers on these teams, they're not even communicating on adjacent properties. So, I had to enter those into the record. The one from last night is 25080000. The last five, sorry, real quick, are 71980. This has got to stop. Thank you.

TICK SEGERBLOM

It is. All right. Any further comments? Seeing none, we'll close the hearing for today. Adjourned until tomorrow morning at 9 a.m.
