

AMENDMENT TO THE INTERLOCAL CONTRACT
TO GRANT COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS
TO THE CITY OF MESQUITE
FOR PROGRAM SERVICES FOR FISCAL YEARS
2016/2017, 2017/2018, 2018/2019, 2019/2020

WHEREAS, the Board of County Commissioners of Clark County, Nevada ("the Board" and the "County", respectively) and the City Council for the City of Mesquite (the "Subrecipient"), have previously entered into an Interlocal Contract to grant Community Development Block Grant ("CDBG") Funds to the City of Mesquite for its capital development projects for low income residents (the "Interlocal Contract"); and

WHEREAS, it is the desire of the Subrecipient to amend the allocated CDBG capital funds for the fiscal year as described herein; and

WHEREAS, all of the funds subject to reallocation as described herein are within the Subrecipient's Five-Year Capital Improvement Plan for Fiscal Years 2015/16 through 2019/20 as previously approved by the Subrecipient and County, and as hereby amended; and

WHEREAS, under the original Interlocal Contract for Fiscal Year 2016/17, Subrecipient was allocated CDBG funds in the amount of \$203,857 which was programmed for Capital projects. Said contract was approved by the Subrecipient on February 14, 2017 and by the County on March 7, 2017. This amendment revises the scope of work further to shift funds from Mesquite Recreation Park Improvements at Desert Rose, Jensen Park and Pickleball Court Complex to other approved activities, being the Woodbury Skate Park; and

WHEREAS, under the original Interlocal Contract for Fiscal Year 2017/18, Subrecipient was allocated CDBG funds in the amount of \$205,244 which was programmed for Capital projects. Said contract was approved by the Subrecipient on January 9, 2018 and by the County on February 6, 2018. This amendment revises the scope of work further to shift funds from Mesquite Recreation Park Improvements at Desert Rose Park, Jensen Park and Pickleball Court Complex to other approved activities, being the Woodbury Skate Park; and

WHEREAS, under the original Interlocal Contract for Fiscal Year 2018/19, Subrecipient was allocated CDBG funds in the amount of \$229,920 which was programmed for Capital projects. Said contract was approved by the Subrecipient on November 27, 2018 and by the County on December 18, 2018. This amendment revises the scope of work further to shift funds from Mesquite Recreation Park Improvements at Desert Rose Park, Jensen Park and Pickleball Court Complex to other approved activities, being the Woodbury Skate Park; and

WHEREAS, under the original Interlocal Contract for Fiscal Year 2019/20, Subrecipient was allocated CDBG funds in the amount of \$230,997 which was programmed for Capital projects. Said contract was approved by the Subrecipient on October 8, 2019 and by the County on December 3, 2019. This amendment revises the scope of work further to shift funds from Mesquite Recreation Park Improvements at Desert Rose, Jensen Park and Pickleball Court Complex to other approved activities, being the Woodbury Skate Park; and

WHEREAS, under the original Mesquite Consortium Interlocal Agreement between the County and Subrecipient for Housing and Urban Development Community Development Block Grant County Program for Fiscal Year 2018 – Fiscal Year 2020. Said contract was approved by the Subrecipient on May 23, 2017 and by the County on June 20, 2017.

WHEREAS, Subrecipient has provided the County with a list of reprogrammed capital activities and projects to be funded within the Program necessitating this Amendment to the Interlocal Contract for Fiscal Years 2016/17, 2017/2018, 2018/2019 and 2019/2020. This amendment is in accordance with the reallocation approval by the City Council of Mesquite for its CDBG capital projects on July 26, 2022, and attached hereto as revised Exhibit “B” and Exhibit “D” for Fiscal Years 2016/17, 2017/18, 2018/2019 and 2019/2020.

NOW, THEREFORE, BE IT AGREED BY THE BOARD AND SUBRECIPIENT THAT:

- A. Exhibits “B” and “D” for Fiscal Years 2016/17, 2017/18, 2018/2019, 2019/2020, attached hereto, shall replace the previously adopted Exhibits “B” and “D” adopted under the original Interlocal Contract for each fiscal year as noted herein.
- B. Except as amended hereby, or inconsistent herewith, the Interlocal Contract shall remain in full force and unchanged.
- C. References to Community Resources and its manager shall be replaced with references to Social Service and its director.

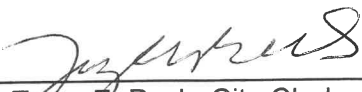

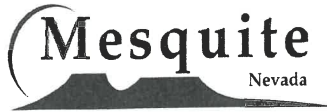
