- The term of the Contract is from date of award through October 31, 2026 and includes the option to renew for four (4), one-year periods and includes a 3 month extension.
- Includes the option to increase the award amount up to ten percent 10% based on possible increased user requirements for the renewal terms and approved budget appropriations.
- Includes the option to increase the award amount up to five percent 5% for possible price increases for renewal terms.
