PROFESSIONAL PROJECT ADMINISTRATION AND CONSTRUCTION MANAGEMENT SERVICES CONTRACT FOR CAREY AVENUE – NELLIS BOULEVARD TO TOIYABE STREET

SUPPLEMENTAL NO. 1

THIS SUPPLEMENTAL NO. 1, hereinafter referred to as "Supplemental No. 1", is made and entered into this 20th day of May, 2025, between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada, hereinafter referred to as "COUNTY", and CMWorks, Inc., a corporation duly authorized to do business under the laws of the State of Nevada, hereinafter referred to as "ENGINEER."

WITNESSETH

WHEREAS, on May 2nd, 2023, the COUNTY and the ENGINEER entered into a contract for professional project administration and construction management services, hereinafter referred to as "Contract", for the construction of Carey Avenue – Nellis Boulevard to Toiyabe Street, hereinafter referred to as "Project"; and

WHEREAS, the amount of services required has been greater than anticipated due to no fault of the ENGINEER. The additional construction management services are required to complete the project due to utility conflicts, extended project duration, and revisions. The additional funding needed will be \$90,200.00, bringing the total Contract value to \$1,914,200.00, and

NOW, THEREFORE, for and in consideration of the premises and mutual covenants herein contained, the parties mutually agree to supplement the Contract as follows:

ARTICLE III PAYMENT FOR SERVICE

3.01- MAXIMUM AMOUNT PAYABLE shall be changed to read as follows:

The COUNTY shall pay to the ENGINEER for Basic Services and Special Services provided, a sum of money not to exceed One Million Nine Hundred and Fourteen Thousand Two Hundred an 00/100 Dollars (\$1,914,200.00) unless such sum is increased by the Clark County Board of Commissioners, but only to the extent such total sum is increased.

Payments made pursuant to this Contract are to be determined by provision 3.02, 3.03, and 3.04 set forth herein.

The remainder of the Contract shall remain unchanged.
