Skills & Experience:

Currently, I am a children's attorney in the Children's Attorneys Project (CAP) at Legal Aid Center of Southern Nevada (LACSN). I have worked in this capacity since 2015. I also serve as a team chief. I am interested in joining this committee because I see a great opportunity for helping advance children's rights and learning about resources and programs to obtain better outcomes for children and families within the child welfare system. There are numerous programs and resources available however, without proper coordination and communication, not everyone is aware of their existence. I would like to learn about resources and policies and help to utilize them to improve our system in Nevada.

Since becoming a children's attorney ten years ago, I have not only enhanced my skills as an advocate and my knowledge of child welfare, but I have also developed my organizational, communication, interpersonal, and management skills by taking on more leadership roles within LACSN and the community. At LACSN, I serve as a team chief, supervising and supporting a team of five attorneys and two legal assistants. In this role, I review and assign incoming cases, participate in monthly team chief meetings, lead team meetings, set goals and help to achieve them, and respond to the needs of team members and outside agencies. I also balance my own caseload of clients. I have developed and taught Continuing Legal Education (CLE) classes on child welfare and mentored pro bono attorneys.

I am also an adjunct professor of law for William S. Boyd School of Law's Samuel S. Lionel Externship Program, where I manage and advise students in their legal externships, deliver lectures on ethics and professional development, prepare course materials, and evaluate and grade student assignments. In a previous teaching position as an adjunct faculty lecturer in the Criminal Justice Department at the University of Nevada, Las Vegas, I lectured on criminal justice and law, prepared course materials, evaluated and graded student assignments, and advised students about careers in the legal field. I was also an adjunct professor in the Poverty Law & Policy Clinic, where I helped to prepare course materials, guide students on researching policy issues, and reviewed, edited, and graded student assignments. These positions have taught me how to educate, motivate, and encourage individuals to learn.

Outside of work, I served on many boards in various positions and have helped to establish organizations' short and long term goals, plans, and strategies, work with members to achieve the goals of the organization, support the work of committees, and be responsive to and incorporate other members' input, maintain a collaborative and respectful atmosphere, facilitate board and general assembly meetings, and monitor the financial standing of the organizations.

My knowledge of child welfare, enthusiasm, experience, and strong organizational, communication, interpersonal, and problem-solving skills, gained from these experiences, would be helpful to the committee.

I believe that my experiences, combined with my willingness to learn and collaborate, make me a well-rounded candidate. Thank you for your consideration.
