## FIRST AMENDMENT TO SITE LEASE AGREEMENT FOR WIRELESS COMMUNICATION FACILITY

THIS FIRST AMENDMENT TO SITE LEASE AGREEMENT (this "First Amendment") is made and entered into effective as of the \_\_\_\_ day of \_\_\_\_\_, \_\_\_\_ (the "Effective Date"), by and between Clark County, Nevada, a political subdivision of the State of Nevada ("Lessor" or "County"), and Bell Atlantic Mobile Systems LLC d/b/a Verizon Wireless, a Delaware limited liability company, successor-in-interest to Southwestco Wireless, Inc. (the "Lessee"), collectively known as the "Parties" or individually as the "Party."

#### WITNESSETH:

WHEREAS, the County leased to Lessee's predecessor-in-interest a portion of the County's Sunset Park property located at 2601 E. Sunset Road, Las Vegas, NV ("Site"), and more particularly described in that certain Site Lease Agreement dated February 1, 2005 (the "Prior Lease") for Lessee's installation and operation of a wireless communications system on the Site; and

WHEREAS, the Prior Lease expired on January 31, 2020 and Lessee continued to operate its wireless communications facility on the Site while the Parties negotiated renewal lease terms ("Holdover Period");

WHEREAS, the Parties entered into a site lease agreement effective as of May 19, 2020 ("Lease");

WHEREAS, the Parties have or will enter into a settlement agreement regarding holdover rent and late fees due and owing to County during the Holdover Period ("Settlement Agreement"); and

WHEREAS, as part of the Settlement Agreement, the Parties are required to amend the Lease to clarify Subsection 4.3 of the Lease regarding late fees.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth herein, the Parties agree as follows:


- 1. Section 4.3 of the Lease shall be deleted and replaced with the following:
  - "4.3 Lessee shall pay County, in addition to any payment due, a late payment charge, equal to five percent (5%) per month ("Late Fee") of any payment required by this Lease which is not paid when due ("Past Due Amount"). A Late Fee is considered a payment required ("Required Payment") under this Lease and added to any Past Due Amount collectively becomes a Past Due Amount. Any Past Due Amount shall incur a monthly Late Fee added to the Past Due Amount until paid in full. County shall not additionally charge compound interest for any payment not received."
- Except as expressly amended in this First Amendment, the Lease shall remain in full force and effect.
