SUMMARY – An Ordinance to amend Clark County Code 2.68.060 to allow for the County Manager or designee to authorize additional compensation for a hearing officer.

AN ORDINANCE TO AMEND TITLE 2, CHAPTER 2.68, SECTION 2.68.060 OF THE CLARK COUNTY CODE TO ALLOW THE COUNTY MANAGER OR DESIGNEE TO AUTHORIZE ADDITIONAL COMPENSATION FOR A HEARING OFFICER; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION 1.** Title 2, Chapter 2.68, Section 2.68.060 of the Clark County Code shall be amended to provide as follows:

**2.68.060 - Hearing officer compensation.**

The hearing officer, unless employed by the county shall be entitled to compensation from the county for services rendered on any given hearing at the rate of one hundred twenty dollars per hour with a maximum chargeable time of ten hours per hearing. In the event that a hearing officer serves more than ten hours on any given hearing, he or she may submit to the ~~board~~ County Manager or the County Manager's designee a written statement requesting additional compensation and setting forth reasons therefor. The ~~board~~ County Manager or the County Manager's designee may

authorize such additional compensation at the rate of one hundred twenty dollars per hour if it is satisfied that the additional hours of service were justified and necessary.

SECTION 2. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall take effect on and be in force from and after its passage and the publication thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks.
