THIS AMENDMENT is made and entered into this ____ day of _____ 2023, by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY” or “Customer”), and ENVIRONMENTAL SYSTEMS RESEARCH INTSTITUE, INC. (hereinafter referred to as “PROVIDER” or “Esri”).

WITNESSETH:

WHEREAS, the parties entered into an agreement under CBE Number 604790-18, entitled Master Purchase Agreement 329214 with an effective date of April 17, 2018 (hereinafter referred to as AGREEMENT or PA); and

WHEREAS, the parties desire to amend the AGREEMENT.

NOW, THEREFORE, the parties agree to amend the AGREEMENT as follows:

1. Document 2, State and Local PA Terms and Conditions, Article 2

ORIGINALLY WRITTEN

“Customer’s right to purchase under this PA shall remain in effect for five (5) years from the effective date unless terminated earlier as set forth in Article 5 – Termination, Cancellation. The term may be extended upon mutual written agreement. The term of any Product licenses or maintenance ordered through this PA shall be as stated in the Master Agreement.”

REVISED TO READ

“Customer’s right to purchase under this PA shall remain in effect for five (5) years and an additional five (5) one-year periods from the effective date unless terminated earlier as set forth in Article 5 – Termination; Cancellation. Customer will provide written notice of Customer’s intent to exercise any such one-year period prior to the anniversary date. The term of any Product licenses or maintenance ordered through this PA shall be stated in the Master Agreement.”

2. Document 2, State and Local PA Terms and Conditions, Section 9.1 Pricing

ORIGINALLY WRITTEN

“9.1 Pricing. Esri will provide Product, maintenance, and support specified at the prices incorporated into this PA. The specified prices stated in the incorporated Esri Price List are exclusive of shipping, installation, and applicable taxes. Esri may update the pricing no more than once each calendar year upon written notice to County.”

REVISED TO READ

“9.1 Pricing. Esri will provide Product, maintenance, and support specified at the prices incorporated into this PA. The specified prices stated in the incorporated Esri Price List are exclusive of shipping, installation, and applicable taxes. Esri may update the pricing no more than once each calendar year

upon written notice to County. Esri may update prices of items also included in their General Services Administration (GSA) Contract GS-35F-253CA, to remain compliant with that Contract. These items are not subject to the once-a-year price increase restriction. Esri will provide County with written proof of acceptance of price increases within 30 calendar days of receipt of acceptance from GSA.

3. The revisions contained herein are effective as of April 18, 2023.

Except as expressly amended herein, the terms and conditions of the Agreement shall remain in full force and effect.
