**WITNESSETH:**

**WHEREAS**, the parties entered into an agreement under CBE Number 606381-22, entitled "Technical & Economic Assistance Program Administration" dated December 9, 2022 (hereinafter referred to as CONTRACT); and

**WHEREAS**, the parties desire to amend the CONTRACT.

**NOW, THEREFORE**, the parties agree to amend the CONTRACT as follows:

Direct grant awards, Amount \$5,000,000

**REVISED TO READ:**

Direct grant awards, Amount \$6,500,000

2. Exhibit A Scope of Work, Part 1.

**ORIGINALLY WRITTEN:**

*[1] The budget assumes a fund size of \$5 million, approximately 350 applications awarded, and 1,300 applications fully processed. The number of applications will be capped at 1300. If additional services are required COUNTY and PROVIDER will work through the Amendment process.*

**REVISED TO READ:**

*[1] The budget assumes a fund size of \$6.5 million, approximately 350 applications awarded, and 1,300 applications fully processed. The number of applications will be capped at 1300. If additional services are required COUNTY and PROVIDER will work through the Amendment process.*

3. Page 1, Section II, Compensation and Terms of Payment, Subsection C.2.

**ORIGINALLY WRITTEN:**

Payment of invoices will be made within thirty (30) calendar days after receipt of an accurate invoice that has been reviewed and approved by COUNTY.

**REVISED TO READ:**

Payment of invoices will be made immediately after receipt of an accurate invoice that has been reviewed and approved by COUNTY.


This Amendment No. 1 represents an increase \$1,500,000.
