
Clark County Commission Education Priorities

Educational Priority Areas	Research and Analysis
 Expansion of Open Schools, Open Doors CCSD Collaboration with Clark County on children's mental health and access to services. CCSD Collaboration with Clark County on school construction/renovation. Identification of rural-specific education issues. Embed the County's Truancy Prevention Outreach Program (TPOP) into CCSD. Status of the Lundy Elementary School on Mt. Educational Priority Areas Updates

Open Schools Open Doors:

- Staff from Office of General Counsel, Government Relations, and Accounting are conducting an internal review of all existing ODOS agreements.
- Clarify obligations and establish procedures for facility use and scheduling.
- Office of General Counsel is drafting necessary amendments and has completed the proposed addendums for Boulder City and City of Henderson.
- Draft will be presented to the Director of Govt Relations and leadership for feedback.
- CCSD will work with municipalities to finalize amendments for board consideration.



Educational Priority Areas Updates

Facilities Master Plan:

- Long-range roadmap for future Board decisions and actions.
- Not just for capital investments, but also programs and facility use.
- Inform decisions about grade configurations and the number, size, and location of schools.
- Consider critical facility needs, including modern HVAC, shaded outdoor learning spaces, solar panels to reduce energy costs, and buildings designed to support collaborative learning, potentially replacing outdated schools.
- The planning process includes focus groups and community meetings.
- Two community surveys to gather input: one in the spring to establish core priorities, and another in the fall to evaluate specific future options.



Educational Priority Areas Updates

Facilities Master Plan Upcoming Events:

- September–October Survey 2
- November—December workshops to review survey results and develop recommendations and project prioritization.
- January–March 2026 Master Plan Report and final recommendations to the Board.




NSPF (Nevada Report Card) Results Released:

- 136 CCSD schools made improvements in their star ratings.
- CCSD improved in both English Language Arts (ELA) and Mathematic proficiency, across all levels, in elementary, middle, and high school.
- Largest gains in middle school ELA proficiency, which improved by 4.9 percentage points districtwide.
- Chronic absenteeism rates reduced by more than four percent, from 31.3 percent in 2023-2024 to 26.9 percent in 2024-2025.
- Overall, 272 CCSD schools increased their index scores from 2024 to 2025 on the NSPF.
- The following 50 CCSD Schools improved their index scores by 20 or more points:

2025-26 School Budgets - Fall 2025 Revision:

- "Count Day" student enrollment ended 3,600 students fewer than originally predicted when draft school budgets were released in the Spring.
- Schools that are serving fewer students than anticipated did see a reduction in their 2025-26 budgets.
- 40% of schools saw increased enrollment over spring predictions.
- Some schools saw a decrease in students who received a weighted funding amount, such as students who were designated under state definitions as English Language Learners, At-Risk, or Gifted and Talented.
- Like public school districts across the nation, CCSD is experiencing declining enrollment.
- 24,500 CCSD students are enrolled in 12th grade compared to 17,600 new kindergartners.
- CCSD received \$36 million less in At-Risk weighted funding in 2025-26 than originally projected due to eligibility changes in the state funding formula. The District opted to utilize central funds to cover this reduction so that school budgets were not impacted by this change.

Results of Superintendent Ebert's 100 Day Plan:


- The 100-Day plan made significant progress in working to improve four areas of our climate and culture:
