I want to make note that Item 36, which is - relates to the pedestrian bridges, is going to be held to our first meeting in January, January 2<sup>nd</sup>, and we will not be hearing that item today. So, if you're here to speak on that item, it's not going to be heard. Yes, Mister Uehling?

Yes, I wanted to thank you as for-

I need you to say your name.

Come on, Ed. Let's talk about the agenda. Let's talk about something on the agenda.

**UEHLING** 

Thank you. One of the reasons why there are so many drunk driving incidents is the County's law that doesn't permit bars to be established within certain distances. I think the distance is now 2,000 feet. And so, the County is actually acting; on the one hand, it's saying, "Oh, we want to prevent deaths." On the other hand, it's saying, "Let's encourage people to kill themselves on the roads." That's one of the many hypocrisies and bad public decisions.

I want to talk about number 28. This provides parking for the Super Bowl employees over a period of time, and I gather that it's the - it says a hundred acre lot. If someone could clarify what the hundred acres is about, I would appreciate it. I specifically know about the 42-acre lot which is on the corner of Tropicana and Paradise Road, which is where the detention basin is going to be constructed. So, I imagine it's primarily about that. And many times, we've – well for 40 years, the gay community used that lot for parking. Sometimes, so many cars that have reached down to Tropicana Avenue. Then when the airport bought the property about 20 years ago, we were - it was fenced off and we weren't allowed on the property, all that stuff. Then every time we want to use it, I personally arrange for it to be paved with used - what

do you call it from the roadway? The stuff that they take up from the roadways and the runways and things like that. And so, there wouldn't be any dust. But every time we want to do that, the Air Quality Control people just go crazy. You can't have a car park on that property on those 42 acres. You can have – you can put up with huge dust storms coming off the property - of certain areas of the property. You ruin our air conditioners, but you can't park there, and yet there seems to be no consideration of that here.

**GIBSON** 

Thank you. Morning.

MARGARET COLEMAN

Good morning. It's been a while. I stayed away so you could think about me. My name is Margaret Coleman. And as you know, you want me to be Margaret Watson, and that is impossible. This is business items. I got an opportunity to go back into my home, and it has been a life-threatening situation whereas I have an overload of electricity in my home, and I have complained to the Fire Department to decrease it. Now, I've been in there three months trying to get some sleep. I haven't gotten it off from being homeless off the streets. I'm needing you to pay attention to my reasons for coming here, and that's to help me. You placed my life on a pole and that's my reason why the electricity is coming into my house. 1316 Wizard has an address concerning me, Margaret Coleman. There is a 1316 Star Meadows that is placing my life at a threat, and I would like it corrected.

This is concerning also the future of my child that Kevin Schiller placed, and the committee placed into a shelter for self-alliance. She got ran over and I'm trying to have her independency, but it's not working. My children are suffering with me. I'm needing finances, I'm needing you to release my money. I have not been here, and I have given you reasons to reimburse me. It's because you used it. So, if you take the time out and call me at the number that I gave you, 702-934 - not 934. 725-825-285-9419. That is my number. We need help, okay?

And the community has - you have taken DBA and LLC to be controllers of my home next door, and the attorneys and lawyers, and they're putting my home house at a threat because they don't believe I'm the owner. Breaking in and entering, taking stuff, I don't appreciate. So, you're giving me the opportunity to go back. I'm needing to pay my taxes. You, in partnership with Pay Pega, that won't release the name of my ownership of my home. I need that done, so let's correct that, please. Thank you. My name is Margaret Coleman and the reason why I return is for you to do corrections.

GIBSON Good morning.

CHRISTINA RAMOS Good morning, Commissioners. For the record, Christina Ramos, Deputy Director of

Human Resources.

GIBSON Will you pull that microphone over right in front of you?

The item before you is a full contract with a three-year term from 7/1/2023 through 6/30/2026. The cost for the agreement is \$1,151,620. Of the entire agreement, 11 articles were amended and there are 252 impacted positions. I respectfully request

GIBSON Would you state your name, please, for the record?

EPPENGER Kevin Eppinger, President of Juvenile Justice Probation Officer's Association.

GIBSON Thank you.

EPPENGER Sorry.

GIBSON Thank you. That completes your presentation on the County contract?

RAMOS Yes. I would like to thank Kevin though and his team who's always in the back. We

spent a really long day, but we finally got a three-year, fair agreement that we've got

put in place.

GIBSON Thank you very much. This is a public hearing. Is there anyone here who wishes to

speak on this item? That's Item 35 that relates to this contract with the Clark County Juvenile Probation Officers Association. There being no one, the public hearing is

closed.

SEGERBLOM Move to approve and congratulate everyone. Thank you.

GIBSON Yes, thank you very much for your work. There's a motion for approval of Item 35,

SCHILLER Commissioners, we can now move to the business section of your agenda. Item 37 is

to identify emerging issues to be addressed by staff or by the Board at future meetings, receive updates on the activities of the various regional boards and

commissions, and direct staff accordingly.

GIBSON Are there any emerging issues? Commissioner Segerblom, did you have one?

**SEGERBLOM** 

Yes. Thank you, Mister Chair. Last month, we had an appointment to Justice Court position in Henderson Justice Court. And at the time, it was understood that we would be able to - there was a second vacancy created by our Assistant County Manager that we would be able to appoint that position also. It turns out that given the length of time that would require to post the position, create a committee to investigate and all that stuff, they wouldn't be able to actually pick the person until after the filing period closes which is in January.

So, I wanted to propose we all met with the individuals that were selected for the first position. I would propose that you could just consider that group of people. We could waive the rule that we have currently requiring a new opening. And I would ask that with the Board, this be put on the agenda for the second meeting in December where we could decide whether we want to waive the rule that requires a new opening and just consider the people that we've already considered for the first position back in November, if that makes sense.

GIBSON Counsel? Miss Logsdon?

LISA LOGSDON So, I think what you're asking is staff to come back with a proposed agenda item

regarding a waiver of the resolution. And if that waiver would occur, then you could

have a separate agenda item to make an appointment.

SEGERBLOM Correct. And then the vote would be in January after the - or during – so whoever we

picked could be know that they were picked and file in that period, that window in

January. I think there's a 20-day window in January when you have to file.

LOGSDON So, per your Board rules, you would have a discussion item first, so you're coming up

on some timing issues with that because your Board rules require a discussion item to be brought before this Board to discuss that. And so, you would really be looking at a

three-meeting process under your rules.

SEGERBLOM Alright. So, when could we actually take a vote then? Would it be within that period

where people would know whether they could file or not?

LOGSDON You could have your discussion item at your next meeting and then you could

agendize depending on how that discussion item went. Could agendize for the first meeting in January. You could have a dual, kind of if this passes, then you could vote

on a second item, kind of agenda item.

SEGERBLOM Alright. That would be my request at this time. Thank you.

GIBSON Is there any comment on that request? So, we'll see this item on for discussion at our

next meeting. Alright. Thank you.

JUSTIN JONES Mister Chair?

GIBSON Yes?

**JONES** 

I just wanted to say on behalf of everybody, well done to all of our amazing team at Clark County for their efforts when it came to F1. I know that was a tremendous effort across the board.

And I did want to specifically address, I raised this at prior meeting, the work of our Public Communications team working with Public Works was tremendous. I think that we need to bring that same level of communication to our Public Works projects across the board. And so, I just ask that we really explore working with Public Works to make sure that communications with regards to the projects that we all drive through, the orange cones that we drive through every day get the same level of attention that certainly F1 did.

**GIBSON** 

Thank you. Are there any other emerging issues? Commissioner Naft?

MICHAEL NAFT

Chairman, just a comment of thanks. This Board has led - since we've been in this meeting, the federal government announced the \$3 billion grant for the Brightline West project. This Board's led two resolutions unanimously in support of that project, and just wanted to acknowledge how transformational that'll be for this community. Thousands of union - well-paying union jobs, tons and tons of carbon removed from the atmosphere. And of course, protecting our vital California tourism industry. So, it's a really big day for transportation in Clark County and really proud of everybody who helped make it happen.

**GIBSON** 

One other thing, a week ago, there were two of our Nevada Highway Patrol Officers killed in a completely incredibly stupid and horrific event. They each left families. We've had some discussion with the Department of Public Safety and others, the Governor's Office and the Governor. And we are, of course, heartbroken at the loss of those lives. Sergeant Michael Abbate and Trooper Alberto Felix, they obviously lost their lives in line of duty, and we extend our most sincere condolences to their families in this difficult time. I think that generally, in Clark County, we don't realize how many miles of highway - State highway that they have responsibility for. They're out there working and protecting us every day.

In the wake of their passing, the Injured Police Officer's Fund is accepting donations to help Sergeant Abbate and Trooper Felix's families. If you would go to https://IPOF.vegas to donate. The only official website collecting donations on behalf of these officers' families is IPOF.vegas. We hope that the community will step forward and bring some support forward. These families have been left without their primary source of support, and all because of the needless criminal act that was perpetrated by an individual while they were attempting to help someone. We wish we could do more, but one thing we can do is remember them. We need to keep their families in our prayers. If we know them, we need to be reaching out. There's a lot of numbness that occurs in a family when there has been this kind of a tragedy, and we encourage people to go to IPOF.vegas and consider making contributions that would support these families.

I also want to comment on the thing, the thing, the item that Commissioner Jones mentioned. The Formula One race was something that was extremely difficult for the community. No other community could have gotten it done, but it was, we know at the expense of considerable sacrifice by a lot of people. First, the time and the energy and the professionalism that was shown by the departments in our County is something that really made it all happen, and we appreciate and recognize that work.

### **GIBSON**

So that people can understand what on earth was the benefit, our community is dependent upon tourism. International travel to Las Vegas still has not completely recovered. During the Formula One broadcast, it is estimated that there were 100 million international eyeballs or sets of eyeballs on that race. It showed Las Vegas actually in an incredibly beautiful and effective way. We hope for the recovery of the

international travel to our community and even growth in the travel from the international segment to the community. And we pledge that we're looking very hard at that event and everything that went into it so that - to the extent that we can make it much more efficient and less impactful to us, we pledge to do just that.

And over the coming weeks, we'll be doing that evaluation and there will be - we'll publish the outcome of the things that we consider and determine. We're in discussions and we'll continue to be in discussions with the Convention Authority and with the Formula One people. And I think that we deserve the credit, or we should extend credit to those agencies, those departments in our agency that were effective in helping the Formula One race be successful the way it was. We will reap benefits from it, and we will also get to a point where it happens in a considerably easier way than it did this past year. So, thank you very much for all that you've done to help us get through this.

Mister Schiller, I think that concludes our identifying emerging issues item.

Thank you, Mister Chairman. I want to, one, clarify a couple of things because it's been misconstrued on what this Board actually its role is. This was a bill sponsored by Lesley Cohen in the Legislature, and it was actually started to be a statewide opiate task force on death reviews. To review the deaths to see if there's commonalities, which was modeled after Ohio and a couple of other states. However, the State did not want to encumber the cost, so the bill was going to die if we couldn't. I spoke with Assemblywoman Cohen at the time and said, "I felt that we could do it prospectively but not reactively," because they wanted to go back a year and it's just too much. And

#### KIRKPATRICK

if you'll all remember, we've since hired a Medical Examiner. We've since, at the Health District, put an epidemiologist and those people in place so that we could comply with this and use our opiate dollars to look at the deaths.

So, this Board specifically looks at the deaths. So, there was a lot of people and including the cities, "Oh, this is how the opioid money is going to be spent." Absolutely not. This is going to be looking at trends on deaths that have occurred within opiates, so some of that information might mean things such as how many overdoses did they have before the last overdose? How many - did they have a job and what was their economic background? And some of those things which - I just wanted to clarify that because I've been at two meetings now where I was thrown under the bus on what this committee does, and I'm clarifying this is what it does.

SCHILLER Commissioners, Item 44 is to discuss a potential resolution establishing a Colorado

NAFT Thank you, Manager Schiller. This is an item that was brought to me from the

Laughlin Town Advisory Board. I'd like to ask, I guess through Miss Logsdon, to lead some language that this body can move forward appointing a group of advisors on the Heritage Trail. As long as there's no opposition, I don't think it requires actions.

GIBSON No, I don't think that's an action item but that's a - she understands the assignment

she's given.

LOGSDON Yes. And if staff has any or if staff will bring in an agenda item back if there's any

further discussion of the Board.

GIBSON Great. Thank you.

**ACTION:** No action was taken by the Board.

GIBSON And that we don't have a confidential session, so that completes the agenda except for

the public comments.

**ACTION:** No closed session was held. No action was taken by the Board.

PUBLIC COMMENTS

GIBSON We'd invite those who wish to make public comment to come forward. Please know

that I'm departing right now but I will be able to listen to your comments, and Commissioner Segerblom will take responsibility for managing the meeting.

COLEMAN Yes. My name is Margaret Ann Coleman, that you want Margaret Watson to be me at

301 Duke, but I'm 1316 Wizard. I want to address that. Now, I'm at a point where I don't want to be on the Board. You people are callous. You're creating criminal matters that I have to confront criminal stoppers to contact you. I'm going to sue you people for trying to kill me at 1316 Wizard and creating that house. I got 37 jacks in my house that's overloading and giving me electricity overload. You want that to be the Fire Department Station? I didn't create that problem when I left 1316 Wizard, 2007, when I owned it. I'm going through pure hell to get my ownership. As I told you, you want DBA and LLC to take over Pegas. Pega, I want them released. Now I came up here nice, but listening to you all talking about safety, you're not trying to

save me and my kids' life.

My children are suffering and I'm tired of trying. I'm 70. I'm in my 70s. I'm getting old and I'm fed up and I haven't lived a life here. I haven't even gambled. You got my money tied up in this system because I wanted to be on the Board seat to have - to

earn an income.

You got this alkaline water that is battery water, and you know it's in my house coming through the refrigerator ice. You guys had set that house up to kill me. I wanted to stop. I want my money. You got Tom Hopper next door. As I told you, got attorneys next door that is trying to supply the neighborhood. That's why they're hating me because I'm back to take control over my ownership. But I want my money so I can move out and make some choices for safety and get my kids to safety.

Laws of Vegas have not done me equality or equal rights to take care of my children and raised them here. To have another child here has been an insult, I'm sorry to say it. I created you Board members to create the comfort of living for not only everybody but for me and my family, and you have destroyed my whole honesty and appreciation for you of being here. And I feel sorry for myself, and that I never wanted to do is feel pity. I want to leave with my head up high when I leave Las Vegas. I was a winner in the court system of receiving workman's comp and my pension, and you got them on the same block of trying to destroy me. Roaches coming into my house. I had to put towels up to stop electricity.

Thank you, Miss Coleman. Mister Braisted?

DANIEL BRAISTED

Chairman, Daniel Braisted, B-R-A-I-S-T-E-D. I want to thank the County for providing the large TV in the amphitheater so that we could watch the Formula One without all the traffic. It was very effective, and I know what happened there and in Henderson. Just wondering how many of the flat TVs in the downtown homeless area carried the race? The problem with the homeless area, all they talk about is homeless, and we should have stuck the Formula One down there. The Catholic Charities has a dining room that has 10 screens in it, so consider that for future. The small cover that damaged the Formula One race car during the practice, I believe, is the same small cover that is missing in several of the roadways on the pipes here in town. I've reported two to SeeFix and - what is it? SeeClickFix or whatever. I've reported two and I know of others.

So, upcoming - I don't represent these conventions but the big one coming up in December is the Longevity Fest 2023. It's a repeat convention that comes to town and they bring in state-of-the-art health devices, and it's on a Thursday, Friday, and Saturday, December 14th and 16th. So, even if you just went on a Saturday - the County people can go on a Friday, and the fee is - you'll probably get a discount, but I think it's about \$500. But the number of tests that you can experience walking around from all the booths and the feedback is very valuable. And I think a lot of the devices there should be in our prisons and should be in our jails and the first responders. There's certain devices that deal with COVID that we don't see on the site.

The other big convention coming up, of course, is CES and that's in January, the 9th through the 12th. Go to CES.tech to buy a ticket to walk to the floor. It's \$300 now. The key area is the Eureka Park. Every year, all those booths are - all those companies are only allowed one booth, none of the big ones. So, there's a lot of little businesses in there and that's in the basement of the Venetian Expo. I wonder how many companies or businesses in Nevada or Las Vegas County or Clark County are going to be down there exhibiting. We're talking about building this, our infrastructure and jobs, and we don't exhibit there. The patent offices there, they have pitch contests. They even have a place for universities to brag about what they do. So, consider adding CES to your schedule.

DOCTOR JUANA JORDAN

Good morning to the Chair, Vice-Chair, and the illustrious Board of County Commissioners. I am Doctor Juana Leia Jordan, and I am speaking as it relates to Item 42. I am pleased to be an applicant however displeased that I was not selected. I am going to just quickly revitalize you about and navigate through who I am.

I am a Las Vegas citizen who has been in Las Vegas since May 13th, 1979 as an undergraduate coming to Las Vegas at an early age from HBCU. Got my master's from UNLV as one of the first Black graduates in the School of College of Education and Counseling. Finally, my doctorate is from Santa Barbara, University of Santa Barbara in California at Fielding Graduate School. I have been a grassroot advocate starting with Assembly Petrick, if we remember him from District 18. I remember working with Governor Miller doing volunteerism. Also, with the Honorable Bryan. Everyone knows that.

I remember you, Honorable Kirkpatrick, when you were working over here behind the (inaudible). I remember that. And also, to Tick Segerblom, one of the EEO great attorneys. I am representing Spring Valley District F by the incomparable humanitarian, Justin Jones. Also, Michael Naft also in that district. I represent you on the Spring Valley Board. And the Historic West Side, William McCurdy. I have been an advocate for the less fortunate. And opioid, I was talking with Madam Hillary Clinton as it related to opioid addiction. Life skills, training, don't decriminalize the people. Let's give them what they need as it relates to the training.

I am here also to say when Nevada State College became a college, I ran for that position against the legendary Mark Alden, to say that we need Nevada State College. Of course, we didn't have it at this time because our minds had not broadened that perspective.

Next, I was also the four contestants for the appointed positions - excuse me, I know my time's up, for Assembly 42. But I'm here to tell you that I feel the need that we have the task force and I'm just letting you know that I appreciate all that we have done and thank you so much for your time. I hope to be back again, and I will continue to serve District F and represent you proudly, Commissioner Jones and Commissioner Naft. Thank you so much.

JENNIFER HOUSTON

Good morning, Commissioners.

Good morning.

**HOUSTON** 

My name is Jennifer Houston. I reside at 4624 Diamond Head Drive, Las Vegas Nevada, 89110. And I have lived in Las Vegas for 30 years. In October, I created a nonprofit hostel living and I have IRS approval. For that nonprofit, I know that there is a Bill of Rights for the homeless in legislation now. And in response to the homelessness in Southern Nevada, hostel living presents an innovative solution that goes beyond shelter. Our proposal involves establishing a hostel community within a gated space, comprising of approximately 30 homes, a communal backyard and a clubhouse totaling approximately 33 properties. What sets hostel living apart is our commitment to not only providing a home but also preparing occupants for a self-

sufficient future. Under our 18-month contract, occupants will undergo a comprehensive program. The initial 12 months are dedicated to education and counseling, empowering individuals with the skills and knowledge needed for personal and business development. The subsequent six months will focus on a tailored approach to job readiness and self-sufficiency. We believe that equipping occupants with the tools to secure employment and maintain self-sufficiency can break the cycle of homelessness. Our vision extends beyond a single location. These hostel communities can be strategically distributed throughout the valley. Our hostel model is not just about beds. It's about building a vibrant, inclusive community where individuals from all walks of life can thrive.

By taking a holistic approach to homelessness, we aim to create a positive lasting change in the lives of our occupants. To achieve this, we rely on the support of generous donors, contributions in the form of land, monetary funds or in-kind donations play a crucial role in turning our vision into reality. Donations enable us to extend our reach and make a tangible impact on the lives of those in need. By contributing land, you provide a physical foundation for our hostel communities. Monetary donations empower us to implement and sustain our programs, ensuring that individuals experiencing homelessness receive the support they need. In-kind donations, whether it be supplies or services, further enhance our ability to create a lasting impact.

We invite you to join us at hostel living as we pave the way for a brighter, more reliant future for the homeless population in Las Vegas. Together, we can build a community that not only provides shelter but empowers individuals to secure meaningful employment and achieve lasting self-sufficiency.

This is my first address to the Board, but I assure you it will not be my last. Thank you.

DEREK WILLIAMS

Thank you so much.

Good morning. Name is Derek Williams and I'm kind of piggyback on what she says. I'm holding a picture of a guy sleeping in a box on the streets of Clark County, streets of Las Vegas, and I think it's unacceptable. More must be done. More should be done. We shouldn't have homelessness here. And if we do have it, we should address why we have it. Enough is not being done. I've been here four years. I'm from another area of Ohio, Cleveland Ohio, and there's more there done. More resources. The churches, other places come together as a team, and I think we need to have that here. Enough is not being done. Nobody should be sleeping on the streets here. The guy should not be sleeping in a box on our streets. That's unacceptable. And when we building in all these casinos - I'm not against casinos. I'm not against anyone that tries to better them lock their lives, but more should be done. More need to be done. And I hope that we try to do that. And the people were talking about the water and the grass. You have grass, you have water. Thank God for that. There's people that don't have that. We can start by letting them have a place to take a shower. How about letting them have a place that they could get food or medical attention? Mental attention, things like that. And then we can maybe better our community. Until we address that, that's going to be a problem, and I'm seeing that. Okay?

I thank you for listening and I hope we actually can do something about that. Of all the people of the City, this State and this County. Thank you.

**SEGERBLOM** Thank you.

**UEHLING** Yeah, thank you for giving us permission to clap again in the last part of the session.

It's no (inaudible)

Would you state your name, please? **SEGERBLOM** 

My name is Ed Uehling. Excuse me. U-E-H-L-I-N-G. Thank you. It's no secret that **UEHLING** 

> this Board of Directors is very disappointed with some of the decisions of the court. And therefore, with the basic concept on which the United States of America was founded, which is separation of powers. You control two of the powers in the County and now you're manipulating. You are actually manipulating with the District Attorney here in this office to control who is going to be a judge in our courts. You shouldn't be doing that. The State of Nevada has elected judges, not judges that are manipulated by political wannabes that think they know more than every judge, every other judge, and every other person in the County. This is a - please rescind that decision to play with the timing of the meetings so that you get to appoint the judge. You're just so unbelievable. That's crim - that isn't just criminal. That's against the very founding, the very basis of the United States of America versus China or versus Germany or versus any other government in the world. And you're trying to break it down. You're trying to establish one authority.

> And it was stated that no other community in the world could do anything like F1. Excuse me, Macau has been doing F3 for 40 years right down the middle of the city with all the tourists and everything. Macau, when 40 years ago was nothing. It was a backwater and had less gaming revenues than Las Vegas. Now, Macau has almost as many tourists as Las Vegas. It has four times the amount of income - gaming income as Las Vegas. It's an incredible city. If you ever get the chance to go live there - to go visit there. You can't live there because you need a visa to live there, and they don't give the visas out unfortunately. But it's not just Las Vegas. There are lots of things happening all over the world. And when you close yourselves up because you know everything and we know nothing and none of us know anything, we're headed for bankruptcy.

I've been waiting for five years to say this, thank you, Mister Uehling. **SEGERBLOM** 

**UEHLING** Why? Why would you say thank you?

**SEGERBLOM** Because you're done. Your time is up. But with respect to the judgeship, all we're

doing is allowing the judge we appoint to be able to file for office and run in the

election, which as you said is unique to Nevada. Our judges run for office.

**UEHLING** (inaudible)

KIRKPATRICK Wait, don't respond to him. Don't violate the (inaudible).

**SEGERBLOM** Good afternoon. Good morning.

VERONICA VERA Hi, Commissioners. My name is Veronica Vera and I initially came up because I was

> looking at the Clark County website and this was regarding short-term rentals. And it lists things like the application closed on March 13th, 2023, and it goes into the application process. But what it doesn't do is it doesn't give the intervals in which the

application process is open again. It doesn't talk about, I guess in the different zones, how each - how many they are established. I've heard something about a lottery and it's not a clear process. The application process is clear, but it doesn't - say, this amount of homes within this region will be allowed to do the rental – the property rentals, and I know that Las Vegas earns a good bit of money because of our hotel industry. I don't think that anyone wants to take away from that, but we do want to make sure that they are fair ratios with the rental program and how often - and the intervals - we want to know that it's a fair process. So, I just want to bring that to your attention.

But while I was up here, I noticed that some of the people were talking about the homelessness. I am originally from the East Coast, and I've lived in various areas across the United States, and I'm not here to complain. What I am here to say is that maybe as a solution, maybe there could be a tax that each hotel can pay toward homelessness. Maybe, you all could open money for nonprofit organizations to help solve the problem. No one feels that each one of you should solve the problem, but if you provide vehicles for other people to support the process, maybe we will have less homelessness in the city. And I just, as an individual just sitting here, I didn't know I was coming today. I heard this concern, and great minds - people come together and they come up with solutions. So, as I heard this, I feel like the casinos could get involved. They could contribute a little bit. Maybe, it could be a mandate of something be brought to you all or open money for nonprofits. I myself would open a nonprofit if I had funding to help homelessness here in Las Vegas. And thank you for your time.

**SEGERBLOM** 

Thank you. Seeing no one else, I'll recess the public hearing and resume tomorrow morning at 9:00 a.m.
