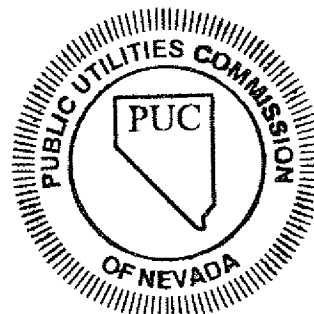

ORDER

The Public Utilities Commission of Nevada (“Commission”) makes the following findings of fact and conclusions of law:

I. INTRODUCTION

Arcadian Infracom 2, LLC d/b/a Arcadian and Arcadian Infracom (“Arcadian”) filed with the Commission an application, designated as Docket No. 23-10003 (“Application”), for authority to operate as a competitive supplier of telecommunication service within the State of Nevada.

II. SUMMARY

The Commission grants the Application, as amended, and orders issuance of a Certificate of Public Convenience and Necessity granting Arcadian authority to operate as a competitive supplier of telecommunication service within the State of Nevada.

III. PROCEDURAL HISTORY

- On October 5, 2023, Arcadian filed its Application with the Commission pursuant to the Nevada Revised Statutes (“NRS”) and the Nevada Administrative Code (“NAC”) Chapters 703 and 704, including, but not limited to, NRS 704.330 and NAC 704.7472. Pursuant to NAC 703.5274, Arcadian requested confidential treatment of certain information filed under seal.
- The Regulatory Operations Staff of the Commission (“Staff”) participates as a matter of right pursuant to NRS 703.301.

- On October 9, 2023, the Commission issued a Notice of Application for Authority to Provide Telecommunication Service.
- On November 1, 2023, Arcadian filed an errata providing that it would not be submitting an amended Exhibit No. 10.
- On November 27, 2023, Staff filed a briefing memorandum (“Staff’s Briefing Memorandum”).
- On November 28, 2023, the Commission voted to adopt the recommendations in Staff’s Briefing Memorandum.

IV. APPLICATION

Arcadian’s Request

1. Arcadian requests authority to operate as a competitive supplier of telecommunication service within the State of Nevada. (Application at 1.)

Staff’s Position

2. Staff states that Arcadian has met the requirements of NAC 704.7472. (Staff’s Briefing Memorandum at 1.) Staff recommends the Commission grant the Application, as amended, and issue an order and a certificate granting Arcadian authority to operate as a competitive supplier of telecommunication service within the State of Nevada. (*Id.*)

Commission Discussion and Findings

3. The Commission adopts the analysis and recommendations found in Staff’s Briefing Memorandum. The Commission finds that Arcadian has met the requirements of NAC 704.7472 and grants the Application, as amended.

Therefore, it is ordered:

1. The Application of Arcadian Infracom 2, LLC d/b/a Arcadian and Arcadian Infracom, designated as Docket No. 23-10003, is granted, as amended.

The Assistant Commission Secretary shall issue to Arcadian Infracom 2, LLC d/b/a Arcadian and Arcadian Infracom a Certificate of Public Convenience and Necessity authorizing Arcadian Infracom 2, LLC d/b/a Arcadian and Arcadian Infracom to operate as a competitive supplier of telecommunication service within the State of Nevada.

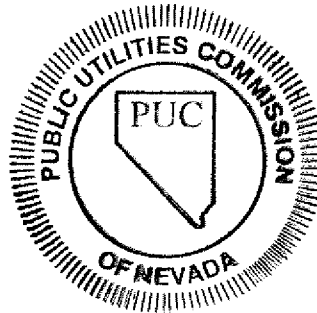

Failure to submit the requested information may result in a refusal by the BCC to enter into an agreement/contract and/or release monetary funding to such disclosing entity.



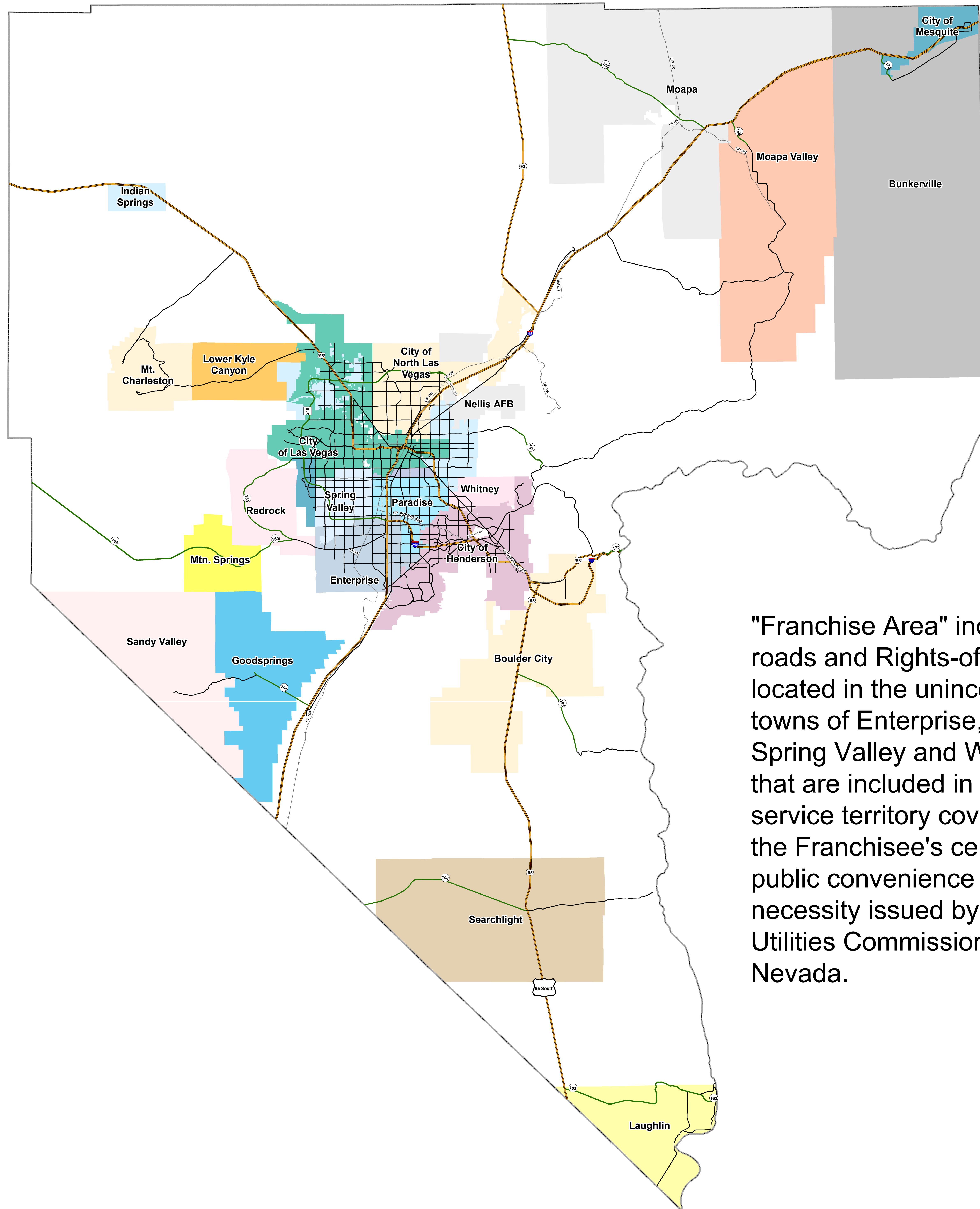

Franchise Service Area

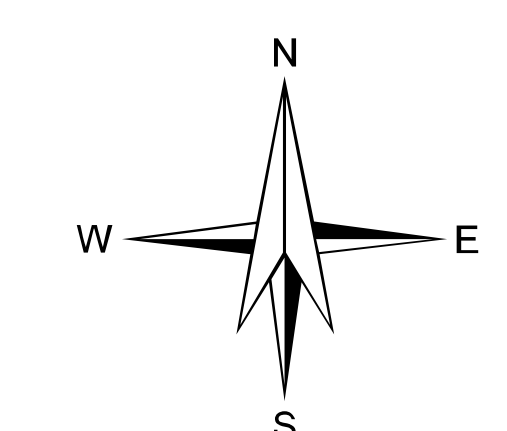

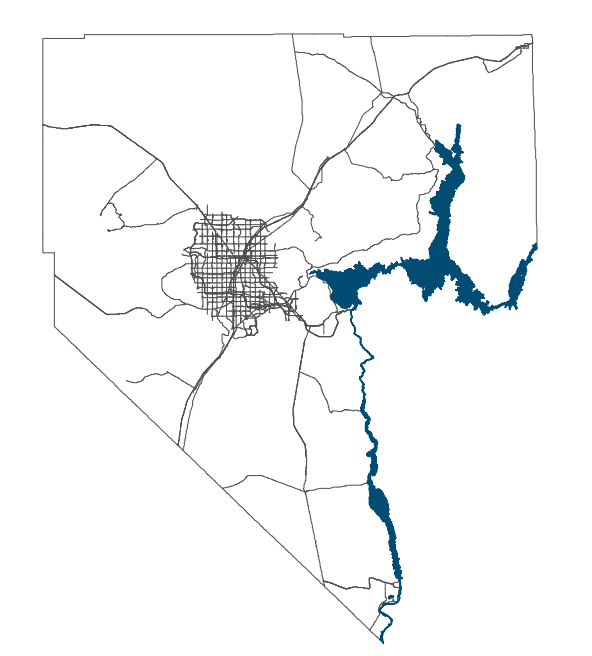
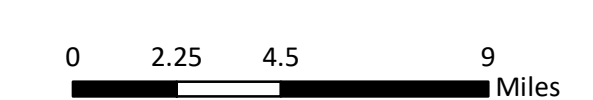
